#### **General**

The Plan is a defined contribution plan available to all employees of Frank H. Hiscock Legal Aid Society (the Organization or Employer) who meet certain eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Eligibility**

Employees are eligible to begin making elective deferrals after attainment of twenty-one years of age. The Plan entry date is the first day of the month coinciding with or next following the date the eligibility requirements are satisfied. To be eligible for the Organization's matching or profit sharing contribution a participant must have completed one year of service.

#### **Contributions**

Each year participants may contribute a percentage of their pre-tax annual compensation, as defined by the Plan, subject to maximum limitations established by the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferred contributions as after-tax contributions into a Roth account. In addition, participants who have attained the age of 50 before the end of the Plan year may contribute an additional catch-up contribution. Participants may also contribute amounts representing distributions from other tax-qualified retirement plans (rollover). All eligible employees are automatically enrolled in the Plan and have elective deferrals withheld in the amount of 5% of compensation unless they elect otherwise.

The Organization makes matching contributions equal to 20% of the first 5% of the employee's deferrals. Profit sharing contributions may be made at the discretion of the Organization's management. Profit sharing contributions amounted to \$203,165 in 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and the allocation of (a) the Organization's matching and discretionary contributions, (b) Plan earnings/losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested account in their account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum.

## 1. DESCRIPTION OF PLAN (Continued)

### Vesting

Participants are immediately fully vested in their voluntary contributions to the Plan. Employer matching contributions made by the Organization are vested at the following percentages:

### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,512 and \$18,580, respectively. These accounts will be allocated to participant account of participants employed on the last day of the plan year. During 2024, no amounts were applied to plan activated from forfeited nonvested accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### Basis of Accounting

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the accompanying financial statements.

### Payment of Benefits

Benefit payments to participants are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## 3. CERTIFIED INVESTMENT INFORMATION

The following financial information relating to the Plan's assets at December 31, 2024 as well as investment income and investment transactions for the year then ended, has been derived from information provided by Ascensus Trust Company and Newport Trust Company, LLC, the custodians of the Plan, and has been certified by them as complete and accurate.

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* valued at the net asset value (NAV) per unit, as reported by the trust holder. The NAV is based on the fair value of the underlying investments held by the trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus Trust Company and Newport Trust Company, LLC., which acts as the custodians as defined by the Plan. Ascensus, LLC is the Plan's third-party administrator. Transactions between these companies and the Plan qualify as parties-in-interest transactions.

#### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

## **7. TAX STATUS**

The Plan adopted a pre-approved plan offered by Security Administrators, Inc. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, stating that the Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

## **8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

While total net assets available for benefits agree between the financial statements and Form 5500 as of December 31, 2024 and the total change in net assets available for benefits agree between the financial statements and Form 5500 for 2024, certain classifications differ between the financial statements and Form 5500.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.

Each participant's account is credited with the participant's contribution and the allocation of (a) the Organization's matching and discretionary contributions, (b) Plan earnings/losses, and (c) administrative expenses. Allocations are based on participant earnings or account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Payment of Benefits**

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum amount equal to the value of the participant's vested account in their account. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of a lump sum.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are immediately fully vested in their voluntary contributions to the Plan. Employer matching contributions made by the Organization are vested at the following percentages:

### **Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,512 and \$18,580, respectively. These accounts will be allocated to participant account of participants employed on the last day of the plan year. During 2024, no amounts were applied to plan activated from forfeited nonvested accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The accompanying financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the investment advisors and qualified institutions.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amount reported in the accompanying financial statements.

### **Payment of Benefits**

Benefit payments to participants are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Organization. Expenses that are paid by the Organization are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

## 3. CERTIFIED INVESTMENT INFORMATION

The following financial information relating to the Plan's assets at December 31, 2024 as well as investment income and investment transactions for the year then ended, has been derived from information provided by Ascensus Trust Company and Newport Trust Company, LLC, the custodians of the Plan, and has been certified by them as complete and accurate.

## 4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

#### 4. FAIR VALUE MEASUREMENTS (Continued)

There have been no changes in the methodologies used at December 31, 2024 and 2023. Following is a description of the valuation methodologies used for assets measured at fair value:

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Collective Trust Fund:* valued at the net asset value (NAV) per unit, as reported by the trust holder. The NAV is based on the fair value of the underlying investments held by the trust.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. PARTIES-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Ascensus Trust Company and Newport Trust Company, LLC., which acts as the custodians as defined by the Plan. Ascensus, LLC is the Plan's third-party administrator. Transactions between these companies and the Plan qualify as parties-in-interest transactions.

#### 6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, participants would become 100% vested in their accounts.

## **7. TAX STATUS**

The Plan adopted a pre-approved plan offered by Security Administrators, Inc. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, stating that the Plan and the related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore believes that the Plan is qualified, and the related trust is tax-exempt.

## **8. RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**

While total net assets available for benefits agree between the financial statements and Form 5500 as of December 31, 2024 and the total change in net assets available for benefits agree between the financial statements and Form 5500 for 2024, certain classifications differ between the financial statements and Form 5500.

## **9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
