## INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of  
A World for Children 401(k) Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of A World for Children 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year then ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of A World for Children 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of A World for Children 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about A World for Children 401(k) Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

**NOTE 1 - DESCRIPTION OF THE PLAN**

General – The A World for Children 401(k) Plan is a defined contribution retirement plan covering substantially all employees of A World for Children. An employee is eligible to participate in the plan immediately upon employment. The Plan provides for retirement, disability, death, and employment termination benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The plan is a defined contribution plan within the meaning of Section 401(a) of the Internal Revenue Code.

Contributions – Participant contributions are made via payroll deductions. Each participant may elect to have compensation deferred up to the maximum percentage or stated amount allowable, not to exceed the limits of code section 3401(a). All employees are automatically enrolled in the plan and they must elect out if they choose not to participate. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The employer is authorized by the Plan to make safe harbor contributions. In order to receive employer safe harbor matching contribution under the Plan, a participant must be having salary deferred. Safe harbor matching contributions will be determined per a formula. The formula at December 31, 2024 and 2023 was 100% up to 3% of the participant's salary and 50% of salary deferral up to the next 2% of plan compensation.

Participant Accounts – Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution, and plan earnings. Participants are responsible for certain plan fees and charges. The employer is responsible for other administrative fees such third-party administrator fees. Lincoln Financial Group (Lincoln) is the trustee.

Vesting – Participants are immediately vested in their voluntary contributions plus actual earnings on these amounts. Vesting in the Company's safe harbor matching contributions is immediate.

Participant Loans – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The participant may only have one loan outstanding at any time. The balance in the participant's account secures the loan. Prevailing interest rates are used. Interest rates range from 4.25% to 9.50%. Principal and interest is paid through bi-monthly payroll deductions. These loans are regarded as a party-in-interest because of the relationship between the Plan and its participants.

Payment of Benefits – Upon termination of service due to retirement, disability, or death, the participant will receive the value of the vested interest in his or her account in the form of one lump-sum payment or in a rollover to another eligible retirement plan. If permitted by the Plan Administrator, the participant may take a partial distribution of his or her vested account. In-service distributions may be made so long as the Plan requirements have been met.

Forfeited Amounts – For the years ended December 31, 2024 and 2023, forfeited accounts totaled \$46 and \$45, respectively. These accounts are used to reduce future employer contributions to the Plan. For the years ended December 31, 2024 and December 31, 2023, employer contributions were reduced by \$-0- and \$993, respectively.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting – The financial statements of the Plan are prepared under the accrual method of accounting.

Nature of Investments – Investments consist of assets held in mutual funds, asset allocation portfolios (Yourpath Portfolios) and a fixed account. Lincoln Financial Group has been appointed to provide all administrative services necessary to support the insurance contracts issued. Lincoln Financial Group Trust Company is the Plan's trustee.

Use of Estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition – The Plan's investments are stated at fair value. Quoted market prices are used to value investments. Income from investments is recognized in the period in which it is earned. Purchases and sales of securities are recorded on a trade-date basis.

Payment of Benefits – Benefits are recorded when paid.

Expenses – Administrative expenses of the Plan are paid by the Plan, as provided in the Plan document. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation (depreciation) of fair value of investments.

**NOTE 3 – INVESTMENTS AT FAIR VALUE**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows.

Level 3            Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Asset Allocation Portfolios:* Valued at the NAV of units. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on fair value of the underlying investments held by the portfolio less its liabilities. This practical expedient is not used when it is determined to be probable that the investment will sell for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the asset allocation portfolios, the investment advisor reserves the right to temporarily delay withdrawal from the fund in order to ensure that securities liquidations will be carried out in an orderly business manner.

The Plan's investments are reported at fair value in the accompanying statement of net assets available for benefits.

**NOTE 4 - INVESTMENT AT CONTRACT VALUE**

As of December 31, 2024, the Plan's group annuity contract with Lincoln National Life Insurance Company is a fully benefit-responsive contract. Under the terms of the contracts, participant-initiated transactions for the purpose of receiving benefits allowed under the plan, such as retirement, death, disability, hardship, required minimum distribution, allowable in-service withdrawal, are completed at contract value without conditions, limits or restrictions.

Contract value represents contributions made, less withdrawals and administrative expenses, plus interest credited. Daily liquidity at contract value is available for participant contributions and withdrawals. The Plan's Lincoln Stable Value Account's contract value is a general liability against Lincoln National Life Insurance Company on the Plan's behalf. Certain events may limit the ability of the Plan to transact at contract value. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a market value adjustment or other withdrawal restriction may apply. The plan sponsor may choose to pay the market value adjustment directly, if applicable, so that the participants' contract values are not affected. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract value of the investment contract at December 31, 2024 and 2023 was \$382,347 and \$378,184 respectively. The interest rate was 2.30% and 2.10% for the years ended December 31, 2024 and 2023, respectively.

**NOTE 5 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of any full or partial termination, participants will become 100 percent vested in their accounts and shall not thereafter be subject to forfeiture, and all unallocated amounts, including forfeitures, shall be allocated to the accounts of all Participants.

**NOTE 6 - EXEMPTION FROM FEDERAL INCOME TAX**

No provision has been made for federal income tax. A prototype plan is used by A World of Children 401(k) Plan. In a letter dated June 30, 2020, the Internal Revenue Service states that an employer using the prototype plan may rely on the letter with respect to the qualification of its plan under Code Section 401(a). The Plan has been amended; however, the Plan administrator and the sponsor believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan's annual returns for 2023, 2022, and 2021 are subject to examination by the IRS, generally for three years after they were filed.

**NOTE 8 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities, which are inherently exposed to various risks such as interest rate fluctuations, and market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE 9 - PARTIES IN INTEREST**

Certain plan investments are managed by Lincoln Retirement Services Company, LLC, which is also the Plan's administration and recordkeeping service provider. Lincoln Financial Group Trust Company is the current trustee. The employer participating in the plan is A World for Children.

Jasmine Johnson, Payroll/HR Administrator of A World for Children, is the Plan Administrator. Ashleigh Wilkes is the Plan Trustee. Douglas Wilson is the Finance Director of A World for Children. Ludwick, Montgomery & Stapp, P.C. is the auditor.

**NOTE 10 - SUBSEQUENT EVENTS/DATE OF MANAGEMENT'S REVIEW**

Subsequent events were evaluated through October 6, 2025, which is the date the financial statements were available to be issued.
