## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of  
How To Manage a Small Law Firm II LLC 401(k) Profit Sharing Plan & Trust

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of How To Manage a Small Law Firm II LLC 401(k) Profit Sharing Plan & Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE 1 - DESCRIPTION OF PLAN

The following description of the How To Manage a Small Law Firm II LLC 401(k) Profit Sharing Plan & Trust (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

A) GENERAL

The Plan is a Safe Harbor 401(K) plan covering employees of How To Manage a Small Law Firm II LLC (the "Company" or "plan sponsor") under the provisions of Section 401(a) of the Internal Revenue Code (the "Code"). Employees who have reached eighteen years of age or older and have completed three consecutive months of service are eligible to join the Plan. Participants become eligible for nonelective contributions after completion of one year of service, as defined. The Plan is subject to and conforms with the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Mid Atlantic Trust Company ("MATC"), a qualified institution, and Paychex Inc. ("Paychex") was the Plan's appointed custodian and record keeper, respectively, for the period from January 1, 2023 to March 21, 2023. Effective March 22, 2023, the Company changed service providers to T. Rowe Price Retirement Plan Services ("T. Rowe"), the custodian and recordkeeper, and Reliance Trust Company ("Reliance"), a qualified institution, became the appointed trustee. T. Rowe and Reliance served as the custodian and trustee as of and for the year ended December 31, 2024, respectively.

B) CONTRIBUTIONS

Eligible employees can contribute a portion of their annual compensation, as defined in the Plan document, subject to Internal Revenue Service ("IRS") limitations. Participants are allowed to designate contributions to both pre-tax and after-tax (Roth) 401(k) classifications. Additionally, participants may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). Eligible employees are automatically enrolled at a default rate of 3% unless declined or election of a different contribution rate. The total maximum allowable contribution per participant to the Plan directly from the participant was \$23,000 for the 2024 year, not including additional catch-up contributions allowed for participants over the age of 50, which were \$7,500.

The Company can elect to make qualified automatic contribution arrangement ("QACA") safe harbor matching contributions and discretionary nonelective contributions to the Plan. During 2024, the Company elected to make QACA safe harbor matching contributions equal to 100% of the amount contributed by participants to the Plan up to the first 1% of participant compensation plus 50% of elected deferrals that exceed 1% of participant compensation up to 6%. The Company's QACA safe-harbor matching contribution was approximately \$312,000 for the year ended December 31, 2024.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

C) VESTING

Participants are immediately vested in their contributions and QACA safe harbor matching contributions plus actual earnings thereon. Vesting in employer discretionary nonelective contributions plus actual earnings thereon is based on years of continuous service. Vesting in the Company's matching and non-elective contributions is as follows:

Participants are 100% vested, regardless of years of service, when they reach normal retirement age, are totally and permanently disabled, or death occurs.

D) PAYMENT OF BENEFITS

Benefits are payable on termination of service due to retirement, termination, disability or death. Participants or their beneficiaries may elect to receive a lump-sum distribution or partial withdrawals or annuities as defined in the Plan document. Eligible participants may also make hardship withdrawals, as defined.

E) PARTICIPANT ACCOUNTS

Each participant's account is credited with the participant's compensation deferral contributions, the Company's discretionary contributions, if any, and an allocation of the investment earnings, based upon each participant's election. The benefit to which a participant is entitled upon withdrawal from the Plan, as defined above, is the vested benefit in the participant's account. Participants may direct the investment of their account balances into various investment options offered by the Plan.

F) INVESTMENT OPTIONS

Participants are allowed to invest their elective 401(k) contributions, rollovers, if any, as well as Company matching and nonelective contributions to the Plan in a variety of investment options as more fully described in the Plan document. Participants may change their investment options and deferral percentages at their discretion.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

G) NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 and up to a maximum equal to the lesser of (a) 50 percent of their vested account balance, or (b) \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. Participants are permitted to have two loans outstanding at any given time. The notes are secured by the vested balance in the participant's account. Notes bear interest at a fixed rate equal to 1% above the prime rate at origination.

Principal and interest is repaid through payroll deductions over a period of no more than five years, unless the loan is used for the purchase of a primary residence.

H) FORFEITED ACCOUNTS

Pursuant to the Plan, forfeited non-vested accounts may be used to pay Plan expenses, reduce future employer contributions or allocated as an employer profit sharing contribution. No forfeitures were utilized to pay Plan expenses or offset matching contributions during the year ended December 31, 2024. At December 31, 2024 and 2023, the Plan had a remaining forfeiture balance of approximately \$15,000.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following are the significant accounting policies followed by the Plan:

A) BASIS OF ACCOUNTING

The Plan's financial statements are prepared on the accrual basis of accounting and in accordance with accounting principles generally accepted in the United States of America for employee benefit plans.

B) USE OF ESTIMATES

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amount of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

C) INVESTMENT VALUATION AND INCOME RECOGNITION

Assets of the Plan are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

C) INVESTMENT VALUATION AND INCOME RECOGNITION (CONTINUED)

Purchases and sales of securities are recorded on a trade date basis. Dividend and interest income are recorded by the trustee in the period earned. Net realized and unrealized appreciation or depreciation in fair value of investments consists of the change in unrealized appreciation or depreciation and the realized gain or loss on the sales of investments during the year. Acquisition costs are included in the cost of investments purchased and sales are recorded net of selling expenses. Investments are self-directed by the individual Plan participants.

D) NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

E) RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

F) PAYMENT OF BENEFITS

Benefits are recorded when paid.

G) ADMINISTRATIVE EXPENSES

The Plan agreement allows for the Company to absorb the majority of the Plan's administrative and investment related expenses. Investment related expenses are included in net depreciation of fair value of investments through revenue sharing arrangements. During the fiscal year ended December 31, 2024, administrative expenses incurred by the Plan totaled approximately \$20,000.

H) RECENT ACCOUNTING PRONOUNCEMENTS

The Company evaluates new accounting pronouncements for relevance and impact on the Plan's financial statements. Management does not expect that timely adoption of new pronouncements will have a material impact on the Plan's net assets available for benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

I) MANAGEMENT REVIEW OF SUBSEQUENT EVENTS

Management has evaluated subsequent events through October 9, 2025, the date when the financial statements were available to be issued.

NOTE 3 - FAIR VALUE MEASUREMENTS

The Plan’s investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to measure the fair value of certain financial instruments could result in a different fair value at the reporting date.

Accounting guidance establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs consist of unobservable inputs and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. During 2024 and 2023, Level 1 inputs were available and therefore used. No level 2 and 3 inputs were used by the Plan.

The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money Market - Money market accounts are valued at fair value using quoted prices in active markets for identical assets.

NOTE 4 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to suspend or terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 5 - TAX STATUS

The Plan has adopted a pre-approved plan document, which has received an opinion letter from the IRS dated June 30, 2020, stating that form of the pre-approved plan document was in compliance with the applicable requirements of the Code. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by T. Rowe as of December 31, 2024. T. Rowe is the custodian as defined by the Plan and, therefore, fees and expenses paid to the custodian qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party- in-interest transactions under ERISA.

NOTE 7 - RELATED PARTY TRANSACTIONS – PROHIBITED TRANSACTION

During 2024, the plan sponsor did not remit certain employees’ contributions in accordance with guidelines set forth by the United States Department of Labor (“DOL”) and Employee Benefits Security Administration (“EBSA”). However, the contributions were remitted soon thereafter. The DOL considers this a prohibited transaction and may impose penalties on the Plan sponsor as a result of these transactions.

NOTE 8 - FIDELITY BONDING

The Company maintains a fidelity bond of \$500,000 for Plan fiduciaries and individuals who handle the funds of the Plan, pursuant to the requirements of ERISA.

NOTE 9 - INFORMATION PREPARED AND CERTIFIED BY THE PLAN TRUSTEE

The plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance, the trustee and qualified institution, has certified that the following information included in the accompanying financial statements and supplemental schedule is complete and accurate as of December 31, 2024 and 2023 and for the year ended December 31, 2024.
