NOTE 1 - GENERAL INFORMATION

A. General

The Plan is a defined contribution plan in accordance with Section 401(k) of the Internal Revenue Code (IRC) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan covers all employees of Moses Lake Industries, Inc. (the Plan Sponsor) who are not excluded employees for purposes of the Plan. Excluded employees include union employees whose employment is governed by a collective bargaining agreement, certain nonresident aliens and employees of any Japanese based member of any controlled group of employers that includes Moses Lake Industries, Inc. where such employees are temporarily assigned to work at Moses Lake Industries, Inc. Provided an employee is not an excluded employee, an employee will be immediately eligible to make salary deferrals and able to participate in the Plan Sponsor's matching contribution. This description provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

B. Contributions

Participants may contribute up to the maximum percentage allowable by the applicable IRC of pretax annual compensation, up to a maximum of \$23,500 as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions of \$7,500. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan Sponsor matches 100 percent of the first 4 percent of base compensation that a participant contributes to the Plan. The matching contribution is invested as directed by the participant. Additional profit sharing amounts may be contributed at the option of the Plan Sponsor.

C. Participant accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Plan Sponsor's contribution and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

D. Vesting

Participants are vested immediately in their contributions plus actual earnings thereon as well as the Plan Sponsor's match and discretionary contribution.

E. Notes receivable from participants

The Plan allows participants to borrow up to 50% of the vested balance of their account, up to a maximum of \$50,000. Interest on participant loans is determined by the Plan trustee in accordance with the Plan's provisions. The term of the loan is generally five years, but can be longer if the loan is used for the purchase of a principal residence. In the event of termination of employment, loan balances and accrued interest shall be deducted from the amount of the distribution.

F. Payment of benefits

On termination of service due to death, disability, retirement or other reasons, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in their account.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. Basis of accounting

The financial statements of the Plan are prepared utilizing the accrual basis of accounting, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

B. Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires Plan management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. Notes receivable from participants

Notes receivable from participants are stated at their unpaid balance plus accrued but unpaid interest. Interest is paid each pay day. The interest rate is determined at the loan origination date according to Plan documents and ranges between 4.25% and 9.50% for all outstanding loans as of December 31, 2024. Since the notes are secured by the participants' vested account balance, no allowance for doubtful accounts is considered necessary.

D. Investment valuation and income recognition

The Plan's investments are stated at fair value. Shares of registered investment companies are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at year end. See Note 5 for discussion of fair value measurements.

Money market mutual funds held with brokers are considered to be investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

E. Contributions

Contributions from Plan participants and the matching contributions from the Plan Sponsor are recorded in the year in which the employee contributions are withheld from compensation.

F. Excess contributions payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

G. Payment of benefits

Benefits are recorded when paid.

H. Plan expenses

Plan expenses are paid by the Plan or the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

NOTE 3 - INVESTMENTS

During 2024, the Plan's investments (including dividends and gains and losses on investments bought and sold, as well as held during the year) appreciated (depreciated) in value by \$5,870,857.

NOTE 4 - RELATED-PARTY TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Charles Schwab Trust Company. Charles Schwab Trust Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

NOTE 5 - FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Mutual funds are valued at daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 6 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its elective contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

NOTE 7 - INCOME TAX STATUS

The IRS has determined, and informed the Plan Sponsor by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021, which is the standard statute of limitations look-back period. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan provides for various investments options, including mutual funds. The underlying investment securities in the mutual funds are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities and investment contracts and the level of uncertainty related to changes in the value of the investment securities, it is at least reasonably possible that changes in risks in the near term would materially affect participant's account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 - INFORMATION CERTIFIED BY CUSTODIAN

Information contained in the accompanying financial statements that was certified by the custodian, Charles Schwab Trust Company is as follows:

- Details (cost and fair value) of investment assets held at December 31, 2024 and 2023;
- Summaries of investment transactions for the year ended December 31, 2024;
- Investment income, including net appreciation (depreciation) in fair value of investments, for the year ended December 31, 2024.

NOTE 10 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 10, 2025, the date which the financial statements were available to be issued. There were no material subsequent events that required recognition or additional disclosure in the financial statements.
