Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of W-S Industrial Services, Inc. 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

1. Description of the Plan

The following description of the W-S Industrial Services, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan was established effective November 1, 1998, and restated effective January 1, 2022. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is available to all employees of W-S Industrial Services, Inc., W-S Mechanical Group, LLC, W-S Specialty Services, LLC, H2O Underpressure, LLC, and FSIS (collectively, the “Company”) who are 21 years of age and have completed one year of service in which the employee provided at least 1,000 hours of service. Effective January 7, 2025, the Plan was terminated following the March 12, 2024 acquisition of the Company by Groome Industrial Service Group. Upon termination, all remaining participants and their account balances were transferred and merged into the successor 401(k) plan.

Plan Administration – One retired officer and one current officer of the Company serve as the plan trustees. The Company has contracted with Nationwide Financial Services, and its subsidiaries, to hold the Plan’s assets and execute investment transactions. Benefit Plans, Inc. has been contracted as a third-party administrator. The Plan has contracted with Iron Fiduciary to serve as the Investment Manager for the Plan.

Contributions – The Plan allows participants to contribute an amount up to Internal Revenue Code limitations of their annual compensation through compensation deferrals. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investments options offered by the Plan. The Company makes safe harbor matchings contribution to each eligible participant’s account in an amount equal to 100% of elective contributions up to 3% of eligible compensation, as defined by the Plan, plus 50% of elective contributions over 3% up to 5% of eligible compensation. The Plan also allows for discretionary profit sharing contributions and employer matches at the option of the Company and are invested as directed by the participant. There were no discretionary contributions made in 2024 or 2023.

Participant Accounts – Each participant’s account is credited with the participant’s and Company matching contributions and allocations of (a) the Company’s discretionary contribution and (b) plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. **Description of the Plan - Continued**

Vesting – Participants are immediately vested in their contributions and the Company’s safe harbor match and the earnings thereon. Vesting in the Company’s discretionary contributions is based on years of continuous service. Participants vest 20% after two years of credited service and 20% each year thereafter and are fully vested after six years of credited service.

Payment of Benefits – The payment of benefits can be made upon reaching age 59 ½, death, disability, hardship, or termination of employment. The Plan requires distribution payments of \$5,000 or less to be rolled over to an individual retirement account designated by the plan administrator, if the participant does not elect otherwise. For vested account balances exceeding \$5,000, the participant or beneficiary may elect to receive either a lump sum, non-recurring partial payments, or recurring installment payments.

Forfeited accounts – On December 31, 2024 and 2023, there were no significant forfeited nonvested accounts. Forfeited accounts are used to offset plan administrative fees or to offset future employer contributions. No significant forfeitures were used for the years ending December 31, 2024 and 2023.

2. **Summary of Accounting Policies**

Basis of Accounting – The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates –The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition – Investments are reported at fair value except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements and Note 5 for discussion of the investment contract.

Purchases and sales of securities are recorded on the trade-date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan’s gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses – Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Third party administrative charges for benefit distributions are paid by participants.

Payment of Benefits – Benefits are recorded when paid.

Subsequent Events – Management evaluated transactions and events occurring subsequent to December 31, 2024, and through October 13, 2025, the date the financial statements were available to be issued, to determine whether any events should be recognized or disclosed in these statements. Other than the termination of the Plan described in Note 1, there were no material transactions or events in the subsequent period requiring disclosure or recognition in the statements.

3. **Investments**

The following information included in the financial statements and in the supplemental schedules at December 31, 2024 and 2023, was obtained or derived from information certified as complete and accurate by Nationwide Trust Services.

4. **Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

5. Investment Contract with Nationwide Life Insurance Company

The Plan entered into a fully benefit-responsive guaranteed investment contract with Nationwide Life Insurance Company ("Nationwide") totaling \$178,599 and \$1,148,124 at December 31, 2024 and 2023. Nationwide maintains the contributions to the Fixed Select Contract ("Account") in a general account. The Account under the contract is credited with interest and charged for participant withdrawals and administrative expenses. Nationwide is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by Nationwide and reviewed quarterly for resetting. Nationwide may terminate the contract with the Plan by providing 90 days prior written notice.

5. Investment Contract with Nationwide - Continued

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Nationwide, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on Nationwide's ability to meet its financial obligations. Nationwide's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Withdrawals from the Account directed by the Company due to Plan termination, merger of the Plan, or reduction in the number of participants may limit the ability of the Plan to transact at contract value. In the event the payments are made directly to affected participants, these payments must be made within 30 days of written notice; if the payments are transferred to a new plan, the payment must be made within 90 days. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with Nationwide and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Party-in-interest Transactions

The Plan includes various investments managed by Nationwide Financial Services, and its subsidiaries. Nationwide Financial Services and its subsidiaries serve as the custodian and recordkeeper of the Plan and, therefore, these transactions and related expenses qualify as party-in-interest transactions.

7. Plan Termination

The Company reserves the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, the Company would discontinue its contributions and participants would become 100% vested in their Company discretionary contributions. As noted above, the Plan was terminated effective January 7, 2025.

8. Tax Status

The Company adopted the Benefit Plans, Inc. non-standardized defined contribution pre-approved plan on January 1, 2022. On June 30, 2020, the Internal Revenue Service stated the pre-approved document adopted by the Company, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has not received a determination letter specific to the Plan. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator believes the Plan has no significant uncertain tax positions. Therefore, no provision or liability for uncertain taxes has been recorded in the financial statements.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.


