Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Upper Peninsula Power Company Employee Benefit Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Upper Peninsula Power Company Employee Benefit Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 9 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Upper Peninsula Power Company Employee Benefit Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Upper Peninsula Power Company Employee Benefit Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control related matters that we identified during the audit.

NOTE 1 DESCRIPTION OF PLAN

The following description of the Upper Peninsula Power Company Employee Benefit Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on August 28, 2014, to provide eligible employees and retirees and their dependents and surviving spouses with medical, prescription, dental, vision, life insurance, a health savings account (HSA), a flexible spending account (FSA), and an employee assistance program (EAP) subject to certain limitations as defined in the Plan document. Certain Plan assets are held in a voluntary employees' beneficiary association (VEBA) trust. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Sponsor

Upper Peninsula Power Company (UPPCO, the Company) is the Plan Sponsor.

Plan Administration

The assets of the Plan, other than assets in the 401(h) Account, are maintained in the Upper Peninsula Power Company Union VEBA Trust (the Trust). The Trust is administered by the UPPCO Administrative Committee, whose members are employees of UPPCO, appointed by the UPPCO Board of Directors. The Plan is the only participant in the Trust.

State Street Bank & Trust Company (State Street) serves as the Plan's trustee, investment manager, and holds the assets of the Plan.

The Company engages third-party administrators to process benefit claims.

Eligibility

The Plan covers most administrative and union employees and retirees of the Company and its participating affiliates. Each employee who is eligible to participate in any of the benefit programs provided under the Plan, and who is not otherwise excluded, shall be eligible to become a participant in this Plan based upon the eligibility rules as described in detail in the contract describing such benefit.

Benefits

Benefits under this Plan are fully insured by outside carriers. Benefits for an eligible employee who has commenced participation under the Plan shall consist of the benefits provided pursuant to (i) the contracts, as in effect from time to time, and (ii) such other benefits payable under this Plan, for which the Participant has paid all required employee contributions, if any.

NOTE 1 DESCRIPTION OF PLAN (CONTINUED)

Benefits (Continued)

The Plan has a health savings arrangement (HSA) and a flexible spending arrangement (FSA) that are funded solely through participant contributions. The HSA and FSA allow eligible participants to be reimbursed tax free for qualified medical expenses subject to a specified ceiling. The accounts cannot be used for anything other than reimbursements for qualified medical expenses. Under the HSA, amounts remaining at the end of the year will be carried over to the next year. Any amounts remaining at the end of the year under the FSA will be forfeited. Forfeited amounts were \$682 and \$555 as of December 31, 2024 and 2023, respectively.

Contributions

It is the policy of the Company and its participating affiliates to contribute funds to the Plan in an amount necessary to fund premiums to insurance carriers and administrative expenses during the plan year on behalf of active participants. The Company will also contribute funds to the Plan for payment of insurance premiums one month in advance of coverage. All active participants make a contribution toward the cost for coverage for themselves and their dependents.

Employees who retire are provided access to the Plan for benefits coverage on an elective basis. If retired employees elect to obtain insurance through the Plan, they are generally charged a premium.

During 2024 and 2023, active employees and retirees contributed \$1,130,674 and \$977,987 to the Plan, respectively.

The Company funds anticipated benefits to be paid on behalf of eligible retired employees on a prospective basis. The level of funding is based on actuarial calculations and represents the amounts necessary to fund current and projected benefits associated with the Plan over a period of years. During 2024 and 2023, the Company contributed \$3,009,864 and \$2,725,246 to the Plan, respectively.

401(h) Account

The Upper Peninsula Power Company Retirement Plan (the Retirement Plan) includes a medical-benefit component in addition to normal retirement benefits to fund a portion of the postretirement obligations for retirees and their beneficiaries in accordance with Section 401(h) of the Internal Revenue Code (IRC). A separate account has been established and maintained in the Retirement Plan for such contributions. In accordance with IRC Section 401(h), the Plan's investments in the 401(h) account may not be used for, or diverted to, any purpose other than providing health benefits for retirees and their beneficiaries. The related obligations for health and welfare benefits are not included in the Retirement Plan's obligations but are reported as obligations in the financial statements of the Plan.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements were prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities, and actuarial present value of benefit obligations and changes therein at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the investment custodian. See Note 4 for further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statement of net assets available for benefits.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, healthcare inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

401(h) Postretirement Medical Benefits

The Retirement Plan, a defined benefit pension plan, provides 401(h) postretirement medical benefits to participants in the Plan. The Plan Accounting – Health and Welfare Benefits Plans Topic of the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) requires that the net assets held in the 401(h) account are accounted for as a Plan net asset.

Expenses

Third-party administrator, auditor, trustee, actuary, and investment manager fees are paid by the Plan. Other administrative costs are paid by the Plan Sponsor and its affiliates. Since such costs are not paid from plan assets, they have been excluded from the accompanying financial statements.

Subsequent Events

The Plan has evaluated events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date on which the financial statements were available to be issued.

NOTE 3 BENEFIT OBLIGATIONS

At December 31, 2024 and 2023, the Plan's net assets exceed the Plan's postretirement benefit obligation.

NOTE 4 FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurements and Disclosures*, are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Collective Trust Funds: Valued based on the net asset value (NAV) of units of the common collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimating fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Interest Bearing Cash: Consists of a money market mutual fund valued at the daily closing price as reported by the fund. The money market mutual fund held by the Plan is an open-end mutual fund that is registered with the Securities and Exchange Commission. The fund is required to publish its daily net asset value (NAV) and to transact at that price. The money market mutual fund held by the Plan is deemed to be actively traded.

NOTE 5 POSTRETIREMENT HEALTH AND LIFE INSURANCE BENEFITS

The Plan's postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to the date of the financial statements. Postretirement benefits include future benefits expected to be paid to or for eligible employees and their dependents. Certain participants pay 100% of the estimated cost of benefits so their future benefits are not included in the postretirement benefit figures.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical data to estimate future annual incurred benefits per participant and adjusting such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

The postretirement obligations were estimated using the medical cost trend rate of 7% and 6.50% for the years ended December 31, 2024 and 2023, respectively, reducing 0.25% for the next eight years until reaching 5% by the year 2033 and using dental cost trend rates of 5%.

Other significant assumptions used in the valuation as of December 31, 2024 and 2023 were:

- Discount rate of 5.72% and 5.20% for 2024 and 2023, respectively.
- Assumed average retirement rate of 60% by age 62 and 100% by age 65 for all administrative participants. Assumed average retirement rate of 80% by age 62 and 100% by age 65 for non-administrative participants.
- For the December 31, 2024 and 2023 measurement, the mortality assumptions for healthy lives was based on the Pri-2012 retiree and contingent annuitant tables with separate tables for males and females. The base mortality table provides separate rates for annuitants and non-annuitants with no collar adjustments. The mortality improvement assumptions were based on the MP-2020 scale for the years ended December 31, 2024 and 2023.
- Premiums paid by retiree vary based on the type of coverage selected.

The forgoing actuarial assumptions are based on the presumption that the Plan will continue. If the Plan were to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of postretirement benefit obligations. The effect of 1% increase in health care cost trend assumption would have resulted in a change of \$1,977,211 and \$2,058,493 as of December 31, 2024 and 2023, respectively.

NOTE 6 TAX STATUS

The Trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the IRC and, accordingly, the Plan's and the Trust's net investment income is exempt from income taxes. The Plan and the related Trust have obtained an exemption letter dated March 3, 2016, from the Internal Revenue Service (IRS), and the Plan Sponsor believes that the Plan and Trust, as amended, continue to qualify and to operate in accordance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intention to do so, the Company has the right under the Plan to modify benefits to participants, to discontinue the contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. Upon termination, the assets then remaining shall be subject to the applicable provisions of the Plan then in effect and shall be used to pay benefits to participants in order of their entitlement.

NOTE 8 PARTY-IN-INTEREST TRANSACTIONS

State Street is the Plan's investment manager utilized by the Plan Sponsor to manage certain investments held by the trust. State Street is the trustee and, therefore, these qualify as exempt party-in-interest transactions. At December 31, 2024 and 2023, the fair value of the assets held by the trust that were managed by State Street was \$26,868,020 and \$25,995,235, respectively. Fees paid to State Street in 2024 and 2023 were \$35,492 and \$34,499, respectively. Such amounts are considered to represent the fair market value of the services performed.

NOTE 9 CERTIFICATION OF INVESTMENT INFORMATION

State Street, the trustee, has reported and certified as to the completeness and accuracy of the investment information for purposes of preparing the financial statements and supplemental schedules related thereto. This information includes investments held at December 31, 2024 and 2023 and net appreciation in fair value of investments, interest and dividends for the years then ended.

In accordance with the procedures stated in 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and disclosure under ERISA, the audit of an independent public accountant need not extend to any statement or information prepared and certified by the trustee. The Plan Sponsor has instructed the independent public accountants to exclude the information certified by the trustee from the scope of their audits.

NOTE 10 401(H) ACCOUNT

A portion of the Plan's obligations is funded through contributions to the Retirement Plan in accordance with IRC Section 401(h). The following table presents the components of the net assets available for such obligations and the related changes in net assets available as of and for the years ended December 31, 2024 and 2023.
