### **Note A**

#### **Description of Plan**

The following description of the Tourism Holdings USA, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

#### **General**

The Plan is a profit-sharing and deferred-compensation plan which covers substantially all employees of El Monte Rents, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

The Setting Every Community Up for Retirement Enhancement Act of 2019 ("SECURE Act") was signed into law on December 20, 2019, and the SECURE 2.0 Act of 2022 ("SECURE 2.0") was enacted on December 29, 2022. These laws include numerous provisions impacting retirement plans, including, but not limited to, changes to the required minimum distribution age, eligibility for long-term part-time employees, automatic enrollment requirements for certain new plans, and expanded withdrawal and contribution options. The provisions of these laws become effective on various dates. The Plan is evaluating the impact of the SECURE Act and SECURE 2.0 and will implement required changes in accordance with applicable effective dates and regulatory guidance.

#### **Plan Administration**

The Company is the administrator of the Plan and, as such, carries out the duties imposed by ERISA. The Company has delegated certain responsibilities for the operation and administration of the Plan. Trustee, custodial, and recordkeeping services are provided by Empower Retirement. Certain administrative expenses of the Plan are paid by the Company for the year ended December 31, 2024. Investment fees, which may vary according to the individual funds selected, are paid out of the assets of the Plan. Participants should refer to the prospectus of the individual investment funds for further details on individual investment fees.

#### **Eligibility**

With the exception of union employees whose employment is governed by a collective bargaining agreement, non-resident aliens, leased employees, and reclassified employees, the Company's employees become eligible to participate in the Plan after reaching the age of 21 and following completion of one year of service as defined by the Plan. Employees may enter the Plan on the first day of the month subsequent to satisfying the eligibility.

#### **Contributions**

Participants may elect to contribute through payroll deductions amounts not less than 1% and not more than 90% of their annual compensation, as defined by the Plan on a pre-tax basis, up to a maximum amount allowed by the Internal Revenue Code ("IRC"). Roth contributions are also permitted.

The maximum allowed deferral amounts were \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants over the age of 50 may also contribute an additional \$7,500 to the Plan for 2024 and 2023. Participants are also allowed to rollover contributions from other qualified employer-sponsored retirement plans.

### Note A

#### Description of Plan (Continued)

The Plan provides for automatic enrollment. Any newly eligible employee who has not affirmatively elected to contribute to the Plan or has not affirmatively declined to participate in the Plan will be automatically enrolled in the Plan with a 3% withholding of pretax annual compensation. This withholding will increase by 1% each subsequent year until the automatic election reaches a maximum withholding contribution of 10% of compensation.

The Company may make discretionary matching and/or profit sharing contributions as determined by the Company's management. During the year ended December 31, 2024, the Company matched 50% of the participant's deferrals up to the first 4% of eligible compensation. The Company made no discretionary profit sharing contributions to the Plan for the year ended December 31, 2024.

#### Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$5,232 and \$9,207, respectively. These accounts will be used to reduce future Company contributions or to pay Plan expenses. During 2024, forfeited nonvested accounts totaling \$34,178 were used to reduce Company contributions and \$250 were used to pay Plan expenses.

#### Participant Accounts

Each participant's account is credited with the participant's contributions, employer matching contributions and allocations of the Company's profit sharing contributions, if any, and Plan earnings. Participant accounts may be charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on the participant's eligible compensation, participant contributions, investment elections, specific participant transactions and/or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their contributions, plus actual net earnings thereon. The Vesting in the Company's discretionary matching and/or profit sharing contributions, plus actual net earnings is based on years of service and hours worked during the calendar year.

#### **Description of Plan (Continued)**

##### Notes Receivable from Participants

Under the terms of the Plan, participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their account balance. Loan terms range from one to five years. Loans are secured by the balance in the participant's account and bear interest at the prime rate as published in the Wall Street Journal plus 2% (7.50% at December 31, 2024), which the administrator believes is commensurate with local prevailing rates. The repayment of principal plus interest is generally required by the Plan to be made through payroll deductions. If loan payments are not made in accordance with the terms of the loan, a deemed distribution may occur in the amount of the unpaid loan balance.

##### Payment of Benefits

Upon termination of service due to death, disability, retirement (age 65), or other reasons, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in their account, installment payments or a partial withdrawal. All vested account balances exceeding \$1,000, but not exceeding \$5,000, may be rolled into an Individual Retirement Account. All vested account balances not exceeding \$1,000 may be immediately distributed in a lump-sum payment. Hardship withdrawals and in-service withdrawals at age 59 1/2 are also permitted, subject to provisions described in the Plan document.

### **Note B**

#### **Significant Accounting Policies**

##### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting and are in conformity with accounting principles generally accepted in the United States of America.

##### Use of Estimates

The preparation of financial statements requires plan administrators to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

##### Contributions

Participant contributions and the related Company matching contributions are to be recognized in the period the participant contribution is withheld from compensation.

##### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note G for discussion of fair value measurements.

#### **Significant Accounting Policies (Continued)**

Purchases and sales of securities are recorded on a trade date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held, during the year. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan agreement.

#### **Payment of Benefits**

Benefits are recorded when paid.

### Note C

#### **Income Tax Status**

The Plan has adopted a pre-approved plan of Empower Retirement, LLC, which received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, stating that the Plan, as then designed, was in accordance with applicable sections of IRC and that any employer adopting this form of the Plan will be considered to have a plan qualified under applicable sections of the IRC. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note D

#### **Unaudited Information Provided by Trustee**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income from notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC, the trustee of the Plan.

### Note E

#### **Party-In-Interest Transactions**

Certain Plan investments are managed by affiliates of Empower Trust Company, LLC. Empower Trust Company, LLC is the trustee and recordkeeper as defined by the Plan. These transactions qualify as exempt party-in-interest transactions.

### Note F

#### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### Note G

#### **Fair Value Measurements**

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 3 inputs for the period presented.

The Plan management has adopted the provision of ASU 2015-07 which removed the requirement to categorize within the fair value hierarchy investments for which fair value are estimated using the net asset value (NAV) as a practical expedient.

The following is a description of the valuation methodologies used at December 31, 2024 and 2023. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies:* These investments are public investment vehicles valued using the NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. The NAV is a quoted price in an active market and classified within Level 1 of the valuation hierarchy.

*Common/ collective trust fund:* The stable value fund is composed primarily of fully benefit responsive investment contracts contained in a collective trust fund and is valued at the NAV of the units of the collective trust fund. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Certain events would limit the ability of the Plan and the trusts to transact at fair value. The Plan Administrator does not believe that any such events are probable of occurring.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Fair Value Measurements (Continued)

The Plan's policy is to recognize transfers between Levels 1 and 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023, there were no transfers between Levels 1 and 3 and no transfers into or out of Level 3.

### Note H

#### Risk and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### Note I

#### Prohibited Transactions

During the Plan year ended December 31, 2024, the plan sponsor inadvertently failed to deposit \$36,558 of participant deferrals and repayments on notes receivable within the required timeframe as stated by ERISA. These deferrals and repayments on notes receivable were deposited beyond the earliest expected date on which assets could be segregated from the employer's assets. The U.S. Department of Labor considers late deposits to be prohibited transactions.

Two late remittances were identified during the year. One of these was corrected through self-correction procedures, while the other remains outstanding as of year-end. The Plan Sponsor has initiated steps to address the remaining late deposit and to prevent recurrence. Management does not believe these issues will have a material impact on the Plan's net assets available for benefits or the Plan's tax status.
