Independent Auditor's Report

To the Plan Administrator and Management of the U.S. OCCMED Holdings, LLC 401(k) Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of *U.S. OCCMED Holdings, LLC 401(k) Plan*, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the *U.S. OCCMED Holdings, LLC 401(k) Plan* financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Opinion

Basis for Opinion

Emphasis of Matter

As discussed in Note 9 of the financial statements, the Plan has prohibited transactions. As discussed in Note 10 of the financial statements, the 2023 financial statements have been restated to correct errors identified in Note 9. Our opinion as stated in the previous paragraph is not affected by these matters.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the *U.S. OCCMED Holdings, LLC 401(k) Plan's* ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 – Description of Plan

The following description of the U.S. OCCMED Holdings, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established effective April 1, 2001, as restated January 1, 2022. The Plan covers all employees who have completed one month of service and that are 21 years of age, excluding those Employees covered by a collective bargaining agreement, non-resident aliens, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions

Each year, participants may contribute a percentage of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants may also designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company contributes a safe harbor match of 100% of the first 3% of compensation deferred and 50% of the next 2% of compensation deferred to the participant's 401(k) accounts. Contributions are subject to certain Internal Revenue Service (IRS) Limitations.

Participants Accounts

Each participant's account is credited with the participant's contributions, matching contributions, as well as an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, rollovers, safe harbor matching contributions, plus actual earnings on contributions. Vesting in the Company's discretionary matching contribution portion of their accounts is based on years of continuous service. The participant is awarded 20% every year after two years of credited service and are fully vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's

account. The loan interest rate is set at the prime rate plus 1% and only changes when the prime rate changes. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or other reasons, a participant may elect to receive a lump sum equal to the value of the participant's vested interest in his or her account or rollover to an IRA. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment or transfer to an IRA.

Forfeitures

As of December 31, 2024, and 2023, forfeited non-vested accounts totaled \$0 and \$1,128, respectively. These accounts can be used to reduce future employer contributions or to pay plan administrative expenses. During 2024 and 2023, \$8,404 and \$24,870 in forfeitures were used to pay employer contributions, respectively.

Note 2 – Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of Fair Value Measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on an accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included as administrative expenses in the financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

Subsequent events were evaluated through October 14, 2025, the date the financial statements were available to be issued.

Note 3 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities within active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

- Money market funds – Valued at the quoted net asset value (NAV) of shares held by the Plan at year end.
- Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 4 – Information Certified by the Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Ascensus Trust Company, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4(i) Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statements of Changes in Net Assets Available for Benefits for the year ended December 31, 2024 and 2023.

Note 5 – Related-Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by the Trustee, and therefore, these transactions qualify as party-in-interest transactions. Additionally, the Plan issues loans to participants, which are secured by the participant’s account balances. These transactions also qualify as party-in-interest transactions. Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor, and no officer or employee receives compensation from the Plan.

Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in the fair value of the investment, as they are paid through revenue sharing, rather than direct payment. Vanguard receives revenue from investment fund service providers for services provided to the funds. This revenue is used to offset certain amounts owed to Vanguard for its administrative services to the Plan. All the above transactions are exempt party-in-interest transactions.

The known parties-in-interest that have provided services to the Plan for 2024 and 2023 are as follows:

- The Plan Sponsor provides administrative services and absorbs administrative costs of the Plan.
- Vanguard serves as Custodian of the Plan and Third-Party Administrator.
- Ascensus Trust Company serves as Trustee.
- Calvin Martin & Company, PLLC serves as the Plan auditor.
- The Plan has notes receivable from participants.

Note 6 – Plan Termination

In 2025, the Plan Sponsor was acquired by Concentra Health Care, Inc. During diligence for the acquisition, it was determined that the Plan Sponsor would continue to maintain, correct and subsequently terminate the Plan. The Plan was frozen effective 03/01/2025, and no further contributions have been made after that date.

Prior to completing the termination process, the Plan Sponsor is performing compliance reviews and corrections of certain errors identified during due diligence (See Note 9). These corrections are being addressed in accordance with the applicable provisions of DOL’s Voluntary Fiduciary Correction Program (“VFCP”) and the IRS’s Employee Plans Compliance Resolutions System (“EPCRS”) Self Correction Program (“SCP”).

Once all necessary corrections have been completed and regulatory approvals obtained, the Plan Sponsor intends to distribute all Plan assets to participants and beneficiaries in accordance with the Plan’s provisions and applicable law. Until the termination process is finalized and distributions are made, the Plan will continue to operate as a frozen plan, and assets will remain invested for the exclusive benefit of participants.

Note 7 – Tax Status

The Plan adopted a non-standardized pre-approved plan offered by Ascensus, LLC. The pre-approved plan received an IRS Opinion Letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the IRS Opinion Letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants’ account balances, and the amounts reported in the statement of net assets available for benefits.

Note 9 – Prohibited Transactions

Qualified Non-Elective Contribution (QNEC)

A controlled group/affiliated service group analysis was performed on the Company and related entities in 2015. At that time, it was determined that all the entities participating in the Plan were in a single controlled group or affiliated service group and that the Plan was a single employer plan. Thereafter, additional employers began participating in the Plan, and the ownership structure of the Company and/or related entities changed from time to time.

After 2015, no controlled group or affiliated service group analysis was performed until the lead-up to the sale of the Company. During due diligence for the sale, analysis of all years from 2016 through 2024 was performed. The analysis concluded that a single controlled group or affiliated service group did not exist that encompassed all employers participating in the Plan. As a result, the Plan was, in operation, a multiple employer plan from 2016 through the sale of the Company in 2025.

Based on identification of related and unrelated employers who adopted the Plan, the Company performed the required testing to ensure compliance in prior years. The Plan sponsor amended the Plan to elect out of safe harbor 401(k) status for the 2020 plan year during the COVID shutdown. This required the Plan to be tested for non-discrimination regarding 401(k) deferrals and matching contributions as well as ensure that the Plan satisfies the top-heavy requirements of IRC Section 416.

The plan failed ADP and ACP testing in 2020 and 2021 based on the change to be treated as multiple employer plan. The Plan Sponsor is correcting the testing failure through a QNEC to participants as part of the 1:1 correction method submission with IRS's EPCRS SCP.

The most recent testing indicated the QNEC to affected participants' accounts in the amount of \$110,146 and \$286,860 for 2020 and 2021 respectively. The amounts include lost earnings due to participants. As of December 31, 2023, a liability of \$397,006 was recorded as a QNEC related to the correction of failed ADP/ACP testing.

The Plan Sponsor has paid the QNEC due to the Plan in the amount of \$397,006 on September 26, 2025. Since payment of the QNEC, the Plan Sponsor has indicated that the testing is still in progress and further corrections may be needed.

Delinquent Participant Contributions

During the review of compliance testing initiated by the due diligence related to the sale of the Company, it was discovered that two payroll errors in 2022 and 2023 resulted in Plan Sponsor not timely remitting certain participant contributions to the Plan. The delinquent contributions were previously remitted, but lost earnings were not included to be fully corrected. The Plan Sponsor is in the process of remitting lost earnings to make affected participants whole. The total amount of contributions pending to be corrected is \$33,523 as of December 31, 2024.

As of December 31, 2024, the Plan Sponsor has accrued an estimated liability of \$1,960 for the payment of lost earnings related to the untimely remittance of participant contributions. The Plan Sponsor intends

to submit the correction to the DOL under the VFCP. Payment of the lost earnings will be made upon completion of the VFCP filing.

The related prohibited transaction is reported on Form 5500, Schedule H, line 4a Delinquent participant contributions, in accordance with DOL reporting requirements.

Note 10 – Restatement of Prior Year Financial Statements

The financial statements for the year ended December 31, 2023, have been restated to correct errors from failed testing and untimely contributions (See Note 9). In prior years, failed testing and untimely contributions resulted in the need for an accrual of QNEC and lost earnings contributions, resulting in an understatement of QNEC contribution (\$397,006) and lost earnings (\$1,746). The effect of the restatement increased contributions and net assets available for benefits by \$398,752 as of December 31, 2023.
