## **Note 1. Description of Plan**

The following description of the Didlake, Inc. 401(k) Plan (Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

### ***General***

The Plan is a defined contribution retirement plan covering substantially all employees of Didlake, Inc. (Company) with the exception of those considered to be highly compensated employees. Employees are immediately eligible to participate for employee elective deferrals, employer matching deferrals, and prevailing wage contributions. Employees over the age of 21 who have one year of service are eligible for profit-sharing contributions. John Hancock Life Insurance Company serves as the custodian of the Plan. The Plan Administrator of the Company controls and manages the operation and administration of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### ***Contributions***

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans and certain individual retirement accounts. The Company provides prevailing wage contributions for participants when required by certain government contracts. Prevailing wage contributions for 2024 totaled 1,302,808. The Company may make a matching contribution equal to a discretionary percentage, to be determined by the Company. During 2024, the Company matched 200% of each participant's contribution up to 3%, who are not eligible for prevailing wage contributions, resulting in a maximum matching contribution equal to 6% of compensation. Employees receiving prevailing wage contributions received up to a 1% match for 2024. Additional profit-sharing contributions may be made at the discretion of the Company. No additional profit-sharing contributions were made in 2024. Contributions are subject to certain limitations.

### ***Investment Options***

Participants direct the investment of their accounts into various investment options offered by the Plan. The Plan currently offers pooled separate accounts and a stable value common collective trust account as investment options for participants.

### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions and plan earnings (losses), and charged with benefit payments and transaction fees related to notes receivable from participants and distributions and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are vested immediately in their contributions as well as employer matching and prevailing wage contributions, plus actual earnings thereon. Participants are subject to vesting in the Company's profit-sharing contributions based on years of service, as defined by the Plan. A participant is 100% vested after 6 years of credited service.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are set at 1% above the prime interest rate. At December 31, 2024, outstanding loans generally bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, retirement, disability or death, a participant may elect to receive a lump sum amount equal to the vested value of their account. Hardship distributions are available upon demonstration of financial hardship with limitations as defined in the Plan. In-service distributions are available from fully vested sources after the participant reaches age 59½.

***Forfeitures***

At December 31, 2024 and 2023, there were no forfeited non-vested accounts. Forfeited balances can be used to reduce future Company contributions or pay plan expenses.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America (GAAP).

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results could differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the custodian. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income from notes receivable from participants is recorded when received. Other interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

### ***Contributions***

Contributions from plan participants and contributions from the Company are recorded in the year in which the participants' contributions are withheld from amounts paid. All participant and Company contributions are participant-directed.

### ***Payment of Benefits***

Benefits are recorded upon distribution.

### ***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. The amount charged to each participant is based on the nature of the expense. Depending on the nature of the expense, it is either charged evenly to all participants or on a pro-rata basis based on their investment balance. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

### ***Subsequent Events***

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

## **Note 3. Fair Value Measurements**

Fair value as defined under GAAP is an exit price, representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1**     Observable inputs such as quoted prices in active markets.
- Level 2**     Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3**     Unobservable inputs about which little or no market data exists, therefore, requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment, and may affect the valuation of fair value assets and liabilities and their placement within the fair value hierarchy levels.

There have been no changes in methodologies used at December 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

### ***Pooled Separate Accounts***

The Plan invests in pooled separate accounts for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the net asset value (NAV) of units, as determined by John Hancock Life Insurance Company, as the estimated fair value. Because quoted prices in active markets for identical assets are not available, these prices are determined using observable market information such as quotes from less active markets and/or quoted prices of securities with similar characteristics.

***Stable Value Collective Trust Fund***

The Plan invests in a stable value collective trust fund for which quoted prices are not available in active markets for identical instruments. The Plan utilizes the NAV provided by the custodian as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the stable value collective trust fund, the issuer reserves the right to require 12-months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

There were no investments at December 31, 2024 and 2023 that are required to be reported within the fair value hierarchy. In accordance with Topic 820, investments that were measured at NAV (or its equivalent) have not been classified in the fair value hierarchy.

- (E) Represents investment in a common collective trust fund consisting of securities in U.S. government agencies, foreign government agencies, mortgage-backed securities, and various fixed-income securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5. Exempt Party-in-Interest Transactions**

Certain plan assets are invested in funds managed by John Hancock Life Insurance Company (Hancock), the custodian of the Plan. Therefore, Hancock is a party-in-interest. Fees paid to Hancock and its affiliates by certain participants in the Plan for participant-initiated transaction fees were \$9,345 during 2024. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund. Fees paid by the Plan to third parties for administrative and recordkeeping services during 2024 totaled \$229,090.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants become fully vested in their accounts.

**Note 7. Tax Status**

The Plan has not obtained a determination letter from the Internal Revenue Service (IRS) stating that the Plan was in compliance with the applicable requirements of the IRC. The Plan is relying on the IRS approval of the pre-approved plan that it is utilizing. The IRS has determined and informed the document sponsor by a letter dated June 30, 2020, that the pre-approved plan document was designed in accordance with applicable sections of the IRC. The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.


