Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the University Radiology Group Profit Sharing Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the University Radiology Group Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Note 1. Description of Plan

The following description of the University Radiology Group Profit Sharing Plan (Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan was established on December 31, 1970, and amended and restated on January 1, 2021. The Plan is a defined contribution plan covering all full-time employees of University Radiology Group, LLC, and other related companies and affiliates (collectively the Company or the Employer). The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Eligibility and Contributions

An employee shall be eligible to become a participant in the Plan and to make elective deferrals and receive employer matching contributions immediately after satisfying the eligibility requirements of attaining age 21 and completing one year of service, as defined (Eligibility Requirements).

Employees who become eligible on or after January 1, 2020, are automatically enrolled in the Plan immediately after satisfying the Eligibility Requirements at a pre-tax deferral percentage of 2%. Employees may elect not to participate in the Plan. Employees auto-enrolled in the Plan are subject to an annual auto escalation of 1% on the first day of each plan year, unless the employee makes a contrary election. The automatic escalation cannot increase an employee's pre-tax deferral percentage higher than a maximum rate of 5%.

Participants may elect to defer up to 100% of their eligible compensation, as defined, as pre-tax or Roth contributions.

The Company makes matching contributions on a plan year basis equal to 50% of the first 4% of the participants' elective contributions.

Each year the Company may contribute a discretionary profit-sharing contribution. An employee shall be eligible to receive a discretionary profit-sharing contribution on January 1 or July 1 coinciding with or next following the date they satisfy the Eligibility Requirements and must be employed on the last day of the year. Employer profit-sharing contributions are calculated on a plan year basis. The Company made a discretionary profit-sharing contribution for the years ended December 31, 2024 and 2023, ranging from 8% to 14% of eligible compensation depending on the participant's group.

Participants' Accounts

Each participant's account is credited with their contributions, employer contributions and the earnings thereon. Contributions to the Plan are invested by the custodian as directed by the participants. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan.

Notes Receivable from Participants

Each participant is permitted to borrow a minimum of \$1,000 up to the lesser of \$50,000 reduced by the highest outstanding loan balance incurred during the 12-month period ending on the day before the date on which the loan was made or 50% of his or her vested account balance. A participant may have up to two loans outstanding at a time. The term of a loan may not exceed five years, unless it is used to purchase a primary residence. Principal and interest is paid ratably through monthly payroll deductions. Loans are measured at their unpaid

principle balance plus any accrued but unpaid interest. The loans are secured by the balance in the participant's account. Interest rates are based on prevailing rates at the inception of these loans (ranging between 4.25% and 9.50% at December 31, 2024). Principal and interest is paid ratably through biweekly payroll deductions.

Vesting

Participants are immediately and fully vested in their own contributions. Participants vest in employer matching and profit-sharing contributions based on years of service (as defined) as follows:

Benefits

A participant's vested interest in the Plan's assets is distributable generally upon termination, disability, retirement or death. Participants may withdraw from their individual accounts pursuant to specific guidelines as set forth in the Plan Document.

Forfeitures

The portion of a participant's balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. The Plan provides for terminated employees who resume employment before the earlier of incurring five consecutive one-year breaks in service or receipt of an actual or deemed cash-out distribution, to have any forfeited amounts reinstated. Plan participants' forfeitures are applied to reduce the Company's contributions for the plan year and, if applicable, any remaining amount shall be applied toward succeeding plan years until fully utilized. Forfeitures from participants for the year ended December 31, 2024, approximated \$122,000, while forfeitures applied against employer contributions approximated \$132,000. At December 31, 2024 and 2023, the available forfeiture balance approximated \$129,000 and \$132,000, respectively.

Administrative Expenses

Administrative expenses are being paid by the Company; however, in the event that the Company does not pay such expenses, they shall be paid by the Plan in accordance with the Plan's provisions.

Note 2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Plan investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Note 3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company (Vanguard), a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

Level 1 Unadjusted quoted prices in active markets for identical investments

Level 2 Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the asset or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Significant unobservable inputs, including the Company's own assumptions in determining the fair value of investments

Following is a description of the valuation methodologies used for assets measured at fair value:

- Mutual funds: Shares held by the Plan at year-end are valued at quoted prices in an active market
- Common collective trusts: The fair value of the common collective trusts are determined by the trustee of the common collective trust based on the underlying assets. Participant-directed redemptions can be made on any business day and do not have a redemption notice period and there are no unfunded commitments.
- Participant directed brokerage investments: Includes common corporate stock, for which the fair value is valued at the closing price reported on the active market on which the individual stock is traded, registered investment companies, corporate bonds, U.S. Treasury bonds, and noninterest-bearing cash

There have been no changes in the valuation methodologies used at December 31, 2024 and 2023.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Tax Status

On June 30, 2020, the Internal Revenue Service (IRS) stated that the volume submitter plan adopted by the Plan, as then designed, qualifies under Section 401(a) of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself; however, the Plan Administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of both December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company reserves the right to amend, alter or terminate the Plan subject to the provisions of the ERISA. If the Plan is terminated, the amount credited to the account of each participant will be fully vested.

Note 7. Risks and Uncertainties

The Plan's investments are concentrated in mutual funds, participant directed brokerage investments, and a common collective trust that invest in various investment securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.

Note 8. Related-Party Transactions

Certain Plan investments are managed by Vanguard and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to Vanguard by the Plan for management services amounted to \$105,940 for the year ended December 31, 2024.

Note 9. Subsequent Events

The Plan has evaluated subsequent events through October 10, 2025, the date the financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.
