Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the accompanying financial statements of Adams Land & Cattle, LLC, 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

NOTE 1. DESCRIPTION OF THE PLAN

The following description of Adams Land & Cattle, LLC, 401(k) Plan (the Plan), provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all eligible employees of Adams Land & Cattle, LLC (the Company), who are 18 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Trustees oversee governance of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance.

Contributions

Each year, participants may make voluntary salary deferral contributions up to 100% of pretax annual compensation, subject to specific dollar limits determined by the Internal Revenue Service (IRS). Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing rollover distributions from other qualified plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and fixed annuities as investment options for participants.

The Plan year beginning on January 1, 2013, was amended to allow for the Qualified Automatic Contribution Arrangement (QACA). Under QACA provisions, if an employee does not complete and return a salary deferral agreement, then the employer will automatically withhold the applicable percentage as indicated below of the employee's eligible compensation from his or her pay each payroll period and contribute that amount to the Plan as a salary deferral:

5 and thereafter	6%

If the employee was a participant as of the effective date of the QACA provision, then the automatic deferral provisions apply unless the employee has a salary deferral agreement in effect on the automatic deferral provision date. If the employee becomes a participant on or after the effective date of the automatic deferral provision, January 1, 2013, then these provisions will automatically apply.

Contributions (Continued)

The Company contributes 100% of the participant salary deferrals that do not exceed 2% of the base compensation and 50% of the participant salary deferrals that exceed 2% of the participant salary deferrals, but do not exceed 6% of the participant salary deferrals. Examples of the matching contributions are as follows:

Salary Deferral Tier	Matching Percentage
Deferral rate of 1%	1.0%
Deferral rate of 2%	2.0%
Deferral rate of 3%	2.5%
Deferral rate of 4%	3.0%
Deferral rate of 5%	3.5%
Deferral rate of 6%+	4.0%

For each Plan year, the Company may contribute to the Plan out of its net profits or accumulated earnings, an amount determined by the Board of Directors (the Board). This amount is a discretionary amount but cannot exceed allowable deduction limits under the federal income tax laws. The Company has not made any contributions under the profit-sharing component of the Plan to this point.

Participant Accounts

Each participant's account is credited with the participant's contribution, the Company's corresponding matching contribution, and allocations of the Company's discretionary profit-sharing contribution and Plan earnings (losses) and is charged with an allocation of fund administrative fees. The allocations for the Company's discretionary profit-sharing contributions are calculated using the percentage of each eligible participant's compensation to the total eligible compensation. The allocation of the Plan earnings is calculated and prorated according to each eligible participant's investment elections and percentage of net assets held of the total Plan at the beginning of the Plan year adjusted for withdrawals and forfeited account balances. The allocation of the fund administrative fees is calculated and prorated according to each eligible participant's percentage of net assets held.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's matching QACA contributions is based on years of continuous service. A participant vests according to the following schedule:

Vesting (Continued)

Vesting in the Company's discretionary profit-sharing contribution portion of their accounts is based on years of continuous service. A participant vests gradually over six years. As the discretionary profit-sharing contributions were made prior to the adoption of the QACA provision beginning on January 1, 2013, all discretionary profit-sharing contributions are fully vested.

Regardless of the vesting schedule, participants' matching contributions shall become fully vested on or after the participants' early or normal retirement age or upon death or permanent disability.

Notes Receivable From Participants

The Plan does not allow participants to borrow on their accounts.

Payment of Benefits

On termination of services for any reason, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, substantially equal installments, or partial withdrawals.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,401 and \$730, respectively. These accounts will be used to reduce future employer contributions. In the years ended December 31, 2024 and 2023, the amount of forfeitures used to offset contributions was \$17,233 and \$15,666, respectively.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Investment contracts held by a defined contribution plan are required to be reported at fair value, except for fully benefit responsive investment contracts (FBRICs). Contract value is the relevant measure attribute for that portion of the net assets available for benefits of a defined contribution plan, attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contribution Receivables

Contributions based on facts that existed at year end, but were not remitted to the Plan before year end are recognized as contribution receivables. They are separately identified as participant, employer, and other employer contributions. Other employer contributions receivable includes qualified nonelective contributions from the employer due to operational circumstances that require a corrective contribution. The associated change in net assets available for benefits is presented as other employer contributions.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

NOTE 3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active market for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820 are described as follows:

Level 1 - Unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 - Inputs are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds - Valued at the daily closing prices as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company of America (Empower) (previously named Great-West Life & Annuity Insurance Company). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

NOTE 4. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by the insurance company, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the Plan's ability to transact at contract value with the insurance company. Such events include the following: (a) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under the Employee Retirement Income Security Act of 1974. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with Plan participants are probable of occurring. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

NOTE 5. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, Plan management instructed the Plan's independent auditors not to perform auditing procedures with respect to the following information certified as complete and accurate by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, except for comparing such information certified by the Empower Annuity Insurance Company of America and Empower Trust Company, LLC, with information included in the Plan's financial statements and supplemental Schedule H, Line 4i - Schedule of Assets (held at end of year):

Certain Plan investments are shares of mutual funds managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is the custodian defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the investment management services amounted to \$36,894 and \$28,445, for the years ended December 31, 2024 and 2023, respectively.

Benefit Plans, Inc., was the third-party administrator for the Plan to May 2023; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the administrative services amounted to \$- 0 - and \$3,047, for the years ended December 31, 2024 and 2023, respectively.

Ascensus Holdings, Inc., has been the third-party administrator for the Plan since May 2023; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the administrative services amounted to \$5,325 and \$1,375, for the years ended December 31, 2024 and 2023, respectively.

HUB Investment Advisors, Inc., is the investment advisor for the Plan; therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for the advisory services amounted to \$34,139 and \$27,307, for the years ended December 31, 2024 and 2023, respectively.

Certain administrative functions are performed by officers and employees of the Company. No officer or employee receives compensation from the Plan for these services. All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 7. PLAN AMENDMENTS

On August 9, 2024, the Plan was amended, effective January 1, 2023. The amendment changed the definition of compensation to exclude bonuses and to correct a typing error in the matching contribution provisions. Both of these changes bring the plan document to the same provisions as the plan document in effect prior to the January 1, 2023, restatement, and the provisions under which the Plan was operating.

NOTE 8. PLAN TERMINATIONS

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

NOTE 9. TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has adopted the provisions of FASB ASC 740-10, *Accounting for Uncertain Tax Positions*. The Plan continually evaluates expiring statutes of limitations, audits, proposed settlements, changes in tax law, and new authoritative rulings.
