## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Plan Management, Board of Directors, Retirement Plan Committee, and Participants of Lipari Foods 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Lipari Foods 401(k) Profit Sharing Plan (Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTE A – DESCRIPTION OF PLAN

The following description of Lipari Foods 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Lipari Foods Operating Company, LLC (Company) who have 6 months of service (no age requirement). The Plan was originally effective January 1, 1990. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute (employee contributions) up to the maximum allowed by the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of plan compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant.

Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan provided a discretionary matching contribution (employer contributions) which was calculated at 50% of employee contributions up to the first 6% of plan compensation (3% maximum match). The Plan also allows for additional discretionary contributions upon proper Company approval.

Participants direct the investment of these contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with participant contributions, and allocations of earnings / losses, administrative expenses, etc. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service and a 6-year graded vesting schedule. A year of service is earned for vesting purposes based on the elapsed time method.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

Upon termination of service, a participant may elect to receive their vested account balance. Distributions are made as a lump sum, partial withdrawals, or installments.

Under certain circumstances, a participant may be able to elect a distribution prior to termination of service. If a participant has a financial hardship or once a participant reaches a certain age as defined in the plan agreement, they can elect a distribution.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,556 and \$6,723, respectively. These accounts are used to reduce employer contributions, and/or pay administrative expenses of the Plan. During the plan year ended December 31, 2024, \$497,634 of these accounts were used to reduce employer contributions.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan

administrator determines the Plan's valuation policies utilizing information provided by the Plan's trustee, record-keeper, and investment manager. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment.

### Contributions

Employee contributions are recorded in the period in which they are withheld from compensation. Employer contributions, as applicable, are recorded in the period in which they become employer obligations as defined by the plan agreement. No allowance has been recorded on contributions receivable, as applicable.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in 2025 and 2024, respectively.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation / depreciation in fair value of investments. Certain fees relating to the administration of notes receivable from participants, processing withdrawals, record-keeping, administration, investment management services, etc. are included in administrative expenses and charged directly to the participant's account.

### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### **NOTE C – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include -

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value (there have been no changes).

### Mutual Funds (Level 1)

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission (SEC). The funds must publish their daily net

asset value (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

### Common Trust Funds (Not Classified)

The fair value of common trust funds is based on the net asset value (NAV) of units as reported by the fund. The NAV is used as a practical expedient to estimate fair value, which is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**NOTE D – CERTIFIED INVESTMENTS**

Certain information in the accompanying financial statements and ERISA-required supplementary schedule related to investments held as of December 31, 2024 and 2023, and net appreciation / depreciation in fair value of investments, and dividends (investment income) for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (a qualified institution).

**NOTE E – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity. Fidelity Management Trust Company is the trustee of the Plan. The Plan also has “Notes Receivable from Participants” (participant loans). These transactions qualify as party-in-interest transactions.

Fidelity also received payments from the Plan for services provided, such as for record-keeping, administration, etc. Direct fees totaled \$208,928 during the plan year ended December 31, 2024. Additional fees were paid indirectly and netted with investment income.

OneDigital received payments from the Plan for investment management services. Direct fees totaled \$45,100 during the plan year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE G – TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the

pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### **NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator, Plan Management, Board of Directors, Retirement Plan Committee, and Participants of Lipari Foods 401(k) Profit Sharing Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of **Lipari Foods 401(k) Profit Sharing Plan (Plan)**, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. ### NOTE A – DESCRIPTION OF PLAN

The following description of Lipari Foods 401(k) Profit Sharing Plan (Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan covering substantially all employees of Lipari Foods Operating Company, LLC (Company) who have 6 months of service (no age requirement). The Plan was originally effective January 1, 1990. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### Contributions

Each year, participants may contribute (employee contributions) up to the maximum allowed by the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan, unless they affirmatively elect not to participate, with a default deferral rate set at 3% of plan compensation. Contributions are automatically invested in a designated balanced fund until changed by the participant.

Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

The Plan provided a discretionary matching contribution (employer contributions) which was calculated at 50% of employee contributions up to the first 6% of plan compensation (3% maximum match). The Plan also allows for additional discretionary contributions upon proper Company approval.

Participants direct the investment of these contributions into various investment options offered by the Plan.

#### Participant Accounts

Each participant's account is credited with participant contributions, and allocations of earnings / losses, administrative expenses, etc. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Vesting in employer contributions plus actual earnings thereon is based on years of continuous service and a 6-year graded vesting schedule. A year of service is earned for vesting purposes based on the elapsed time method.

### Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates. Principal and interest is paid ratably through payroll deductions.

### Payment of Benefits

Upon termination of service, a participant may elect to receive their vested account balance. Distributions are made as a lump sum, partial withdrawals, or installments.

Under certain circumstances, a participant may be able to elect a distribution prior to termination of service. If a participant has a financial hardship or once a participant reaches a certain age as defined in the plan agreement, they can elect a distribution.

### Forfeited Accounts

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$7,556 and \$6,723, respectively. These accounts are used to reduce employer contributions, and/or pay administrative expenses of the Plan. During the plan year ended December 31, 2024, \$497,634 of these accounts were used to reduce employer contributions.

## **NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan

administrator determines the Plan's valuation policies utilizing information provided by the Plan's trustee, record-keeper, and investment manager. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation / depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the plan year.

### Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment.

### Contributions

Employee contributions are recorded in the period in which they are withheld from compensation. Employer contributions, as applicable, are recorded in the period in which they become employer obligations as defined by the plan agreement. No allowance has been recorded on contributions receivable, as applicable.

### Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRC are recorded as a liability, with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants in 2025 and 2024, respectively.

### Payment of Benefits

Benefits are recorded when paid.

### Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation / depreciation in fair value of investments. Certain fees relating to the administration of notes receivable from participants, processing withdrawals, record-keeping, administration, investment management services, etc. are included in administrative expenses and charged directly to the participant's account.

### Subsequent Events

The Plan has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

### **NOTE C – FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include -

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value (there have been no changes).

### Mutual Funds (Level 1)

Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission (SEC). The funds must publish their daily net

asset value (NAV) and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

### Common Trust Funds (Not Classified)

The fair value of common trust funds is based on the net asset value (NAV) of units as reported by the fund. The NAV is used as a practical expedient to estimate fair value, which is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

**NOTE E – RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS**

Certain plan investments are managed by Fidelity. Fidelity Management Trust Company is the trustee of the Plan. The Plan also has “Notes Receivable from Participants” (participant loans). These transactions qualify as party-in-interest transactions.

Fidelity also received payments from the Plan for services provided, such as for record-keeping, administration, etc. Direct fees totaled \$208,928 during the plan year ended December 31, 2024. Additional fees were paid indirectly and netted with investment income.

OneDigital received payments from the Plan for investment management services. Direct fees totaled \$45,100 during the plan year ended December 31, 2024.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE F – PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

**NOTE G – TAX STATUS**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although, the Plan has been amended since adopting the

pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

GAAP requires the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

### **NOTE H – RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
