Opinion

Note 1. Plan Description and Funding

The following description of the American Federation of State, County, and Municipal Employees, Local 2076 Orange County Benefits Trust (Plan) provides only general information. Participants should refer to the Plan's Trust Agreement for a complete description of the Plan's provisions.

General: The Plan is a tax exempt organization established by the American Federation of State, County, and Municipal Employees Local 2076 (Sponsor), for the sole purpose of providing health benefits to eligibility workers of the County of Orange (Employer), represented by AFSCME Local 2076, under a collective bargaining agreement. The Plan engages the services of a third party insurance administrator (Administrator) to manage the insurances policies, enrollment, and participant administration. AFSCME Local 2076 serves as the Plan Sponsor. The Plan is funded by employer contributions and participants voluntary contributions. The Plan must report annually to the County of Orange on the financial status of the plan. Based on the funding arrangement, the Plan is not subject to Title I ERISA reporting requirements. As of December 31, 2024, the Plan had approximately 1,690 participants.

Benefits: The Plan provides basic and supplemental group insurance benefits such as, but not limited to, disability, vision, dental, life insurance, and other welfare benefits to all eligible technicians or specialists who are regular, limited-term, and probationary employees of the social services agency, and to their beneficiaries and covered dependents. The Plan is a fully insured plan, health claims of active participants and their covered dependents are provided under group Insurance contracts. Benefits terminate upon termination of employment, but qualify for COBRA continuation coverage if selected by participants.

Funding Policy: Under the provisions of the Memorandum of Understanding (MOU). The County shall, on a biweekly basis, forward \$23.70 per pay period for all regular hours paid for all regular, limited-term and probationary employees in the Eligibility Worker Unit for all employees who have any paid hours in the pay period to the Plan. Participants voluntary contributions vary per participant based on selected upgraded coverage, and is effective upon electing to participate in the Plan. Participant contributions are collected through payroll deductions. Participant voluntary contributions shall continue for the term of employment and terminate upon termination of employment, unless COBRA is selected. The MOU should be referred to for specific information regarding benefits and other Plan matters.

Other: Although it has not expressed any intention to do so, the Trustees have the right under the Plan to modify the benefits provided to active employees and to terminate the Plan subject to the provisions set forth in the MOU.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting: The financial statements of the Plan are prepared on the accrual basis of accounting. Under this basis, revenue is recognized when earned and expenses are recognized when incurred.

Property and Equipment: The Plan capitalizes all expenditures in excess of \$500 for property and equipment at cost. Depreciation is calculated using the straight-line method, based on the estimated useful lives three to ten years.

Estimates: The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts and disclosures. Actual results could differ from those estimates.

Certain Significant Estimates: These include accruals based on historical performance, contingent liabilities, and valuation of assets, accounts receivable and accounts payable.

Cash and Cash Equivalents: The Plan considers all highly liquid investments available for current use with an initial maturity of three months or less to be cash equivalents.

Note 2. Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition: The Fund's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/depreciation includes the Fund's gains and losses on investments held during the year. For financial statement purposes, both realized and unrealized gains and losses on sales of securities are computed using the historical cost of securities measured against the net proceeds of sales of securities.

Note 3. Fair Value Measurements

Accounting standards provide the framework for measuring fair value which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include other significant observable inputs including: Quoted prices for similar assets or liabilities in active markets; Quoted prices for identical or similar assets or liabilities in inactive markets; Inputs other than quoted prices that are observable for the asset or liability; and Inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement. The following is a description of the valuation methodology used for assets measured at fair value.

Following is a description of the valuation methodologies used for assets at fair value.

Certificates of deposit: Valued at cost which approximates fair value.

Common Equities: Valued at the closing price reported in the active market in which the individual security is traded. Commingled

There have been no changes in the methodologies used at December 31, 2024 and 2023.

Note 4. Prudential Stock

The Plan holds shares of Prudential Financial's Common Stock, as a result being a former Prudential Insurance policyholder, and in connection with Prudential's Plan of Reorganization. The amount received was based on a number of factors, including a length of time the policy was in force, face value of the policy, and total premiums paid. The Plan was granted 1,086 shares of Prudential common stock. As of December 31, 2024, the stock is carried at its fair value based on quoted prices in active markets (Level 1 measurement) in the accompanying Statement of Net Assets Available for Benefits, the common stock is stated at the current market value of \$128,724, at December 31, 2024, and \$112,629 at December 31, 2023.

Note 6. Concentration of Credit Risk

The Plan maintains cash balances at two financial institutions, the accounts at these institutions are insured by the Federal Deposit Insurance Corporation (FDIC Insured) up to \$250,000. As of December 31, 2024 the uninsured balance at Citizen's Bank was \$1,422,812. The Plan attempts to limit any financial exposure, its deposit balances may at times exceed federally insured limits. The Plan believes it is not exposed to any significant credit risk on its cash balances and has not experienced any losses in such accounts.

Note 7. Subsequent Events

Subsequent events were evaluated through September 18, 2025, which is the date the financial statements were available to be issued.

Note 8. Tax Status

The Plan is exempt from federal taxes under section 501(c)(9) of the IRS code, and from state taxes under section 23701(i) of the California Revenue & Taxation code. The Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code, therefore, no provision for income taxes has been included in the Plan's financial statements.
