Note 1 - Description of Plan

General

Effective January 1, 2011, Bloomreach, Inc. (the "Plan Administrator", or "Plan Sponsor", or "Company") adopted a defined contribution 401(k) plan (the "Plan") covering all eligible employees of the Company. The Plan excludes interns and employees who are subject to a collective bargaining agreement or are non-resident aliens who receive no compensation, which constitutes income from sources within the United States.

The Plan was amended and restated on May 1, 2022. The Plan was amended in February 2023 to revise the definition of eligible plan compensation.

The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Company has appointed an administrative committee (the "Committee") to manage the operations and administration of the Plan.

The Company contracted with Empower Annuity Insurance Company of America and Empower Trust Company, LLC (collectively referred to as "Empower"), to act as the Plan custodian and trustee.

The Company has adopted a non-standardized pre-approved plan and appointed Empower as the Plan's third-party administrator for processing transactions, maintaining the records of participant accounts, and monitoring compliance with governmental regulatory requirements.

Contributions

Each year, participants may contribute up to 100% of pre-tax eligible compensation as defined in the Plan Document. Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Plan Document also permits Roth 401(k) contributions and in-Plan Roth rollovers into the Plan as well as after-tax contributions. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers investments in mutual funds, a common collective trust fund, and a fixed annuity fund to its participants. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically entered in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The Company currently matches 20% of employee contributions up to a maximum of \$1,000 for each participant. The Company's discretionary matching contributions, net of forfeitures for the years ended December 31, 2024 and 2023 were \$239,227 and \$246,769, respectively. Contributions are subject to certain IRS limitations.

Participant accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan Document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions and the Company's matching contributions plus actual earnings thereon.

Notes receivable from participants

A participant may have a maximum of two loans outstanding at any time. Participants may borrow from their fund accounts a minimum of \$1,000 to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The limit of \$50,000 is reduced by the highest outstanding balance of any previous loan. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%. The interest rate for loans outstanding at December 31, 2024 ranged from 5.00% to 9.50%, which is commensurate with local prevailing rates as determined by the Company. Loan terms typically range up to five years or may exceed five years for the purchase of a primary residence. Principal and interest are paid ratably through semi-monthly payroll deductions.

Payment of benefits

Upon reaching the age of 59½ and at the discretion of the participant or upon termination of service due to death, disability, or retirement, a participant or the designated beneficiary may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Upon termination, if the participant's or beneficiary's vested account balance is \$7,000 or less, the Plan allows the trustee to distribute the vested account balance to an Individual Retirement Account ("IRA") for the participant's benefit. Vested balances of \$1,000 or less may be distributed as a lump-sum amount without the participant's consent.

Forfeited accounts

Forfeitures of non-vested employer contributions may be used to pay the Plan's expenses or to reduce employer contributions, at the discretion of the Plan Sponsor. No forfeitures were used for the year ended December 31, 2024. Forfeitures in the amount of \$4,267 were used to reduce employer contributions for the year ended December 31, 2023. The forfeitures account balance was \$4,756 and \$2,088 as of December 31, 2024 and 2023, respectively.

Note 2 - Summary of accounting policies

Basis of accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from these estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 4 for discussion of fair value measurements.

Investments held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan. The fixed annuity fund held by the Plan is not considered fully benefit-responsive (see Note 5). Accordingly, the statements of net assets available for benefits present these investments at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred. Delinquent participant loans are recorded as Plan distributions on the basis of the terms of the Plan Document. No allowance for credit losses was deemed necessary by the Plan Sponsor based on an assessment of the outstanding notes receivable from participants at December 31, 2024 and 2023.

Payment of benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees paid to the investment managers and recordkeeper for investment management, advisory services and administration of participants' accounts are reported net of revenue sharing arrangements for the years ended December 31, 2024 and 2023. Asset-based fees, fees related to administration of notes receivable and participant withdrawals are charged directly to the participants' accounts and amounted to \$121,367 and \$106,288 for 2024 and 2023, respectively, before netting with the revenue sharing credited to the Plan. Investment fees are included in the net appreciation in the fair value of investments. Revenue sharing credited to the Plan expense account for the years ended December 31, 2024 and 2023 approximated \$37,000 and \$31,000, respectively.

Subsequent events

In preparing its financial statements, the Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified investments

Certain information in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower, a qualified institution.

The Plan's investments in mutual funds and the common collective trust fund (including gains and losses on investments bought and sold, as well as held during the year) appreciated in value by \$2,411,528 and \$2,699,594 during 2024 and 2023, respectively.

Note 4 - Fair value measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The Plan's investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

The Plan's fixed annuity fund value is reported daily, based on the valuation method disclosed in the annuity contract, as calculated by the annuity provider (see Note 5). The underlying assets for the fixed annuity fund are primarily high-quality, fixed income bonds.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

For the years ended December 31, 2024 and 2023, the Plan's investment in the common collective trust fund is valued at the Net Asset Value ("NAV") of units held. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less liabilities. The underlying securities are comprised of stocks and cash, several of which have observable Level 1 inputs. The fund seeks to achieve maximum total return by outperforming its benchmark over the long term.

Note 5 - Fixed annuity fund

The fixed annuity fund ("Key Guaranteed Portfolio Fund") is not considered to be fully benefit-responsive due to a provision in the Plan's investment contract that prevents the immediate and full payout of the contract value for plan-initiated transactions. As a result, the fund is reported at its fair value of \$108,037 and \$123,492 as of December 31, 2024 and 2023, respectively. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly.

Events that may limit the ability of the Plan to transact at contract value with the issuer are premature termination of the contract by the Plan, layoffs, plan termination, bankruptcy, mergers, and early retirement incentives.

Note 6 - Rollover contributions

During 2024, the rollover contributions of \$469,332 from other plans were from eleven active participants. During 2023, the rollover contributions of \$1,007,822 from other plans were from ten active participants.

Note 7 - Related party transactions and party-in-interest transactions

Plan investments in mutual funds and the fixed annuity fund are managed by Empower and other fund managers, and the common collective trust fund is managed by Cohen & Steers Capital Management, Inc. Empower is the Plan custodian, third party administrator and trustee, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Refer to Note 2 for expenses of the Plan paid by the Plan Sponsor as well as the Plan participants to the party-in-interest. All these transactions are considered party-in-interest transactions under ERISA regulations but are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

Note 8 - Plan termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

Note 9 - Tax status

The Internal Revenue Service has determined and informed Empower, by letter dated November 14, 2022 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Committee and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date and through the date of issuance of the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position not likely to be sustained upon examination by taxing authorities and government agencies. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods.

Note 10 - Risk and uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Market risks related to geopolitical tensions, economic instability, and changes in international trade policies, including the imposition of new tariffs, could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.
