For funding, no preretirement mortality is assumed. The postretirement funding mortality follows the IRS 2024 Static Mortality Table with combined tables for annuitants and non-annuitants, as prescribed by Treasury regulation section 1.430(h)(3)-1.

## **EFFECTIVE DATE**

The effective date of the plan was January 1, 2018. The plan was last amended effective May 1, 2024.

## **PLAN YEAR**

January 1 to December 31.

## **CASH BALANCE ACCOUNT**

The sum of Cash Balance Credits and Earnings Credits. As of December 31, 2024, Cash Balance Accounts, excluding Cash Balance Credits for the year, totaled \$1,311,686.

## **CASH BALANCE CREDITS**

Cash Balance Credits shall be credited to eligible participants' Cash Balance Accounts for the year, based on the plan document's provisions. For the 2024 plan year, Cash Balance Credits totaled \$0.

## **EARNINGS CREDITS**

Earnings Credits shall be credited to participants' Cash Balance Accounts based on December 30-year Treasury Rate not to exceed 5% and not be less than 3.5%.

## **NORMAL RETIREMENT AGE**

The attainment of age 65.

## **BENEFIT AMOUNT**

The Cash Balance Account, or its actuarial equivalent payable as an annuity, subject to IRS maximums. Benefits are payable immediately following termination of employment or while in service for participants who have reached age 59.5.

## **VESTING**

Each participant is vested in his or her Cash Balance Account according to the following schedule: 1 year of service: 0%, 2 years of service: 50%, 3+ years of service: 100%.

## **STATUTORY LIMITS**

For 2024, the maximum compensation limit under IRC section 401(a)(17) is \$345,000, and the maximum benefit payable under IRC section 415(b) is \$275,000.
