## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the DePaul Group, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by DePaul Group, Inc. (the Plan Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established and took effect on January 1, 2020 for the purpose of providing retirement benefits to employees of the Plan Sponsor and certain of its affiliated corporations (collectively, DePaul).

#### **Eligibility**

All employees of the Plan Sponsor are eligible to begin salary deferrals as soon as administratively practicable after their date of hire upon an employee's filing of a salary reduction election in accordance with the Plan's contribution election process.

#### **Contributions**

Participants may make voluntary pre-tax and/or after-tax (Roth) contributions in the form of salary reductions at a maximum contribution of the lesser of 100% of the participant's total eligible compensation for the plan year or the maximum amount permitted by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan Sponsor has elected to operate the Plan as a safe harbor 403(b) plan. As a result, DePaul makes ACP safe harbor matching contributions to the Plan equal to 100% of participant deferrals up to 3% of plan participants' eligible compensation, plus 50% of participant deferrals between 3% and 5% of participants' eligible compensation. All elective participant deferrals are eligible for employer matching contributions, including pre-tax, Roth, and catch-up deferrals.

DePaul may also contribute a discretionary profit-sharing contribution to the Plan as determined by the Board of Directors. No discretionary contributions were made in 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, DePaul's safe harbor matching contributions, an allocation of Plan earnings (losses), reduced for benefits paid, charged directly for loan origination and benefit processing fees, if applicable, and charged with an allocation of administrative expenses not absorbed by the Plan Sponsor. Allocations of Plan earnings (losses) and administrative expenses are based on the investments held by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings or losses thereon. Vesting in DePaul's matching contribution portion of participant accounts is based on years of credited service (20% per year), as defined in the Plan document. A participant becomes 100% vested after five years of credited service. Vesting is immediate upon death, termination of employment due to disability or attainment of normal retirement age, as defined. Employment with DePaul prior to establishment of the Plan will be taken into account for purposes of determining years of credited services relative to vesting.

### **Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account, excluding Roth deferral balances which are not eligible to fund a loan distribution under the Plan's loan policy. A participant may not have more than one loan outstanding at any given time. Notes receivable from participants must generally be repaid over a period not longer than five years for general loans and up to 30 years for residential housing loans. Notes receivable from participants are secured by their account balances and bear interest at the prime rate at the time of the loan, as specified in the Wall Street Journal. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

A participant may withdraw any part of their vested account at any time after attaining age 65, or upon termination of service due to death, retirement or other reasons. A participant or beneficiary may receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount. Distributions are also permitted in the event of financial hardship, as defined by the Plan document, and for participants who have attained age 59½ or who become disabled.

### **Forfeitures**

Forfeitures may be used to pay administrative expenses of the Plan or to reduce DePaul's discretionary matching contributions. At December 31, 2024 and 2023, there were \$9,382 and \$6,422, respectively, of forfeited non-vested accounts. There were no forfeitures utilized to pay administrative expenses or offset contributions in 2024 or 2023.

### **Administrative Expenses**

Substantially all administrative expenses associated with the Plan are paid by the Plan Sponsor.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investments**

Investments are reported at fair value, which is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

### **Fair Value Measurement - Definition and Hierarchy**

GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* The Plan's investments in mutual funds are valued based on quoted prices in active markets.

There were no changes in valuation techniques used during 2024 or 2023.

### **Risk and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Payment of Benefits**

Benefits to participants are recorded when paid.

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

### 3. CERTIFIED INVESTMENT INFORMATION

Ascensus, LLC, as an authorized agent of Ascensus Trust Company, the custodian, has certified to the completeness and accuracy of the following information included in the financial statements and Schedule I as of and for the years ended December 31:

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, DePaul has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants would become fully vested in their accounts.

### 6. INCOME TAX STATUS

The Plan has adopted a volume submitter plan document that has received an advisory letter from the Internal Revenue Service dated January 1, 2018, stating that the form of the volume submitter plan document was in accordance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since adopting the volume submitter plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes that the Plan is qualified and no provision for income tax has been included in the Plan's financial statements.

**7. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

**8. PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company (ATC) is the custodian of the Plan's assets. The Vanguard Group, Inc. (VGI) provides recordkeeping and administrative services to the Plan. Additionally, VGI has entered into an agreement with Ascensus, LLC (Ascensus), to provide certain plan recordkeeping and administrative services on VGI's behalf. As such, transactions between ATC, VGI, Ascensus, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.

## NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

### 1. DESCRIPTION OF PLAN

The following description of the DePaul Group, Inc. 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan sponsored by DePaul Group, Inc. (the Plan Sponsor) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established and took effect on January 1, 2020 for the purpose of providing retirement benefits to employees of the Plan Sponsor and certain of its affiliated corporations (collectively, DePaul).

#### **Eligibility**

All employees of the Plan Sponsor are eligible to begin salary deferrals as soon as administratively practicable after their date of hire upon an employee's filing of a salary reduction election in accordance with the Plan's contribution election process.

#### **Contributions**

Participants may make voluntary pre-tax and/or after-tax (Roth) contributions in the form of salary reductions at a maximum contribution of the lesser of 100% of the participant's total eligible compensation for the plan year or the maximum amount permitted by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers).

The Plan Sponsor has elected to operate the Plan as a safe harbor 403(b) plan. As a result, DePaul makes ACP safe harbor matching contributions to the Plan equal to 100% of participant deferrals up to 3% of plan participants' eligible compensation, plus 50% of participant deferrals between 3% and 5% of participants' eligible compensation. All elective participant deferrals are eligible for employer matching contributions, including pre-tax, Roth, and catch-up deferrals.

DePaul may also contribute a discretionary profit-sharing contribution to the Plan as determined by the Board of Directors. No discretionary contributions were made in 2024 or 2023.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions, DePaul's safe harbor matching contributions, an allocation of Plan earnings (losses), reduced for benefits paid, charged directly for loan origination and benefit processing fees, if applicable, and charged with an allocation of administrative expenses not absorbed by the Plan Sponsor. Allocations of Plan earnings (losses) and administrative expenses are based on the investments held by the participant. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## 1. DESCRIPTION OF PLAN (Continued)

### **Vesting**

Participants are immediately vested in their voluntary contributions, plus actual earnings or losses thereon. Vesting in DePaul's matching contribution portion of participant accounts is based on years of credited service (20% per year), as defined in the Plan document. A participant becomes 100% vested after five years of credited service. Vesting is immediate upon death, termination of employment due to disability or attainment of normal retirement age, as defined. Employment with DePaul prior to establishment of the Plan will be taken into account for purposes of determining years of credited services relative to vesting.

### **Notes Receivable from Participants**

Participants may borrow from their account a minimum of \$1,000 up to a maximum loan equal to the lesser of \$50,000 or 50% of their vested account, excluding Roth deferral balances which are not eligible to fund a loan distribution under the Plan's loan policy. A participant may not have more than one loan outstanding at any given time. Notes receivable from participants must generally be repaid over a period not longer than five years for general loans and up to 30 years for residential housing loans. Notes receivable from participants are secured by their account balances and bear interest at the prime rate at the time of the loan, as specified in the Wall Street Journal. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

A participant may withdraw any part of their vested account at any time after attaining age 65, or upon termination of service due to death, retirement or other reasons. A participant or beneficiary may receive an amount equal to the value of the participant's vested interest in their account in a lump-sum amount. Distributions are also permitted in the event of financial hardship, as defined by the Plan document, and for participants who have attained age 59½ or who become disabled.

### **Forfeitures**

Forfeitures may be used to pay administrative expenses of the Plan or to reduce DePaul's discretionary matching contributions. At December 31, 2024 and 2023, there were \$9,382 and \$6,422, respectively, of forfeited non-vested accounts. There were no forfeitures utilized to pay administrative expenses or offset contributions in 2024 or 2023.

### **Administrative Expenses**

Substantially all administrative expenses associated with the Plan are paid by the Plan Sponsor.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The financial statements of the Plan have been prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

### **Investments**

Investments are reported at fair value, which is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan Sponsor determines the Plan's valuation policies utilizing information provided by the custodian.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

### **Fair Value Measurement - Definition and Hierarchy**

GAAP provides a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under GAAP are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual funds:* The Plan's investments in mutual funds are valued based on quoted prices in active markets.

There were no changes in valuation techniques used during 2024 or 2023.

### **Risk and Uncertainties**

Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

### **Payment of Benefits**

Benefits to participants are recorded when paid.

### **Use of Estimates**

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements. Actual results could differ from those estimates.

### 3. CERTIFIED INVESTMENT INFORMATION

Ascensus, LLC, as an authorized agent of Ascensus Trust Company, the custodian, has certified to the completeness and accuracy of the following information included in the financial statements and Schedule I as of and for the years ended December 31:

### 5. PLAN TERMINATION

Although it has not expressed any intent to do so, DePaul has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan terminates, participants would become fully vested in their accounts.

### 6. INCOME TAX STATUS

The Plan has adopted a volume submitter plan document that has received an advisory letter from the Internal Revenue Service dated January 1, 2018, stating that the form of the volume submitter plan document was in accordance with applicable requirements of the Internal Revenue Code. Although the Plan has been amended since adopting the volume submitter plan document, the plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code, and, therefore, believes that the Plan is qualified and no provision for income tax has been included in the Plan's financial statements.

**7. RECONCILIATION TO FORM 5500**

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agreed to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

**8. PARTY-IN-INTEREST TRANSACTIONS**

Ascensus Trust Company (ATC) is the custodian of the Plan's assets. The Vanguard Group, Inc. (VGI) provides recordkeeping and administrative services to the Plan. Additionally, VGI has entered into an agreement with Ascensus, LLC (Ascensus), to provide certain plan recordkeeping and administrative services on VGI's behalf. As such, transactions between ATC, VGI, Ascensus, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

**9. SUBSEQUENT EVENTS**

Subsequent events have been evaluated through October 10, 2025, which is the date the financial statements were available to be issued.
