## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants  
**Angstrom Automotive Group, LLC 401(k) Plan**

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Angstrom Automotive Group, LLC 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### Note 1 – Description of the Plan

#### General

The Plan is a defined contribution plan that was established on January 1, 2012, by Angstrom Automotive Group, LLC and its related controlled group members Alumina, LLC, Angstrom Aluminum Castings, LLC, Angstrom Electric, LLC, Angstrom Fiber Auburn, LLC, Angstrom Fiber Englewood, LLC, Angstrom Fiber Sidney, LLC, Angstrom Precision Metals, LLC, Angstrom Tubular Solutions, LLC, Angstrom USA, LLC, Aspen Technologies, Inc., Enforge, LLC, General Aluminum MFG, LLC, Tec Air, LLC, Vantec Nebraska, LLC, Vantec, LLC, and Wrena, LLC (the Company).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The following description of the Plan is provided for general information purposes only. Participants should refer to the Summary Plan Description or the Adoption Agreement, including amendments thereto, for a complete description of the Plan's provisions.

#### Administration

The Plan Sponsor and named Plan Administrator is Angstrom Automotive Group, LLC. The Plan Administrator is responsible for oversight of the Plan. The Plan Administrator determines the appropriateness of the Plan's investment offerings, monitors investment performance and fees. The Plan's Trustee and Investment Custodian is Fidelity Management Trust Company. The Investment Custodian holds all of the Plan's assets and executes all of the Plan's transactions. The Company has also retained Fidelity Workplace Services, LLC to provide participant recordkeeping and administration services.

#### Eligibility

The Plan covers all employees of the Company. All eligible employees must be 21 years of age and may begin participating in the Plan upon hire, with the entry date being immediately upon meeting the eligibility requirements specified in the plan document.

#### Contributions to the Plan

Each year, participants may contribute up to 100% of their eligible compensation, as defined in the plan document, through payroll withholdings to several investment alternatives as directed by the participant. The Plan also allows participants to make after-tax Roth contributions. Participants who have attained age 50 before the end of the year are eligible to make additional 'catch-up' contributions. Participants may contribute amounts representing distributions from other defined benefit or defined contribution plans (rollovers).

For the year ended December 31, 2024, the Company made safe harbor matching contributions, on behalf of the participants, equal to 100% of the participant's first 3% of compensation, plus 50% of the participant's next 2% of compensation deferred into the Plan. Total safe harbor matching contributions were \$942,390 for the year ended December 31, 2024. The Company may also make discretionary matching contributions or discretionary employer contributions. During the year ended December 31, 2024, no discretionary matching or employer contributions were made.

Participants direct the investment of both their individual contributions plus their share of employer contributions into the various investment options offered by the Plan. The Company's contributions are allocated in the same manner as that of the participant's elective contributions.

Contributions are subject to certain Internal Revenue Service (IRS) limitations.

### Participant Accounts

Each participant's account is credited with the participant's contributions and employer safe harbor matching contributions as well as plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Funds contributed by participants are invested at percentages as directed by participants in any one or more of several investment alternatives.

The income, gains or losses in each fund are allocated daily to the applicable participants' accounts in that fund based on the previously reported account balances, adjusted for current period contributions and withdrawals.

### Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms are from one to five years. Loan terms may exceed five years only in the event the loan proceeds are used to purchase or construct the participant's principal residence. No more than two loans may be outstanding at any time. The participant's vested account balance will serve as the security for the loan. Loans bear interest at a rate commensurate with local rates for loans of similar purpose. Once a loan is granted, the interest rate on that loan will not change. Principal and interest is paid ratably through payroll deductions.

### Distribution of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum amount. The distributable amount is equal to the value of the participant's vested interest in his or her account. Employees who elect to have their benefit payments deferred continue to share in allocations of investment income and losses but do not share in subsequent allocations of discretionary contributions. Special rules apply to distributions due to death, disability and retirement. Participants should refer to the full plan document for details.

On termination of service, participant account balances between \$1,000 and \$5,000 will automatically be rolled over into an individual retirement account determined by the Company unless the participant affirmatively elects otherwise. Participants with balances less than \$1,000 will receive a cash distribution.

The Plan also allows for in-service distributions upon attainment of age 59 1/2 for any reason, and before age 59 1/2 due to financial hardship, as defined in the plan document.

### Vesting

The balance in each participant's salary deferral, rollover, and safe harbor matching accounts is 100% vested at all times.

Discretionary employer contributions are subject to a graded vesting schedule based on years of service. Participants become 100% vested after five years of credited service, when termination of employment is the result of attaining retirement age, or upon death or total disability.

### Forfeitures

Forfeitures attributable to employer discretionary profit sharing contributions may be used to offset employer contributions or to pay plan expenses. The balance in the forfeiture suspense account at December 31, 2024 and 2023 was \$-0-. No forfeitures were used to offset employer contributions or plan administrative costs for the plan year ended December 31, 2024.

### **Note 2 – Summary of Significant Accounting Policies**

#### Basis of Accounting

The financial statements are prepared using the accrual basis of accounting. Employer contributions and income from investments are recorded when they are earned. Employee contributions are recorded when withheld from pay. Expenses are recorded in the accounting period in which they are incurred.

#### Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment custodian and investment advisers. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

#### Notes Receivable from Participants

Notes receivable from participants are valued at their unpaid principal plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are reclassified as distributions based upon the terms of the plan document.

#### Payment of Benefits

Benefits are recorded when paid.

### Fees and Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Direct fees for custodian and recordkeeping services are paid by the Plan and are also included in administration expenses. Investment related expenses are included in the net appreciation or depreciation in fair value of investments.

### Subsequent Events

Effective February 26, 2025, the Plan was amended to add General Angstrom Aluminum Castings Texas, LLC and Angstrom Metal Stampings, LLC to the Plan.

Effective September 8, 2025, the Plan was amended and restated in its entirety to change its name from the Angstrom Automotive Group, LLC 401(k) Plan to the Angstrom NA, LLC 401(k) Plan.

The financial statements and related disclosures include evaluation of events up through and including October 13, 2025, which is the date the financial statements were available to be issued.

### **Note 3 – Unaudited Investment Information Certified by the Trustee**

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted under such election, the following information has been certified by Fidelity Management Trust Company as to its completeness and accuracy and was not subjected to any auditing procedures performed by the Plan's independent auditors:

1. All investment balances reflected in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023,
2. All investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024,
3. All investment-related information included in the Supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and
4. Notes receivable from participants as of December 31, 2024 and 2023 and the related income on notes receivable from participants for the year ended December 31, 2024.

### Note 4 – Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified contractual term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### Mutual Funds

Mutual Funds are valued at daily closing prices as reported by the fund. Mutual Funds held by the Plan are open-ended mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. Mutual Funds held by the Plan are deemed to be actively traded.

### **Note 5 – Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their employer contributions.

### **Note 6 – Plan Amendment and Tax Status**

The Plan has adopted a pre-approved plan sponsored by Fidelity Management Trust Company, which has been filed with the IRS and has received a favorable advisory letter dated June 30, 2020, from the IRS. The Plan Sponsor has not elected to apply for an individual IRS Determination Letter on the adoption of the Plan nor on any subsequent amendments. The Plan Sponsor believes that the Plan is currently designed and being operated materially in compliance with applicable requirements of the Internal Revenue Code and, therefore, that the Plan is qualified under Section 401(a) and that the related Trust is tax-exempt as of December 31, 2024.

The Plan permitted provisions of SECURE Act 2.0 during the years ended December 31, 2024 and 2023. Written amendments to the plan document to reflect these operational changes will be adopted at a later date in accordance with the deadlines pursuant to applicable laws and IRS guidance.

Effective March 29, 2024, the Plan was amended to add General Aluminum MFG, LLC to the Plan.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 7 – Party-in-Interest Transactions**

Certain plan investments are managed by Fidelity Management Trust Company, who acts as the Plan's Trustee and investment custodian. Recordkeeping and administration services are provided by Fidelity Workplace Services, LLC. During the year ended December 31, 2024, the Plan paid direct compensation to this entity related to recordkeeping and administration services.

Indirect compensation (that is netted against investment income on the statement of changes in net assets available for benefits) is paid to the Trustee and Custodian from total annual operating expenses charged on the balance of fund investments, depending on the particular fund. Transactions involving these investments are considered party-in-interest transactions; however, these transactions are not considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

### Note 8 – Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.
