Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Legal Aid of North Carolina Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Legal Aid of North Carolina Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

Legal Aid of North Carolina Retirement Plan

Years Ended December 31, 2024 and 2023

NOTE A--PLAN DESCRIPTION

The following brief description of the Legal Aid of North Carolina Retirement Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General: Effective May 1, 2021, the Plan was restated upon the adoption of the Ascensus, LLC non-standardized pre-approved profit sharing plan, with Ascensus, LLC appointed as trustee for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), the Economic Growth and Tax Relief Reconciliation Act of 2001, The Heroes Earnings Assistance and Relief Act of 2008, and The Worker, Retiree, and Employer Recovery Act of 2008. Under such a plan, the participant is not provided with any fixed benefit. Plan contributions are made at specified rates and are credited to an individual account in the name of each participant. Investment income of the Plan is allocated to participant accounts based on the participant's account balance, as defined in the Plan. The ultimate benefit to be received by a participant depends on the aggregate amount contributed by the participant and contributed for him by the Company over the years and the investment results allocated to his individual account.

The Plan was originally effective January 1, 1988, and was known as the Legal Services of North Carolina Retirement Plan. Effective July 1, 2002, LSNC consolidated its program services into Legal Aid of North Carolina, Inc. (“LANC”), and LANC became the sponsoring employer of the Plan, which was renamed Legal Aid of North Carolina Retirement Plan.

Eligibility Requirements: Provided an employee is not an Excluded Employee as defined in the plan agreement, employees are eligible to participate in the Plan for purposes of elective deferrals on their Employment Commencement date.

Plan Entry Dates: The Plan entry date for employee deferrals is the day upon which eligibility requirements are satisfied.

Contributions: Eligible employees are allowed to have made on their behalf, through salary reduction, an elective contribution up to 100% of compensation, subject to certain limitations set forth in the Internal Revenue Code.

Active Participants completing at least 1,000 Hours of Service during the plan year and who are employed on the last day of the plan year are eligible to share in the employer’s discretionary, nonelective contributions for that plan year, subject to certain Employee Class Exclusions. Participants terminating employment during the plan year due to death, total and permanent disability, or retirement, are also eligible to share in employer discretionary contributions for that plan year. Allocations of employer nonelective contributions are based on a percentage of each participant’s eligible compensation. Employer discretionary, nonelective contributions were 5% of eligible participants’ compensation for 2024 and 2023.

The employer may also make qualified nonelective contributions and matching contributions, though the employer made no such contributions for 2024 and 2023.

Rollover Contributions: The Plan provides for rollover contributions from other qualified retirement plans.

Directed Investment Accounts: The Plan permits every participant to direct the investment of his account balance under the Plan.

Notes to Financial Statements--Continued

NOTE A--PLAN DESCRIPTION -- Continued

Funding Policy: The employer is generally required to pay its contribution to the Plan for each plan year within the time prescribed by law, including extensions of time for the filing of the employer's federal income tax return for the fiscal year. However, employee elective contributions accumulated through payroll deductions shall be paid to the trustee as of the earliest date on which contributions can reasonably be segregated from the employer's general assets, but in any event, within the time prescribed by law. Furthermore, any additional employer contributions which are allocable to participants' accounts for a plan year shall be paid to the Plan no later than the twelve-month period immediately following the close of such plan year.

Participant Accounts: Individual accounts are maintained for each participant showing the participant's interest in the Plan. The accounts are credited with the participants' contributions, an allocation of the employer's contribution, if any, and net plan income and expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Payment of Benefits: A participant's vested interest in the Plan's assets is distributed to the participant, his spouse, or other beneficiary generally upon termination, disability, retirement, or death. Participants who have attained age 59½ may withdraw any portion of the vested value of their account to the extent the balance is not required to secure the outstanding balance of a loan to a participant. Benefit payments are generally available for distribution in a lump sum as soon as administratively feasible thereafter.

Hardship Withdrawals: Withdrawals due to financial hardship are permitted with the approval of the Plan Administrator for the following reasons: medical expenses, purchase of primary residence, post-secondary tuition payment, eviction from or foreclosure on principal residence and other expenses creating a financial need, as provided in published IRS revenue rulings. Withdrawals may only reduce employee deferrals and are not permitted after a participant has separated from service.

Notes Receivable from Participants: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of the vested account balance, whichever is less, and bear a market rate of interest. Loan transactions are treated as a transfer between the investment options and the participant's note receivable. The notes receivable are secured by 50% of the vested balance in the participant's account with principal and interest to be paid ratably through payroll deductions. All loans must be repaid within five years. At December 31, 2024, interest rates range from 4.25% to 9.50% and mature at various dates through 2029.

Vesting: Employees are immediately vested in elective deferrals and earnings thereon. Employees vest in employer contributions and earnings thereon based on years of continuous service. A Year of Service for vesting purposes requires participants to complete at least 1,000 Hours of Service during the plan year. The Plan's vesting schedule is as follows:

Participants also become 100% vested upon attainment of normal retirement age, death, or disability.

Forfeited Accounts: At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$108,153 and \$12,509, respectively. These accounts will be used to restore participant's accounts, to offset plan expenses and then to reduce employer contributions to the Plan. Employer contributions are reported net of forfeitures of \$0 and \$691 for 2024 and 2023, respectively.

NOTE B--SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting: The accompanying financial statements are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Investment Valuation and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Shares of registered investment companies (mutual funds) are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

The Plan invests in the Morley Stable Value fund (the Fund), a common investment trust. The Fund is recorded in the statements of net assets available for benefits at fair value. Fair value is based on using the NAV, as a practical expedient, based on the audited financial statements of the Fund. The NAV of the Fund is determined daily and there are no unfunded commitments and no redemption restrictions.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Contributions: Employer and employee contributions are accrued in the Plan year to which they relate.

Payment of Benefits: Benefits are recorded when paid.

Administrative Expenses: The Plan pays certain mutual funds administrative expenses such as record keeping, accounting, legal and trustee services of which some are netted against investment income; participant loan fees are charged to affected participant accounts upon initiation of loans.

Use of Estimates: The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Date of Management's Review of Subsequent Events: Plan management has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

NOTE C--FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are as described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Assets valued using the net asset value practical expedient are not required to be reported within the hierarchy.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust Funds: Valued at the NAV of units of collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. There are no unfunded commitments and participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. The Fund consists primarily of a diversified portfolio of Stable Value Investment Contracts issued by life insurance companies, banks and other financial institutions, the performance of which may be predicated on underlying fixed income investments. The objective of the Fund is to provide preservation of capital, relatively stable returns consistent with its comparatively low risk profile, and liquidity for benefit responsive plan or participant payments.

The Plan's policy is to recognize transfers of investments between levels of the fair value hierarchy as of the actual date of the event or change in circumstances that caused the transfer. There were no significant transfers between levels of the fair value hierarchy during the years ended December 31, 2024 and 2023.

NOTE D--PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of mutual funds managed by Ascensus Trust Company ("Ascensus"). Ascensus is the trustee and contract administrator of the Plan, therefore, related transactions qualify as exempt party-in-interest transactions. Fees paid by the Plan for the investment management services were \$131,891 and \$117,389 for the years ended December 31, 2024 and 2023, respectively.

NOTE E--PLAN TERMINATION

While they have not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions set forth in the plan document and ERISA. In the event of plan termination, participants will become 100 percent vested in their accounts.

NOTE F--TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the nonstandardized prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

NOTE G--RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE H--CERTIFIED INVESTMENTS

Information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years then ended, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus, LLC (the trustee of the Plan).
