Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter—Supplemental Schedules Required by ERISA

The supplemental schedules of Schedule H, line 4a—schedule of delinquent participant contributions for the year ended December 31, 2024 and Schedule H, part IV, line 4i—schedule of assets (held at end of year) as of December 31, 2024, are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, have been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or are derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

Note 1. Plan Description

The following description of the Jacobson Associates 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan maintained for the benefit of all employees of Jacobson Associates (the Sponsor or Employer).

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Vanguard Fiduciary Trust Company serves as the recordkeeper and Ascensus Trust Company serves as the trustee.

The Plan was most recently amended effective February 1, 2021, to add an additional requirement of working 1,000 hours of service during the Plan year in order to be eligible for the Employer match. Participants are automatically enrolled in specific target funds at a 5% initial employee contribution, unless specifically changing the deferral percentage and investment options.

Eligibility: Eligible employees are those who have completed 12 months of service in which the employee has worked at least 1,000 hours of service and is age 21 or older. Eligible employees may begin participating in the Plan on the first day following each quarter throughout the Plan year. Eligibility requirements are the same for employer qualified nonelective contributions and profit sharing contributions.

Contributions: The Plan provides for employee salary 401(k) contributions of annual compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also contribute to the Plan in the form of a rollover of funds from another qualified plan.

The Plan Sponsor may elect to make Employer matching contributions, qualified nonelective contributions, or profit sharing contributions during the year. Employer matching contributions and profit sharing contributions are discretionary. Qualified nonelective contributions are not discretionary. To qualify for the Employer contributions, participants must work at least 1,000 hours of service during the Plan year and must be employed on the last day of the Plan year. Profit sharing contributions made by the Employer are allocated using a pro rata formula. There were \$41,750 of Employer contributions for 2024 that were paid in 2025.

Vesting: Participants are immediately vested in their participant-directed, qualified nonelective Employer and participant rollover accounts and earnings thereon. Vesting of discretionary Employer matching contribution accounts, discretionary Employer profit sharing contribution accounts and related earnings is based on years of service (with 20% vesting for each year of service, after one year of service, being fully vested after six years of service). Participants are automatically fully vested upon normal retirement, death, or permanent disability.

Forfeitures: In event of termination of employment before full vesting, the nonvested portion of a participant's account is immediately forfeited. The amount of the participant's account forfeited will be reinstated providing the participant resumes employment prior to incurring a break in service (as defined). Amounts forfeited during the year are first used to restore any prior forfeitures in the event of a former participant's return to employment. Forfeitures are retained in the Plan and will first be used to pay administrative expenses. Any remaining amounts will be used to reduce future Employer matching contributions. No forfeitures were used to pay plan expenses in 2024, the forfeiture account appreciated, and the balance was \$1,678 and \$0 at December 31, 2024 and 2023.

Note 1. Plan Description (Continued)

Participant accounts: Each participant's account is credited with the participant's contribution and allocations of the Employer's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Payment of benefits: Distributions are payable upon retirement, death, disability, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. Participants may make withdrawals from their account upon reaching age 59½, normal retirement age, as defined, or by determination that a financial hardship, as defined, has been incurred.

At December 31, 2024, there were no amounts owed to former participants whose employment had been terminated and who requested payment of their account balances.

Participant notes receivable: Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50% of their vested account balances, not to exceed \$50,000. Loan terms range from one to five years. Loans for the purchase of a principal residence can be paid over a 30-year period. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, at the time of the loan origination, as determined by the Plan Administrator. Principal and interest are paid ratably through periodic payroll deductions. Interest rates ranged from 4.25% to 9.50% as of December 31, 2024 and 2023, respectively.

Administrative costs: The majority of administrative costs of the Plan are paid for by the Plan with the remainder paid by the Sponsor.

Subsequent events: Plan management has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

Note 2. Summary of Significant Accounting Policies

Basis of accounting: The accompanying financial statements are prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America in accordance with the Financial Accounting Standards Board Accounting Standards Codification.

Investment valuation and income recognition: Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income (loss) is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year. Capital gain distributions are included in interest and dividends.

Note 2. Summary of Significant Accounting Policies (Continued)

Valuation of participant notes receivable: Participant notes receivable are measured at their unpaid principal balances, plus any accrued interest. Delinquent loans are treated as distributions based on the terms of the plan document.

Payment of benefits: Benefits are recorded when paid. Corrective distributions payable generally represent the distributions of certain assets to employees in order for the Plan to comply with ERISA nondiscrimination rules.

Contributions: Participant contributions are recognized when earned. Employer matching contributions (if any) are recognized concurrently with participant contributions. Employer discretionary nonelective contributions are recognized annually, as applicable.

Use of estimates: The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 3. Information Certified or Provided by the Ascensus Trust Company

Certain information related to certain assets and income disclosed in the accompanying financial statements and ERISA required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Ascensus Trust Company (the trustee of the Plan). Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedule.

Note 4. Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing fair value. The framework for determining fair value is based on a hierarchy that prioritizes the inputs and valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to observable inputs (Level 3).

The three levels of the fair value hierarchy are described below:

Level 1: Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2: Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active and inputs other than quoted prices that are observable for the asset.

Level 3: Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset. These Level 3 fair value measurements are based primarily on management's own estimates using pricing models, discounted cash flow methodologies, or similar techniques taking into account the characteristics of the asset.

In instances whereby inputs used to measure fair value fall into different levels in the above fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

The following valuation methodology has been used to value the Plan's investments:

Shares of registered investment companies: Valued at the daily closing price, as reported by the fund. Shares held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Units of common/collective trust: Valued based on the NAV of units of the common/collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate the fair value. The NAV is based upon the fair value of the underlying investments comprising of the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Changes in fair value levels: To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluates the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no significant transfers in or out of Level 3

Note 5. Tax Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the prototype plan, as designed, is qualified for federal income tax-exempt status. The Plan has not individually sought its own determination letter. U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken on an uncertain position that more likely than not would not be sustained upon examination. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to outside audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 6. Excess Contributions Due to Participants

For the years ended December 31, 2024 and 2023, the Plan failed the actual deferral percentage nondiscrimination tests. As a result, a portion of the 2024 and 2023 contributions had to be refunded to highly compensated employees in order for the Plan to maintain its qualified status with the IRS. Earnings on the excess contributions were also refunded. For the years ended December 31, 2024 and 2023, the excess contributions and related earnings were refunded in 2025 and 2024, respectively.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Sponsor has the right under the Plan to discontinue its contributions at any point and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in the Employer contributions portions of their accounts. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such manner as the Sponsor may determine.

Note 8. Related-Party and Party-in-Interest Transactions

Certain plan investments are managed by the recordkeeper and, therefore, these transactions qualify as party-in-interest. Furthermore, the trustee provides plan administration services to the Plan.

The Sponsor pays certain investment and administrative expenses of the Plan. Total expenses paid to the trustee and recordkeeper by the Plan for the year ended December 31, 2024, were \$74,117. In addition, certain administrative functions are performed by employees of the Plan Sponsor for which no compensation is received from the Plan.

Note 10. Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11. Prohibited Transactions

During 2024, there were no prohibited transactions. During 2023, the Plan inadvertently failed to remit \$2,709 of participant contributions within the timeframe as stated by the United States DOL regulations. The Plan Sponsor deposited lost earnings in 2024 to correct the failures that occurred in 2023. The Plan Sponsor filed the Form 5330 and paid applicable excise tax to the IRS. The correction and any excise taxes, if applicable, was made from the Plan Sponsor's assets and not from the assets of the Plan.
