**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Kairoi Management, LLC 401k Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## NOTE 1 – DESCRIPTION OF PLAN

The following description of Kairoi Management, LLC 401k Plan, formerly LKZ Management, LLC 401k Plan, (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

### General

The Plan is a defined contribution plan covering all employees of Kairoi Management, LLC (the Company or Plan Sponsor) who have six (6) months of service and are age twenty-one (21) or older. The Plan is designed to meet the requirements of Internal Revenue Code Section 401(a) and is subject to provisions of the Employment Retirement and Income Security Act of 1974 (“ERISA”). The entry date is the first day of the month following the month the employee becomes eligible.

### Contributions

Discretionary matching contribution amounts may be contributed at the option of the Company's management. Nonelective employer contributions are allocated based upon the participant's compensation using a nonintegrated allocation formula. Contributions are subject to certain limitations. For the years ended December 31, 2024 and 2023, \$631,285 and \$455,206 contributions were made, respectively.

Participants may elect to contribute 100 percent of eligible compensation (either as pre-tax or Roth deferral), subject to Internal Revenue Code (IRC) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan automatically enrolls employees that become eligible to participate in the Plan at 3 percent of their eligible wages, unless the employee elects a different percentage.

### Participant Accounts

Participants direct the investment of their contributions into various investment options offered by the Plan.

Each participant's account is credited with the participant's contribution, allocations of the Company's contributions, if any, Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 – DESCRIPTION OF PLAN (CONTINUED)

Vesting

Participants are vested immediately in their contributions and actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. Company matching and profit sharing contributions have a four-year graded vesting period as follows:

Less than 1 year	0%
1 year	25%
2 years	50%
3 years	75%
4 years	100%

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range up to five years or over a reasonable period of time for the purchase of a primary residence, as established by the Plan Administrator at the time of the loan. The loans are collateralized by the vested balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined quarterly by the Plan Administrator. Principal and interest are paid through payroll deductions.

Payment of benefits

On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. Any balance under \$5,000 is automatically paid out as soon as administratively possible. Hardship withdrawals are also available subject to certain limitations.

New Legislative Changes - Secure 2.0 Act

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 (the "Act") was signed into law on December 29, 2022. The Act includes both mandatory and optional provisions affecting retirement plans.

Although the provisions of SECURE 2.0 are phased in over several years, the Plan, a defined contribution 401(k) plan, previously adopted or already included language in its governing document that aligns with certain provisions of the Act. These provisions include, but are not limited to:

NOTE 1 – DESCRIPTION OF THE PLAN (CONTINUED)

- Eligibility for Long-Term Part-Time Employees – Expanded eligibility criteria (Section 125), which the Plan already reflects.

The Plan Administrator continues to assess the impact of SECURE 2.0 and is monitoring ongoing regulatory and administrative guidance to ensure full compliance with the applicable provisions as their effective dates approach. As of December 31, 2024, the implementation of these provisions has not had a material impact on the Plan's financial statements.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The accompanying financial statements are prepared on the accrual basis of accounting.

Payment of benefits

Benefits are recorded when paid.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

Investments are reported at fair value. Fair value is the price that would be recognized to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for disclosure of the fair value measurements.

Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan. The Statements of Net Assets Available for Plan Benefits presents the fair value of the investment contract, as well as the adjustment of the fully benefit-responsive investment contract from fair value to contract value, if any. The Statements of Changes in Net Assets Available for Plan Benefits is prepared using contract value for the fully benefit-responsive investment contract.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Excess contribution payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (IRS) are recorded as a liability with a corresponding reduction to contributions. Corrective contributions payable of \$68 and \$13 were made for the years ended December 31, 2024 and 2023, respectively.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation of fair value of investments.

NOTE 3 – INFORMATION CERTIFIED AND PROVIDED BY THE CUSTODIAN

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedule that was prepared by or derived from information provided by the Voya Retirement Insurance and Annuity Company and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the Plan Administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information which appears throughout the financial statements and the supplemental schedule related to the following assets:

The custodian (Voya Retirement Insurance and Annuity Company) also certified the completeness and accuracy of \$587,357 of dividends and net appreciation (depreciation) in fair value of investments and \$4,228 of interest from notes receivable from participants for the year ended December 31, 2024.

The custodian (Voya Retirement Insurance and Annuity Company) also certified the completeness and accuracy of \$402,411 of dividends and net appreciation (depreciation) in fair value of investments and \$2,528 of interest from notes receivable from participants for the year ended December 31, 2023.

NOTE 4 – FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board's *FASB Accounting Standards Codification* (ASC), Fair Value Measurements and Disclosures, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under the ASC, Fair Value Measurements and Disclosures, are described below:

Level 1

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2

Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices for the asset or liability that are observable
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, Level 2 inputs must be observable for substantially the full term of the asset or liability.

NOTE 4 – FAIR VALUE MEASUREMENTS (CONTINUED)

Level 3

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques that are used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts

Pooled separate accounts are valued at net asset value (NAV) as determined by the issuing insurance company based on the fair value of the underlying assets. Although NAV is used as a practical expedient to estimate fair value, these accounts are categorized as Level 2 because NAV is not quoted on an active exchange but is primarily based on observable inputs of the underlying securities

Guaranteed investment contract

The guaranteed account is fully benefit responsive and is therefore reported at fair value (see Note 2). The guaranteed account is measured at contract value which approximates fair value. Fair value, as reported to the Plan, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses.

The methods above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Transfers between levels

For the years ended December 31, 2024 and 2023, there were no significant transfers between Levels 1 and 2 and no transfers in or out of Level 3.

NOTE 5 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of a plan termination, participants become 100 percent vested in their accounts.

NOTE 6 – GUARANTEED INVESTMENT CONTRACT

During 2024 and 2023, the Plan had a benefit-responsive guaranteed investment contract, the Voya Fixed Account (4062), with Voya Retirement Insurance and Annuity Company. Voya maintained the contributions to the Voya Fixed Account (4062) in a general account. The account was credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The issuer of the guaranteed investment contract is contractually obligated to repay the principal and specified interest rates that are guaranteed to the Plan.

As described in Note 2, because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the guaranteed investment contract. Participants ordinarily directed the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limited the ability of the Plan to transact at contract value with the issuer, including termination of the guaranteed investment contracts. The Plan administrator believes that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, was not probable. The guaranteed investment contract does not permit the custodian to terminate the agreement prior to the scheduled maturity date.

There were no valuation reserves recorded to adjust contract amounts at December 31, 2024 and 2023. The average yield and declared interest rate of the guaranteed account was 1.75% for the years ended December 31, 2024 and 2023, respectively. The declared interest rate may be changed by Voya Retirement Insurance and Annuity Company from time to time, but has a guaranteed minimum rate of 1%.

#### NOTE 7 – RISK AND UNCERTAINTIES

The Plan invests in various investments. Investments are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### NOTE 8 – TAX STATUS

Effective November 12, 2017, the Plan adopted a nonstandardized form of a prototype plan. The Plan has received an opinion letter from the IRS as to the prototype plan's qualified status. The prototype plan opinion letter has been relied upon by the Plan. Although the Plan has been amended since receiving this determination letter, the Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan is subject to income tax examination for the years ending December 31, 2023, 2022, and 2021.

#### NOTE 9 – RELATED PARTY TRANSACTION

The Plan paid administrative fees to parties-in-interest (Custodian and other service providers) totaling \$44,960 and \$16,173 for the years ended December 31, 2024 and 2023, respectively.

#### NOTE 10 – RECLASSIFICATION

Certain amounts in the 2023 financial statements have been reclassified to conform to the 2024 financial statement presentation. These reclassifications were made to enhance comparability and provide a clearer presentation of financial information. These reclassifications did not impact previously reported net assets available for benefits, changes in net assets, or participant account balances. These changes were made solely for presentation purposes and did not impact the financial position or results of operations of the Plan for any period presented.

#### NOTE 11 – SUBSEQUENT EVENTS

The Plan has evaluated subsequent through October 07, 2025, the date the financial statements were available to be issued.
