Opinion

We have audited the financial statements of Commercial Plumbing Inc. Employee Stock Ownership Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits of Commercial Plumbing Inc. Employee Stock Ownership Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). NOTE A - PLAN DESCRIPTION AND BASIS OF PRESENTATION

The following brief description of the Commercial Plumbing Inc. Employee Stock Ownership Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for complete information.

- (1) **General** - Commercial Plumbing Inc. (Company) established the Plan effective as of February 1, 2002. The Plan has since been amended and operates, in relevant part, as an employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code of 1986, as amended (IRC), and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by the Company and its Administrative Committee comprised of one or more individuals appointed by the Company's board of directors. The Plan retains the services of an independent trustee.

In October 2002, the Plan purchased 567,000 shares of the Company's common stock from the stockholders which represented 100 percent of the issued and outstanding shares, and holds the common stock in a trust established under the Plan. The purchase price of \$5,000,000 was entirely financed through notes payable to the Company's stockholders, with interest at 6% and a maturity date of December 31, 2012. Unallocated shares were released from the trust based on periodic debt principal and interest payments as a percentage of total future debt principal and interest payments. The notes payable were paid off in December 2012.

On January 1, 2013, the ESOP contributed its remaining 555,492 outstanding shares of Company common stock to Commercial Plumbing Holdings, Inc. (CPHI) in exchange for 555,492 shares of CPHI common stock.

- (2) **Eligibility** - Employees of the Company are generally eligible to participate in the Plan after one year of service, providing they worked at least 1,000 hours during such Plan year and are 20 years of age. Participants who do not have at least 1,000 hours of service during such Plan year or are not employed on the last working day of a Plan year are generally not eligible for an allocation of Company contributions for such year.
- (3) **Employer contributions** - Employer contributions of either cash or shares of CPHI common stock shall be made to the Plan each Plan year as determined by the Company's board of directors.
- (4) **Payment of benefits** - Distributions on account of death, disability, or retirement are made in a lump sum or installment payments beginning no later than the completion of the Plan year following the event. Distributions for other separations from service are made in a lump sum or installment payments beginning no later than the completion of six Plan years following the Plan year within which the participant terminates service and generally, are paid no longer than over a period of five years. The amount to be distributed is based upon the immediately preceding valuation date.

Under the provisions of the Plan, the Company is obligated to repurchase participant shares, which have been distributed under the terms of the Plan as long as the shares are not publicly traded or if the shares are subject to trading limitations. During 2024 and 2023, the Company repurchased 25,747 and 25,578 participant shares at prices determined from an independent appraisal, respectively.

- (5) **Administrative expenses** - As provided in the Plan agreement, administrative expenses may be paid either by the Plan or by the Company. The Company has historically paid the operating expenses for the Plan.
- (6) **Voting rights** - Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the Trustee prior to the time that such rights are to be exercised. The Trustee is not permitted to vote any allocated share for which instructions have not been given by a participant.
- (7) **Participant accounts** - The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of CPHI common stock released by the Trustee from the forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation. Allocations are based on a participant's eligible compensation, relative to total eligible compensation. Plan earnings are allocated to each participant's account based on the ratio of the participant's account balance. A participant is also eligible to receive an allocation in the Plan year of their retirement, disability, or death.
- (8) **Vesting** - If a participant's employment with the Company ends for any reason other than retirement, permanent disability or death, he or she will vest in the balances in his or her account based on total years of service with the Company. Participants vest 20% per year of service and are 100% vested after five years of service.
- (9) **Put option** - Under federal income tax regulations, CPHI common stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the Company buy any shares of CPHI common stock distributed to participants for which there is no market. The put price is representative of the current appraised value of the stock. The Company can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.
- (10) **Diversification** - Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in CPHI common stock into investments that are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a 6-year period. In each of the first 5 years, a participant may diversify up to 25 percent of the number of post-1986 shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50 percent. Participants who elect to diversify receive a cash distribution.

- (11) **Forfeitures** - Plan forfeitures are allocated to each participant's account based upon the relation of the participant's eligible compensation to total eligible compensation for the Plan year. Forfeitures allocated to participants during the years ended December 31, 2024 and 2023 totaled \$9,170 and \$26,224, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

- (1) **Basis of accounting** - The financial statements of the Plan are prepared on the accrual basis of accounting.
- (2) **Use of estimates** - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- (3) **Investment valuation and income recognition** - The shares of CPHI common stock are reported at fair value. See Note D for a discussion of the fair value measurements. Net appreciation is based on the increase of the fair value as determined by an annual independent appraisal.
- (4) **Payment of benefits** - Benefits are recorded when paid.
- (5) **Subsequent events** - The Plan has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued. There were no subsequent events that required adjustment of or disclosure in the financial statements.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

CPHI common stock: Reported at fair value based on an annual independent appraisal. The appraisal was based on the asset approach utilizing the tangible asset method consistent with prior years. Plan management has concluded that a market participant would also recognize a discount for lack of marketability. The valuation process involves Plan management's selection of an independent appraiser under contract for a term of one year. Plan management accumulates the data for the appraiser from the reviewed financial statements of CPHI. The appraiser prepares a valuation report which is reviewed and approved by Plan management and the Trustee.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS

The Plan invests in CPHI common stock. This is a related party and party in interest transactions. As described in Note A, the Company pays all plan expenses. The Plan has a number of service providers. Such providers are parties in interest under ERISA.

NOTE F - RISKS AND UNCERTAINTIES

The Plan investments consist primarily of CPHI's common stock, which is exposed to various risks, such as interest rate, market, and credit risks, as well as valuation assumptions based on the asset approach. Due to the level of risk associated with the investment in the common stock and to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE G - PLAN TERMINATION

The Company reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon termination of the Plan, the Administrative Committee directs the Trustee is to pay all liabilities and expenses of the ESOP. Subsequently, the interest of each participant in the trust fund will become fully vested and distributed to such participant or his or her beneficiary at the time prescribed by the Plan terms and the IRC.

NOTE H - TAX STATUS

The Internal Revenue Service has determined and informed the Company by a letter dated June 16, 2014, that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
