Notes to Financial Statements

December 31, 2024 and 2023

Note 1 - Plan Description

The following description of Anderson Pacific Engineering Construction Inc. Money Purchase Pension Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established on April 1, 1983 intended to qualify under Section 401(a) and related provisions of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and applicable provisions of the IRC and subsequent laws. All employees of Anderson Pacific Engineering Construction Inc. (the "Company") are immediately eligible to participate in the Plan except employees covered by a collective bargaining agreement, certain nonresident aliens, and leased employees.

Administration

The Company is the sponsor of the Plan. The administrative committee, as provided in the plan agreement, is the plan administrator and has responsibility for the administration of the Plan. Charles Schwab Trust Bank serves as the custodian and holds the Plan's assets. Corporate Pension Consultants serves as the recordkeeper, maintains the Plan's records, and provides administrative services to the Plan. Investment management fees and custodian fees are paid by the Plan in accordance with the plan agreement.

Investments are directed as determined by the Company.

Contributions

The Company must make annual contributions equal to 10 percent of total eligible participant compensation, which are remitted to the Plan quarterly. The Company met the minimum funding requirements established by ERISA.

Vesting

Participants with at least one hour of credited service, as defined in the Plan, after January 1, 2008 are immediately 100 percent vested in their respective account balances.

Participant Accounts

Each participant account is credited with the allocations of the Company's contributions and plan earnings and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payment of Benefits

Upon disability, retirement, or termination, a participant or his or her beneficiary may receive, at his or her election, within a reasonable period of time, a lump sum or a life annuity distribution in the amount equal to the participant's vested account balance. Upon death, distribution of the participant's entire account shall be completed by December 31 of the calendar year containing the fifth anniversary of the participant's death unless an election is made by his or her beneficiary to receive distributions either (a) over the life or over a period not greater than the life expectancy of the beneficiary commencing on or before December 31 of the calendar year immediately following the calendar year in which the participant died, or (b) if the beneficiary is the surviving spouse, the date distributions are required to begin in accordance with (a) above and shall not be earlier than the later of (i) December 31 of the calendar year immediately following the calendar year in which the participant died and (ii) December 31 of the calendar year in which the participant would have attained age 73. Benefits are recorded when paid.

Note 1 - Plan Description (Continued)

The Plan allows in-service distributions and partial distributions to participants age 62 or older who have not terminated employment with the plan sponsor. Furthermore, the Plan allows for terminated participant vested account balances of \$1,000 or less to be automatically distributed as a lump-sum amount equal to the value of the participant's vested interest in his or her account.

Party-in-interest Transactions

The Plan provides for participant notes receivable, which are party-in-interest transactions that are exempt from the prohibited transaction rules. Certain fees are paid to the Plan's recordkeeper; however, under ERISA, these transactions qualify as exempt party-in-interest transactions.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. If the Plan is terminated for any reason, the plan administrator is to distribute each participant's interest to the participant or the participant's beneficiary.

Note 2 - Summary of Significant Accounting Policies

Contributions Receivable and Contributions from Employers

Contributions are made by the employer for the amount of benefits due to eligible employees on the date of payment. Contributions are accrued based on the benefit obligations earned during each quarter of the plan year.

Investment Valuation

The Plan's investments are stated at fair value, as reported to the Plan by the custodian. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

The common collective trust fund is valued at net asset value per share (NAV) (or its equivalent) of the fund, which is based on the fair value of the fund's underlying net assets. The common collective trust fund's strategy is to maintain a target allocation that ranges between 50 percent and 70 percent in domestic and international equities. The remaining investments of the common collective trust fund are to be composed of allocations to fixed income, such as bonds, stable value, and money market funds, as well as allocations to alternative investment strategies, such as long, short, and managed futures. The common collective trust investment manager will primarily use mutual funds to execute the strategy. There are no redemption notice requirements, redemption restrictions, or unfunded commitments on this investment.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

Participant Notes Receivable

Participants may borrow from the Plan subject to certain maximum and minimum amounts determined by the plan administrator and the Internal Revenue Code. The Plan does not restrict the purposes for which loans may be made. Notes receivable bear interest at a fixed rate determined by the plan administrator. The loans are collateralized by the vested balances in participants' accounts and bear interest at rates that range from 5.25 to 10.50 percent and mature at various dates through July 2029.

Note 2 - Summary of Significant Accounting Policies (Continued)

Principal and interest are paid ratably through payroll deductions. Participant loans are recorded in the financial statements at amortized cost (which represents unpaid principal plus accrued interest). Upon termination of a participant from employment, the participant's loan shall be due in full. Participant loans are written off when deemed uncollectible and treated as a taxable event to the participant.

Administrative Expenses

The Plan pays all expenses for administrative services provided to the Plan.

Risks and Uncertainties

The Plan invests in a common/collective trust fund that invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including October 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

Charles Schwab Trust Bank (the "Custodian") holds the Plan's investments and executes all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by the Custodian.

Note 4 - Tax Status

The Plan uses a preapproved plan. The preapproved plan has received a favorable notification letter from the Internal Revenue Service indicating that each plan, as designed, was qualified for federal income tax-exempt status. The Plan had not individually sought its own determination letter.
