REPORT OF INDEPENDENT AUDITORS

To the Audit and Finance Committee of the Board of Directors
The Barton Group 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of The Barton Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

NOTE 1 – DESCRIPTION OF PLAN

The following brief description of The Barton Group 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan, sponsored by Barton Mines Corporation (DBA The Barton Group), covering substantially all employees of Barton Mines Corporation and Barton Mines Company, LLC (DBA Barton International) (collectively, the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Eligibility

Substantially all employees of the Company are eligible to participate in the Plan effective immediately following the date of hire.

Contributions

Participants may contribute up to 100% of annual compensation, as defined in the Plan. Participants may make pre-tax contributions or after-tax Roth contributions to the Plan, up to the limit prescribed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled into the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation, with an annual increase of 1%, up to a maximum of 10%, and their contributions invested in a designated target date fund until changed by the participant.

The Company has the discretion to make a matching contribution for each participant’s basic contribution. Participants must have a minimum of 6 months of employment to be eligible to receive the Company matching contribution. The Company provided a match of 100% up to 6% of compensation during 2024.

The Company has the discretion to make non-elective contributions. Participants must have a minimum of 6 months of employment to be eligible to receive the non-elective contribution. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.

Participant Accounts

Participant accounts are credited with participant contributions, Company discretionary matching contributions, discretionary non-elective contributions, if any, and investment earnings and are charged an allocation of administrative expenses. Allocations of investment earnings and administrative expenses are based on participant account balances relative to the total account balances of all participants in the same investment. The benefit to which a participant is entitled is the benefit that can be provided from a participant’s vested account.

NOTE 1 – DESCRIPTION OF PLAN (Continued)

Vesting

Participants immediately vest in their contributions, plus actual earnings thereon. Participants become 100% vested in Company discretionary matching and non-elective contributions under the following circumstances:

- death or disability;
- if the Plan is terminated or if all contributions are discontinued;
- if participation ceases due to a partial termination of the Plan;
- a participant attains their sixty-fifth birthday; and
- a participant attains their early retirement date defined as age fifty-five with six years of service.

Except as otherwise stated above, participant vesting in discretionary matching and non-elective contributions is as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 2 years	0%
After 2 years but less than 3 years	20%
After 3 years but less than 4 years	40%
After 4 years but less than 5 years	60%
After 5 years but less than 6 years	80%
After 6 years	100%

A participant of the Plan who terminates service with the Company forfeits the non-vested portion of Company discretionary matching and non-elective contributions.

Payment of Benefits

Upon termination of service for any reason, participants with a vested account balance less than \$5,000 will receive a lump-sum payment equal to the value of the participant's vested account balance. Terminated participants with a vested account balance greater than \$5,000 may elect to receive either a single lump-sum payment; installment payments over a period of not more than the participant's life expectancy; or partial withdrawals.

Withdrawals from participant salary deferral accounts (excluding earnings) may be made in the event of financial hardship, in accordance with the provisions specified in the Plan and from participant accounts upon reaching age 59½, in accordance with the provisions specified in the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in a participant's account. Loan interest rate, determined quarterly, is set at 1% above the prime rate, as defined. Principal and interest are paid ratably through payroll deductions. Upon termination, loans will not become automatically due and payable. Participants with loans may request a direct rollover of the loan to their new employer upon termination of employment or may arrange for scheduled loan payments to be made directly to Empower Annuity Insurance Company of America.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested account balances totaled \$19,686 and \$28,403, respectively. These accounts will be used to reduce future employer contributions or to pay Plan administrative expenses. During 2024, \$29,034 of forfeited non-vested account balances were used to fund employer contributions and \$630 was used to reduce Plan administrative expenses.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Investment contracts held are required to be reported at fair value, except for fully benefit-responsive investment contracts where contract value is the relevant measure for the portion of net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued interest. Interest income is recorded on the accrual basis. Related fees are charged directly to individual participant accounts and are included in administrative expenses.

Payment of Benefits

Benefits are recognized when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to participant accounts and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 – FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (level 1) and the lowest priority to unobservable inputs (level 3).

Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets. Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs are not available. Level 3 inputs are used if Level 1 or Level 2 inputs are not available.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (NAV) and to transact at that price.

Variable annuities: Unit values calculated daily by the annuity provider according to the methods described in the annuity contract. The initial pricing input is the quoted price obtained for the underlying mutual fund which is then adjusted to apply the expense factor disclosed in the annuity contract. The formula-calculated unit value is then compared to an accounting-driven unit value the following morning. The accounting unit value is determined in a manner similar to a mutual fund NAV calculation: dividing the net assets by the number of units outstanding. Any discrepancies between the two-unit values are resolved to ensure the recordkeeping system reflects the accurate value for the day.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 4 – INFORMATION CERTIFIED BY TRUSTEE

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Retirement, LLC (collectively Empower), the insurance company and recordkeeper of the Plan, have furnished certain financial information to the Plan administrator and certified as to its completeness and accuracy.

These certifications are as of December 31, 2024 and 2023 and for the year ended December 31, 2024, and includes investment information related to fair value of investments, contract value of investments, notes receivable from participants, interest and dividend income, interest income on notes receivable from participants and net appreciation (depreciation) in fair value of investments that are included in the Plan’s financial statements and supplemental schedule of assets (held at end of year).

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT

The Plan holds a separate account guaranteed interest contract which is a fully benefit-responsive investment contract (fixed interest fund) with Empower. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. Empower is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than 3%. The crediting rate is reviewed and reset semi-annually. The guaranteed investment account does not permit the insurance company to terminate the agreement prior to its scheduled maturity date. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

NOTE 5 – FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT (Continued)

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity washing provisions; (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan; (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA; or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract insurers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines; (2) a breach of material obligation under the contract; (3) a material misrepresentation; or (4) a material amendment to the agreement without the consent of the issuer.

NOTE 6 – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan, subject to the provisions of ERISA. In the event of a termination, participants would become 100% vested in their employer contributions.

NOTE 7 – TAX STATUS

The underlying non-standardized prototype plan has received an opinion letter from the IRS dated June 30, 2020, stating that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 – RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant’s account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9 – PARTY-IN-INTEREST TRANSACTIONS

Certain plan investments are managed by Empower. Empower is the Plan’s insurance company and recordkeeper, and therefore, these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules of ERISA.

Notes receivable from participants also qualify as party-in-interest transactions and are also exempt from the prohibited transaction rules of ERISA.
