The following brief description of the Nichols Contracting, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan documents or the Summary Plan Description for more complete information.

***General***

The Plan is a profit-sharing plan covering substantially all employees of Nichols Contracting, Inc. (Company) who have completed three months of service and who are 21 years old. Employees are automatically enrolled into the Plan on the first day of the month coinciding with or following attainment of eligibility unless they affirmatively elect otherwise. Nonresident aliens and union and leased employees are excluded from the Plan. The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may contribute up to 100% of annual compensation, as defined by the Plan. Participants are automatically enrolled in the Plan after three months of service at a rate of 2% and will increase annually by 1% up to a maximum of 10% of compensation unless an alternative election is made. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes a flexible discretionary matching contribution of 50% of the participant's deferrals up to 4% of the contributing participant's eligible compensation. The Company also contributes a safe harbor non-elective contribution that is equal to 3% of each participant's eligible compensation. The Company may make additional non-elective discretionary contributions to the Plan. There was no non-elective discretionary contribution for the year ended December 31, 2024. To be eligible for the flexible discretionary matching contribution and Company non-elective profit-sharing contribution, the participant must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of any Plan earnings. Participants' accounts are charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions, and non-elective safe harbor employer matching contributions, plus actual earnings thereon. A participant's interest in the Company's discretionary profit-sharing contributions and the Company's flexible discretionary matching contributions become fully vested and nonforfeitable upon six years of service credited as defined by the Plan.

***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions to specified investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options as of the first day of each month.

***Notes Receivable From Participants***

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable bear interest equal to 1% above the prime rate. Notes receivable are repaid through payroll deductions and may be repaid in full at any time. Participants may only have two loans outstanding at any time.

***Payment of Benefits***

Upon retirement, death, disability, or termination of employment, a participant may elect to receive the value of the participant's account in a lump sum. Distributions of less than \$5,000 that meet the provisions for a mandatory distribution will be rolled over into an IRA in the participant's name with a qualified institution, if the participant does not elect the distribution method. In addition, hardship, and in-service distributions are permitted if certain criteria are met.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in the net change in investments.

***Forfeited Accounts***

At December 31, 2024, forfeited nonvested accounts totaled \$18,382. These accounts will be used to reduce the Company's contributions and administrative expenses in accordance with

the Plan documents. In 2024, the Company's contributions and administrative expense of the Plan were reduced by forfeitures of \$44,753.

**NOTE 2**    **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Basis of Accounting***

The accompanying financial statements were prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

***Payments of Benefits***

Benefits are recorded when paid.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

***Reclassifications***

Certain prior year amounts were reclassified to conform with the current year presentation.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE CUSTODIANS**

Plan investments were held by the Custodians, Fidelity Management Trust Company at December 31, 2024 and Empower Annuity Insurance of America at December 31, 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Custodians. That information, which was not audited by independent auditors, is summarized below.

**NOTE 4 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs

*(See Independent Auditors' Report)*

to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Codification are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value.

Money Market Fund and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Pooled Separate Accounts: Valued using NAV per unit. The NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes

its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5** **GUARANTEED INVESTMENT CONTRACT**

The Plan had a traditional fully benefit responsive guaranteed contract with Empower Annuity Insurance Company of America, which is reported at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

**NOTE 7 TAX STATUS**

The Plan adopted a non-standardized Pre-Approved Profit-Sharing Plan with a cash or deferred arrangement sponsored by Fidelity Management Trust Company. The Plan received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated the Plan and related trust were designed in accordance with applicable requirements of the IRS. The Plan since was amended. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 8 RELATED-PARTY TRANSACTIONS**

The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$37,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**SCOPE AND NATURE OF THE ERISA SECTION 103(A)(3)(C) AUDIT FOR THE 2024 FINANCIAL STATEMENTS**

We performed an audit of the accompanying financial statements of the Nichols Contracting, Inc. 401(k) Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the Statement of Net Assets Available for Benefits as of December 31, 2024, the related Statement of Changes in Net Assets Available for Benefits for the year then ended, and the related notes to the financial statements.

**NOTE 1**    **DESCRIPTION OF PLAN**

The following brief description of the Nichols Contracting, Inc. 401(k) Profit Sharing Plan (Plan) is provided for general information purposes only. Participants should refer to the Plan documents or the Summary Plan Description for more complete information.

***General***

The Plan is a profit-sharing plan covering substantially all employees of Nichols Contracting, Inc. (Company) who have completed three months of service and who are 21 years old. Employees are automatically enrolled into the Plan on the first day of the month coinciding with or following attainment of eligibility unless they affirmatively elect otherwise. Nonresident aliens and union and leased employees are excluded from the Plan. The Plan Administrator and Plan Trustees are responsible for oversight of the Plan, determine the appropriateness of the Plan's investment offerings, and monitor investment performance. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions***

Participants may contribute up to 100% of annual compensation, as defined by the Plan. Participants are automatically enrolled in the Plan after three months of service at a rate of 2% and will increase annually by 1% up to a maximum of 10% of compensation unless an alternative election is made. Participants who turn 50 years old before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). The Company makes a flexible discretionary matching contribution of 50% of the participant's deferrals up to 4% of the contributing participant's eligible compensation. The Company also contributes a safe harbor non-elective contribution that is equal to 3% of each participant's eligible compensation. The Company may make additional non-elective discretionary contributions to the Plan. There was no non-elective discretionary contribution for the year ended December 31, 2024. To be eligible for the flexible discretionary matching contribution and Company non-elective profit-sharing contribution, the participant must be employed on the last day of the Plan year and complete 1,000 hours of service during the Plan year. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

***Participant Accounts***

Each participant's account is credited with the participant's contribution, any Company contributions, and an allocation of any Plan earnings. Participants' accounts are charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their contributions, and non-elective safe harbor employer matching contributions, plus actual earnings thereon. A participant's interest in the Company's discretionary profit-sharing contributions and the Company's flexible discretionary matching contributions become fully vested and nonforfeitable upon six years of service credited as defined by the Plan.

***Investment Options***

Upon enrollment in the Plan, a participant may direct contributions to specified investment options. Specific information regarding these options may be obtained from the Plan Administrator. Participants may change their investment options as of the first day of each month.

***Notes Receivable From Participants***

Participants may borrow against the balance in their account, up to a maximum of the lesser of 50% of their vested balance or \$50,000. Note terms require amortization of principal and interest over a period not to exceed five years. Notes used to acquire a principal residence may extend beyond a five-year term. The notes receivable bear interest equal to 1% above the prime rate. Notes receivable are repaid through payroll deductions and may be repaid in full at any time. Participants may only have two loans outstanding at any time.

***Payment of Benefits***

Upon retirement, death, disability, or termination of employment, a participant may elect to receive the value of the participant's account in a lump sum. Distributions of less than \$5,000 that meet the provisions for a mandatory distribution will be rolled over into an IRA in the participant's name with a qualified institution, if the participant does not elect the distribution method. In addition, hardship, and in-service distributions are permitted if certain criteria are met.

***Administrative Expenses***

Certain administrative expenses of the Plan are paid by the Company. Expenses paid by the Company are excluded from these financial statements. Investment-related expenses are included in the net change in investments.

***Forfeited Accounts***

At December 31, 2024, forfeited nonvested accounts totaled \$18,382. These accounts will be used to reduce the Company's contributions and administrative expenses in accordance with

the Plan documents. In 2024, the Company's contributions and administrative expense of the Plan were reduced by forfeitures of \$44,753.

**NOTE 2**    **SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Accounting Standards Codification***

All references in the financial statements to the Codification refer to the Accounting Standards Codification and the Hierarchy of Generally Accepted Accounting Principles (GAAP) issued by the Financial Accounting Standards Board. The Codification is the single source of authoritative GAAP in the United States.

***Basis of Accounting***

The accompanying financial statements were prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

***Valuation of Investments***

The Plan's investments are reported at fair value, except for fully benefit responsive investment contracts, which are reported at contract value. See Note 4 for a discussion of fair value measurements.

***Payments of Benefits***

Benefits are recorded when paid.

***Risk and Uncertainties***

The Plan provides for investments in various investment securities, which are exposed to various risks, such as interest rate, credit, and overall volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term, and such changes could materially affect the amounts reported in the Statements of Net Assets Available for Benefits.

***Notes Receivable From Participants***

Notes receivable from participants are carried at their unpaid principal balance plus accrued interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan documents.

***Reclassifications***

Certain prior year amounts were reclassified to conform with the current year presentation.

***Subsequent Events***

The Plan evaluated subsequent events and transactions for potential recognition or disclosure in the financial statements through October 10, 2025, the date the financial statements were available to be issued.

**NOTE 3 INFORMATION CERTIFIED BY THE CUSTODIANS**

Plan investments were held by the Custodians, Fidelity Management Trust Company at December 31, 2024 and Empower Annuity Insurance of America at December 31, 2023. Financial information related to those investments is included in the accompanying financial statements based on information certified as complete and accurate by the Custodians. That information, which was not audited by independent auditors, is summarized below.

**NOTE 4 VALUATION OF INVESTMENTS**

Investments are recorded at fair value in accordance with the provisions of the Fair Value Measurements and Disclosures Topic of the Codification, which establishes a framework for measuring fair value. The framework provides a fair value hierarchy that prioritizes the inputs

*(See Independent Auditors' Report)*

to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under the Codification are described below:

Level 1      Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2      Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;

Quoted prices for identical or similar assets or liabilities in inactive markets;

Inputs other than quoted prices that are observable for the asset or liability;  
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3      Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Below are descriptions of the valuation methodologies used for assets measured at fair value.

Money Market Fund and Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan at year end. NAV is based on the value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of shares outstanding. NAV is a quoted price in an active market.

Pooled Separate Accounts: Valued using NAV per unit. The NAV is based on the value of the underlying investments owned by each fund, minus its liabilities, and then divided by the number of units outstanding. Participant-initiated transactions may occur daily at NAV.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes

its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**NOTE 5** **GUARANTEED INVESTMENT CONTRACT**

The Plan had a traditional fully benefit responsive guaranteed contract with Empower Annuity Insurance Company of America, which is reported at contract value. Contract value, as reported to the Plan by Empower Annuity Insurance Company of America, represents contributions made under the fund, plus earnings, less participant withdrawals and administrative expense. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. Certain events limit the Plan's ability to transact at contract value with Principal. Such events include the following: (a) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, or (d) a material misrepresentation. The Plan Administrator does not believe any events that would limit the Plan's ability to transact at contract value with Plan participants or the issuer are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, and the value of the interests of all participants and beneficiaries shall be determined and distributed to them in a lump sum.

**NOTE 7 TAX STATUS**

The Plan adopted a non-standardized Pre-Approved Profit-Sharing Plan with a cash or deferred arrangement sponsored by Fidelity Management Trust Company. The Plan received a favorable opinion letter from the Internal Revenue Service (IRS) on June 30, 2020, which stated the Plan and related trust were designed in accordance with applicable requirements of the IRS. The Plan since was amended. The Plan Administrator believes the Plan is currently designed in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes was included in the Plan's financial statements.

GAAP requires Plan management to evaluate uncertain tax positions for recognition in the financial statements. The Plan Administrator concluded that there were no uncertain tax positions taken as of December 31, 2024.

**NOTE 8 RELATED-PARTY TRANSACTIONS**

The Plan pays investment management and recordkeeping fees to parties in interest. The Plan paid approximately \$37,000 to parties in interest for the year ended December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 9 RECONCILIATION OF FINANCIAL STATEMENTS TO FORM 5500**
