## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors of the  
Capital Internal Medicine Associates, PC  
401(k) Retirement Plan

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Capital Internal Medicine Associates, PC 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Capital Internal Medicine Associates, PC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 7 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the Capital Internal Medicine Associates, PC 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Summary Plan Description and the Plan Agreement for complete information.

General

The Plan is a defined contribution savings plan pursuant to Section 401(k) of the Internal Revenue Code covering electing employees of Capital Internal Medicine Associates, PC (the Company or the Employer). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Eligible employees for employee deferrals are defined by the Plan as employees of Capital Internal Medicine Associates, PC with at least 90 days of service and are age 21 or older. Participant deferrals are subject to annual limitations imposed by the IRS. The amounts deferred shall be contributed by the Company on behalf of the participant into the Plan for allocation to the participant's employee contribution account.

Participants may also contribute amounts representing distributions from other qualified employee benefit plans (rollovers). The Plan received \$86,020 and \$212,961 in rollover contributions during 2024 and 2023, respectively.

The Company may make Safe Harbor non-elective contributions into the Plan. Participants must complete one year of service to be eligible for employer contributions. The employer matches, dollar for dollar, up to 3% of the employees' contribution and half of employee contributions greater than 3%, up to 5% (maximum of 4% of employees' eligible compensation). Employer Safe Harbor contributions are calculated on the last day of the fiscal year and remitted to the Plan in the following year.

The Company may make profit sharing contributions into the Plan. Profit sharing contributions are discretionary and participants are eligible after completing one year of service. The Company made \$0 of profit sharing contributions for the years ended December 31, 2024 and 2023.

Participant Accounts

Each participant's account is credited with each participant's contributions and allocations of (a) the Company's contributions, and (b) plan earnings and expenses. Amounts are allocated to participant's accounts based on compensation or account balances, as defined. Each participant shall maintain his or her account in one or more funds, all of which are maintained by American Funds. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in their employee deferrals, employer safe harbor contributions, and earnings thereon, at all times. Discretionary employer profit sharing contributions are subject to a six year vesting schedule.

Forfeitures

Forfeited non-vested company contributions accounts totaled \$67 and \$4,275 at December 31, 2024 and 2023, respectively. Forfeitures can be applied to reduce administrative expenses of the Plan or allocated to reduce the employer's contribution. During 2024 and 2023, \$4,297 and \$912, respectively, of forfeitures were used to pay expenses of the Plan. During 2024 and 2023, \$0, of forfeitures were used to reduce the employer's contribution.

Payment of Benefits

Upon retirement (normal retirement on or after age 65) or other separation of employment because of death, disability, or for other reasons, a participant will receive their benefit as a lump-sum payment equal to the value of their account. In-service distributions are available for participants who have obtained age 59½ or upon request due to financial hardship.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

Basis of Accounting

The financial statements are prepared on an accrual basis.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The process of preparing financial statements in conformity with accounting principles generally accepted in the United States of America requires the use of estimates and assumptions regarding certain types of assets, liabilities, revenues, and expenses. Such estimates primarily relate to unsettled transactions and events as of the date of the financial statements. Accordingly, upon settlement, actual results may differ from estimated amounts.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from the financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation (depreciation) of fair value investments.

Subsequent Events

The Plan evaluates events and transactions that occur after year-end for potential recognition or disclosure in the financial statements. These subsequent events have been considered through October 13, 2025, which is the date the financial statements were available to be issued.

**NOTE 3 - PLAN TERMINATION**

Although there has not been any expressed intent to do so, the Company reserves the right under the Plan to terminate the Plan in whole or in part at any time, subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their account balances.

**NOTE 4 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

**NOTE 5 - INCOME TAX/ERISA STATUS**

The Plan operates under a non-standardized Plan Document and obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. Although amended since that letter, the plan administrator believes the Plan, as amended, is currently being operated in compliance with applicable requirements of the Internal Revenue Code and is exempt from federal income taxes.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE 6 - RELATED PARTY TRANSACTIONS**

Plan investments are shares of mutual funds of the American Funds. The Plan's trustee is Capital Bank and Trust Company, which is related to the American Funds. Therefore, these transactions qualify as exempt party-in-interest transactions.

Certain administrative expenses of the Plan are paid directly by the plan sponsor and are not charged to the Plan.

**NOTE 8 - FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
  
- Level 2: Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - quoted prices for identical or similar assets or liabilities in inactive markets;
  - inputs other than quoted prices that are observable for the asset or liability
  - inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be publicly traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
