**NOTES TO FINANCIAL STATEMENTS
DECEMBER 31, 2024 AND 2023**

1. DESCRIPTION OF PLAN

The following description of the Arise Child & Family Service, Inc. Profit Sharing 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Arise Child & Family Service, Inc. and its subsidiary ARISE at Marshall Farms, Inc. (the Company) who complete one year of service, as defined, and are age eighteen (18) or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Participants may make voluntary contributions subject to certain limitations and the Company can make a discretionary match of each participant's contribution. In 2024 and 2023, the Company matched 50% of the first 5% of each participant's contribution to the Plan. The Company can also make supplemental contributions at the discretion of the Board of Directors; however, there were no supplemental contributions for the years ended December 31, 2024 and 2023. The Company's contributions are invested according to the participant's investment election. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover).

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and Plan earnings/losses. Allocations of earnings/losses and administrative expenses are based on account balances, according to specific terms provided by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account balance.

Vesting

Participants are immediately vested in their voluntary contributions and the Company's match, plus earnings/losses thereon. Vesting in the Company's supplemental discretionary contributions plus earnings/losses thereon is based on a vesting table, and participants are 100% vested after completing five years of credited service.

Notes Receivable from Participants

Plan participants may borrow up to the lesser of \$50,000 or 50% of the amount of the participant's vested interest in the Plan and may have a maximum of one outstanding loan. The minimum loan is \$500. Notes are repayable over not more than five years, except in the case of a note for the purchase of a primary residence. Participants must make note payments directly to the custodian. Notes receivable from participants are secured by their account balances and bear interest at rates ranging from 4.25% to 9.50%.

Payment of Benefits

On termination of service due to death, retirement or other reasons, a participant or beneficiary may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum amount, or in periodic payments if the vested balance exceeds \$5,000.

1. DESCRIPTION OF PLAN (Continued)

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's voluntary contributions account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

Forfeitures

Forfeitures of supplemental discretionary contribution accounts are used to reduce employer matching contributions, pay plan administration costs or can be reallocated to eligible participants. During the year ended December 31, 2023, forfeitures of non-vested account balances of \$2,500 were used to reduce employer matching contributions. There were no forfeitures used to reduce employer contributions in 2024. The total forfeited non-vested balances at December 31 2024 and 2023 were \$1,256 and \$816, respectively.

Administrative Expenses

The Company pays certain administrative costs of the Plan and certain costs are passed through to participants. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation in value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investments

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

The Plan has investment contracts with VOYA Retirement Insurance and Annuity Company (VOYA) that maintains participant contributions in a general account. These accounts are credited with actual earnings on the underlying investments and are charged with certain administrative expenses of the Plan. Since the agreement or funding agency has the ability to restrict certain transfers and withdrawals, the contract is not considered fully benefit responsive.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy

Accounting Standards Codification (ASC) Section 820 establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair market value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access. Valuation adjustments are not applied to Level 1 instruments. Since valuations are based on quoted prices that are readily and regularly available in an active market, valuation of these products does not entail a significant degree of judgment. There are no level 1 assets.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

The following is a description of the valuation methodology used for assets measured at fair value:

Pooled Separate Accounts: The fair value of the accounts is valued daily using accumulation unit value (AUV). AUV represents the underlying fund's daily net asset value, plus any applicable income, less the daily separate account charge. The AUV is first established when a new fund starts (typically, the beginning AUV is \$10.00) and is then determined daily. The fund's daily net asset values are available from the custodian. The contract's daily asset charge (separate account charge) is communicated to Plan management in the contract and applicable notice of change.

The Plan's investments in pooled separate accounts are invested in global and domestic equity and fixed income-based investments. The investment strategies of these accounts is to invest in global and domestic equity and fixed income investments with the goal of producing favorable long-term returns primarily through appreciation of assets, dividends, and interest. There are no restrictions on the number of transactions a participant can conduct. There are no withdrawal restrictions on any of the pooled separate accounts and there are no unfunded commitments related to these investments.

Fixed annuity contracts: Value is calculated based on discounted cash flows using risk-adjusted discount rates.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the methodologies used at December 31, 2024 and 2023.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Risks and Uncertainties

The Plan's investment securities are exposed to various risks, such as interest rate, market, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in participant accounts and the accompanying financial statements.

Contributions Receivable

The Plan records a receivable for the employee and employer contribution that is remitted to the Plan subsequent to the Plan's year end.

Notes Receivable

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

VOYA Retirement Insurance and Annuity Company, the custodian, has certified that the investment information included in the financial statements and accompanying supplemental schedule as complete and accurate as of and for the years ended December 31, 2024 and 2023, respectively, as follows:

5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time, subject to the provisions of ERISA. In the event of termination, partial termination, or complete discontinuance of contributions to the Plan, all amounts credited to the accounts of the participants would become fully vested and nonforfeitable. All distributions would be made in accordance with any applicable requirements of the ERISA and the Internal Revenue Code (the Code).

6. TAX STATUS

The IRS has determined and informed by letter for the prototype plan adopted by the Plan, dated March 31, 2014, that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

7. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. However, net assets available for benefits and changes in net assets available for benefits shown in the financial statements agreed to Form 5500 in total as of December 31 2024, and 2023, and for the years ended December 31 2024, and 2023, respectively.

8. PARTY-IN-INTEREST TRANSACTIONS

VOYA is the custodian of the Plan and the Company is the sponsor. As such, transactions between VOYA, the Company, and the Plan qualify as party-in-interest transactions. Additionally, notes receivable from participants are party-in-interest transactions.

9. SUBSEQUENT EVENTS

On September 12, 2024, the Company's Board of Directors approved a merger agreement with Exceptional Family Resources, Inc. (EFR) with an effective date of January 1, 2025. On December 16, 2024, the Company adopted an amendment to the Plan to merge the ARISE Child & Family Services, Inc. Profit Sharing 401(k) Plan (the "Plan") into the Exceptional Family Resources 401(k) Plan (the "Surviving Plan").

The plan merger became effective January 1, 2025, at which time all assets, liabilities, and participant account balances of the Plan were transferred to and became part of the Surviving Plan. The transfer of assets to the Surviving Plan was completed on August 19, 2025, at which point the Plan ceased to exist as a separate plan.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
