1. Description of Plan

The following description of the BDG Media, Inc. 401(k) Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees, as defined in the Plan, of BDG Media, Inc. (the "Company" or "Employer"). Employees are eligible to participate upon hire. The Plan was effective February 1, 2019 (inception). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Contributions

Each year, eligible employees may elect to contribute a portion of their eligible compensation to the Plan on a pre-tax basis or Roth basis, subject to limitations established by the Internal Revenue Code ("IRC"). The Plan has an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan at a rate of 3% unless they affirmatively opt out. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may make discretionary matching contributions and discretionary non-elective contributions to the Plan, which would be allocated to all eligible employees. Eligible employees must complete 1,000 hours of service. For the year ended December 31, 2024, the Employer did not make a discretionary matching contribution or discretionary non-elective contributions to the Plan.

Vesting

A participant is immediately 100% vested in their elective deferrals and rollover contributions, including allocated earnings thereon at all times. A participant is 100% vested in Employer discretionary matching contributions and discretionary non-elective contributions as follows: 0-2 years of service, 0% vested; after 2 years of service, 50% vested and after 3 years of service, 100% vested.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Employer contributions and (b) Plan earnings (losses). Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. All investments are participant directed.

1. Description of Plan (continued)

Payment of Benefits

Upon termination of service due to death, disability, retirement, age 59 1/2 or for other reasons, a participant or their beneficiary is entitled to receive a distribution in the amount equal to the value of the participant's vested interest in his or her account. If a participant has a balance less than \$1,000, he or she shall receive a lump-sum amount equal to the value of the participant's vested interest in his or her account without his/her consent.

Benefits can also be distributed from a participant's vested elective deferrals in the event of a participant's immediate and heavy financial need. Such distributions, which are considered hardship withdrawals, cannot exceed the amount required to relieve the financial need.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum amount of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with interest rates currently being charged on similar commercial loans by persons in the business of lending money as determined by the plan administrator. Principal and interest is paid ratably through payroll deductions. The loan must be repaid within a period not to exceed five years from the date the participant receives the loan, unless the loan is for the purchase of the participant's principal residence, in which case the loan must be repaid within the period permitted which is greater than five years.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP"), which requires management to make estimates and assumptions that affect assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist. The Plan's investments, that were valued at fair value, were valued using level 1 inputs.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for the insurance company general account which is valued at contract value. Mutual funds held by the Plan are valued at the fair value based on the daily closing price as reported by the funds. All of the mutual funds are open-ended and are registered with the Securities and Exchange Commission. These mutual funds are required to publish their daily NAV and to transact at that price. The insurance company general account is valued at contract value, which represents contributions plus credited interest less participant withdrawals and fees.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Employer and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded upon a distributable event. Such payments are reflected as deemed distributions in the Statement of Changes in Net Assets Available for Benefits.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is October 13, 2025.

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Life & Annuity Insurance Company of New York and Empower Trust Company, LLC (collectively "Empower"), qualified institutions.

4. Insurance Company General Account

Participants have the option to invest in a benefit-responsive investment contract with Empower Life & Annuity Insurance Company of New York. The Guaranteed Interest Account (the "GIA") is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets of the portion of the Empower Life & Annuity Insurance Company of New York general account that is used to determine the GIA's crediting rate compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset at least annually and no more frequently than quarterly for some contracts. Participants may direct permitted withdrawal and/or transfer transactions of all or a portion of their account balance at contract value.

Because the insurance company general account is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the insurance company general account.

5. Party-in-Interest Transactions

The GIA is managed by Empower Life & Annuity Insurance Company of New York, the custodian of the Plan, as defined by the Plan. Accordingly, these transactions are considered exempt party-in-interest transactions under ERISA.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statements of net assets available for benefits.

Certain employees of the Employer, who may also be participants in the Plan, perform administrative services for the Plan at no cost to the Plan.

The Plan and Empower Annuity Insurance Company have entered into a revenue sharing arrangement whereby a portion of the revenue earned by certain funds is passed through to the Plan for payment of permitted plan expenses. In order for the Plan to receive credits as a result of this revenue sharing arrangement, and to use this credit to pay plan expenses, the Company created the ERISA Account. The ERISA Account is similar in design to forfeiture accounts, and is used to record keep the redistribution of plan-generated fund revenue that exceeds the costs associated with plan administration. The ERISA Account balance was \$0 and \$0 at December 31, 2024 and 2023. During 2024, administrative expenses incurred by the Plan were reduced by \$66,483 from the ERISA account.

6. Tax Status

The Internal Revenue Service has determined and informed the prototype document preparer by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event of a plan termination, participants would become 100% vested in their Employer contributions.

8. Prohibited Transactions

During the 2024 Plan year and prior, the Employer failed to transmit to the Plan certain participant's contributions totaling \$88 and \$10,275 within the period described by Department of Labor regulations. Delays in remitting these amounts to the Plan were due to an administrative oversight. The Employer is in the process of calculating and remitting lost earnings.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
