## INDEPENDENT AUDITOR'S REPORT

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of JELD-WEN 401(k) Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of JELD-WEN 401(k) Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

### Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- The amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- The information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of JELD-WEN 401(k) Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

## **Responsibilities of Management for the Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about JELD-WEN 401(k) Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

## JELD-WEN 401(k) RETIREMENT SAVINGS PLAN NOTES TO FINANCIAL STATEMENTS

### 1. Plan Description

The following description of the JELD-WEN 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

The Plan is a defined contribution plan which was adopted on January 1, 2007, for all eligible employees of JELD-WEN, Inc. (the Company) and participating subsidiaries. Participants of the Plan can elect to make tax-deferred or Roth (after-tax) contributions upon eligibility and are eligible for Company matching contributions. The Plan is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The JELD-WEN Retirement Benefits Administration Committee (the Committee) oversees governance of the Plan. The Plan's most recent restatement was effective January 1, 2023.

An eligible employee is defined as an employee who has completed one month of service for the Company or a participating subsidiary, provided they are over the age of 18 and are not excluded from participating as defined in the Plan Agreement.

#### Participant Accounts

Participants direct the investment of their accounts into various investment options offered through the Plan's trustees, Principal Trust Company, who held the Plan's assets through October 31, 2023 and Fidelity Management Trust Company, who held the Plan's assets effective November 1, 2023. Participant accounts include the following subaccounts:

- *Employee contributions (elective deferrals)* – The Plan includes automatic enrollment for newly eligible employees. The Company will automatically deduct a percentage determined by the Committee annually. For the years ended December 31, 2024 and 2023, auto enrollment was set at 4 percent of a participant's compensation on a pre-tax basis. Participants have the option to change their rate of contribution, elect to contribute on a Roth (after-tax) basis, or decline participation entirely. The Plan also includes an automatic escalation feature. The parameters of the automatic escalation are also determined by the Committee annually. For the years ended December 31, 2024 and 2023, unless they opt out, the deferral rate for Participants who contribute between 1 percent and 7 percent will automatically increase by 1 percent up to a maximum of 8 percent. Total annual deferrals may not cause the participant's total contributions to exceed limitations provided by the Internal Revenue Code (IRC). Additionally, employees age 50 or older are eligible to contribute "catch-up" contributions up to Internal Revenue Service (IRS) limits. Participants may elect their deferrals be treated as pre-tax or after-tax (Roth), which are accounted for separately.
- *Employee rollovers* – Rollover contributions represent amounts transferred by participants from other tax-qualified retirement plans, other than those sponsored by the Company.

**Participant Accounts**, continued

- *Employer contributions* – The Company contributes a Safe Harbor match equal to 100 percent of the first 3 percent and 50 percent of the next 2 percent of a participant's compensation contributed as deferrals. Employer contributions to union-represented employees are based on a collectively bargained formula and are not subject to the discretion of the Board of Directors of the Company. Effective January 1, 2023, the Plan was restated to suspend Safe Harbor matching contributions and add a discretionary non-Safe Harbor matching contribution. The Plan was amended on December 28, 2023 to reinstate Safe Harbor matching contributions for the 2024 Plan year and provide a retroactive matching contribution for 2023 to each eligible employee actively employed on June 30, 2023 as well as a matching contribution through December 31, 2023, in an amount equal to the previous Safe Harbor match. The Company will not make any discretionary matching contributions to the Plan for Plan years beginning on or after January 1, 2024.
- *ESOP transfers* – Qualified diversification distributions from the JELD-WEN, Inc. Employee Stock Ownership and Retirement Plan are directed into the Plan. These transfers are included in "transfers of assets from other plans" on the statements of changes in net assets available for benefits.
- *KSOP transfers* – Qualified diversification distributions from the JELD-WEN, Inc. KSOP are directed into the Plan. These transfers are included in "transfers of assets from other plans" on the statements of changes in net assets available for benefits.
- *Union transfers* – Former participants in the JELD-WEN, Inc. Restated 401(k) Savings Plan for Union Represented Employees have transferred their balances into the Plan.

Each participant's account is credited with their respective contributions and earnings and charged with an allocation of administrative expenses paid by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Payment of Benefits**

In the event of death, disability, retirement, or termination of employment, the participant's account balance is payable as soon as administratively feasible after the date of the event. The participant's entire balance will be distributed in a single lump-sum cash payment. If the participant's account balance exceeds \$1,000, they may retain their account with the Plan until reaching age 70½, or effective in 2020, age 72, at which time they must begin receiving required minimum distributions.

The Plan provides for hardship withdrawals in the event of an immediate and heavy financial need in an amount not to exceed the lesser of the participant's eligible sub-account balances or the amount of the financial need.

**Notes Receivable from Participants**

The Plan allows participants to borrow from their accounts in an amount not to exceed the lesser of \$50,000 or 50 percent of their account balance, reduced by the highest outstanding loan balance during the prior 12-month period. Loan transactions are treated as transfers from the investment funds to the participant's loan fund. Participants may only have one loan outstanding at a time. The loans are secured by the balance in the participant's account and bear interest at a reasonable rate commensurate with prevailing interest rates at the time of origination, as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

**Vesting**

Participant accounts are 100 percent vested at all times.

**ERISA Spending Account**

The Plan maintains an ERISA spending account in a common/collective trust investment. This account is credited with a rebated percentage of the asset value of particular funds by the fund manager and the percentage varies by fund. During 2024, the Plan removed the majority of their revenue sharing funds and implemented a flat 3.5 basis point fee to all funds and that fee is credited to the ERISA spending account. Funds in the ERISA spending account are to be used to pay plan expenses or are reallocated to participants. During the years ended December 31, 2024 and 2023, revenue sharing credits of \$92,781 and \$345,964, respectively, were credited to the ERISA spending account. During the years ended December 31, 2024 and 2023, \$105,428 and \$0-, respectively, was credited to the ERISA spending account from the 3.5 basis point fee applied to all funds. The balance in the account was \$394,056 and \$364,175 as of December 31, 2024 and 2023, respectively. \$179,609 and \$75,300, respectively, were used to pay plan expenses during the years ended December 31, 2024 and 2023. On January 10, 2025, \$280,990 was reallocated to participants.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Plan Administrator determines the Plan's valuation policies utilizing information provided by the Plan's trustees and investment advisors. See Note 9 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income are recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan.

**Administrative Expenses and Fees**

Expenses of maintaining the Plan, including participant recordkeeping and transaction fees as well as allowable professional fees, are paid from the Plan. The Company may elect to pay certain Plan expenses depending on the type and circumstances, which would therefore be excluded from these financial statements. Investment related expenses are included in net change in fair value of investments, other than directly paid third-party investment advisory fees, which are included in investment expenses. Fees for administration of notes receivable from participants and certain distributions are included in administrative expenses and charged directly to the specific participant's account.

**Payment of Benefits**

Benefits are recorded when paid.

**Recent Accounting Standard Adopted**

On January 1, 2023, the Plan adopted Accounting Standards Update (ASU) 2016-13 Financial Instruments – Credit Losses (Topic 326): *Measurement of Credit Losses on Financial Instruments*, and all related amendments (ASC 326), which replaced the incurred loss methodology for recognizing credit losses with an expected loss methodology that is referred to as the current expected credit loss (CECL) methodology. CECL requires an estimate of lifetime expected credit losses to be recognized for financial assets based on historical experience, current conditions, and reasonable and supportable forecasts, and for the financial assets to be presented at the net amount expected to be collected on the statements of net assets available for benefits. The financial assets held by the Plan that are subject to ASC 326 are employer contributions receivable and participant contributions receivable.

**Recent Accounting Standard Adopted**, continued

The Plan adopted ASC 326 effective January 1, 2023. There was no impact to the financial statements as a result of adopting this standard.

**3. Plan Administration**

The Plan is administered by the JELD-WEN Retirement Benefits Administration Committee (the Committee). Employees of the Company are appointed as members of the Committee based on the position they hold with the Company as outlined under the terms of the Plan. The Plan retained Principal Trust Company as the third-party administrator and record-keeper of the Plan through October 31, 2023 and Fidelity Management Trust Company effective November 1, 2023.

**4. Information Certified by the Plan's Trustees**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Principal Trust Company, acting as the trustee through October 31, 2023 and Fidelity Management Trust Company, acting as the current trustee beginning October 31, 2023, have certified the following information included in the accompanying financial statements and supplemental schedule as complete and accurate as of and for the years ended December 31:

**5. Related Party and Party-in-Interest Transactions**

Fees paid by the Plan to the trustees and charged to participant accounts for trustee and record-keeping services (not including fees for specific participant loan and distribution transactions) were \$424,240 and \$418,261 for the years ended December 31, 2024 and 2023, respectively. Loan and distribution transactions fees charged to participants totaled \$230,655 and \$164,116 for the years ended December 31, 2024 and 2023, respectively.

These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA.

**7. Tax Status**

The Plan has obtained a determination letter dated December 16, 2014, in which the IRS determined and informed the Company that the Plan as then designed was in accordance with the applicable requirements of the IRC. Although the Plan has been restated and amended since receiving the determination letter, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC, and therefore believes that the Plan is qualified.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

**8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**9. Fair Value Measurements**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to their fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Registered investment companies (mutual funds):* Valued at the daily closing price as reported by the fund. All mutual funds held by the Plan are open-end mutual funds that are registered with the SEC and are deemed to be actively traded. These funds are required to publish their daily net asset value (NAV) and to transact at that price.

*Cash and cash equivalents:* Values at contract value of shares held, which approximates fair value.

*Common/collective trusts:* Units held in the common/collective trusts are valued using the NAV of the fund. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying assets owned by the fund, minus its liabilities, and then divided by the number of units outstanding. Participant transactions (purchases and sales) may occur daily at NAV. Pursuant to Accounting Standards Update (ASU) 2015-07, *Fair Value Measurements*, the common/collective trusts measured at NAV have not been classified in the fair value hierarchy. All common/collective trusts investments held by the Plan have no unfunded commitments, and the investments may be redeemed by participants on a daily basis with no required notice period. The stable value fund units held by the Plan are considered to not be fully benefit-responsive and are therefore carried at fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair value. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**10. Subsequent Events**

Management evaluates events and transactions that occur after the statement of net assets available for benefits date as potential subsequent events. Management has performed this evaluation through the date of the independent auditor's report.

A class action complaint was filed on June 25, 2025 in US District Court, Northern District of Illinois (Eastern Division), by plaintiffs Kenneth Kring and Elizabeth Kring against JELD-WEN Holding, Inc., Gallagher Fiduciary Advisors, LLC and the JELD-WEN Retirement Benefits Administration Committee for the Plan.

Effective January 1, 2025, the Plan has adopted selected SECURE 2.0 withdrawal provisions, including qualified birth or adoption withdrawals, withdrawals for victims of domestic abuse, emergency withdrawals and withdrawals for employees affected by federally declared disasters.

The Company amended the Plan to suspend the Plan's Safe Harbor matching contribution for the remainder of 2025 effective September 12, 2025.
