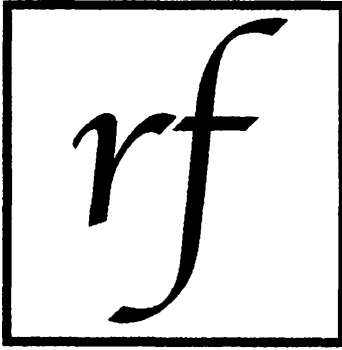

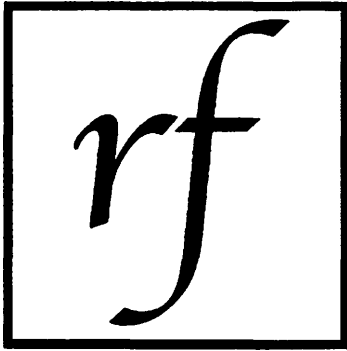

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

### ***Auditor's Responsibilities for the Audit of the Financial Statements for the 2024 Financial Statements***

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated October 7, 2024, indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). **Notes to Financial Statements**  
**December 31, 2024 and 2023**

**Note 1**            **Plan Description**

The following description of the Solvista Health 403(b) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan established by West Central, Inc. dba Solvista Health (Solvista Health) and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was adopted under the provisions of Internal Revenue Code (IRC) Section 401(a). Participation in the Plan is entirely voluntary. An eligible employee is any person employed by Solvista Health. There are no age or service requirements for participants to make salary deferral contributions. In order to be eligible to receive matching contributions from the employer, participants must be at least twenty-one years of age and have completed at least six consecutive months of service with the Solvista Health. A year of service is achieved by working at least 1,000 hours during the eligibility measuring period immediately following the participant's date of hire. Employees must work 500 hours to avoid a break in eligibility service.

Employee Contributions

Participants are permitted to contribute up to 100% of their annual compensation, as defined in the Plan document, to the Plan on a pre-tax or after-tax basis. Contributions may not exceed dollar limits set by the IRC. Transfers from qualified plans are allowed under provisions of the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual fund options for participants.

Employer Contributions

Participants that satisfy the eligibility requirements as defined by the Plan provisions and make salary deferrals to the Plan are entitled to receive matching contributions. Solvista Health is entitled to make discretionary matching contributions to participating employees. The amount that can be added each year to a participant's account, which includes contributions made by the participant and the Company on the participant's behalf, is subject to restrictions imposed by the IRC. For the year ended December 31, 2024, the Company made matching contributions of each participant's elective deferral up to 6%, of a participant's eligible compensation. For the year ended December 31, 2023 the Company made matching contributions of \$418,497.

Participant Accounts

Each participant's account is credited with the participant's contributions, Solvista Health's contributions made on the participant's behalf, and Plan earnings. Allocations of Plan earnings are based on participants' account balances as defined by the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Investment Elections

Each participant may direct that salary reductions to his or her account be invested in one or more of the investment options offered by the Plan. Participants may change such allocations at any time directly with Ascensus, LLC, the Plan's third party administrator (TPA).

### Vesting

Participants are immediately vested in their contributions, including rollover contributions, plus actual earnings thereon. Employees are 100% vested in the Plan's discretionary contribution portion of participants' accounts plus actual earnings after completing six months of service. A year of vesting service is credited for each year in which a participant works at least 1,000 hours. In the event of a participant's death, disability, or attainment of normal retirement age (65) while employed with the Plan, the participant is automatically 100% vested.

### Payment of Benefits

Upon termination of service, a participant will receive a lump-sum payment equal to the value of his or her account, provided the account does not have a value greater than \$1,000 and an election has not been made to directly rollover the balance to an eligible individual retirement account (IRA). Participants with account values of at least \$1,000, but less than \$5,000, may receive a lump-sum payment, elect to rollover the balance to another plan or IRA, or if no other option is selected, the balance will be rolled over to an IRA on behalf of the participant. If a participant's account value is \$5,000 or more, the participant may continue holding investments within the Plan, or elect to withdraw. Participants are not required to take payments from the Plan until the required distribution age of 70 ½. In-service distributions are permitted, subject to the provisions of the Plan, if a participant has reached age of 59 ½ at the time of distribution, or if a hardship has been incurred. Distributions upon a participant's death will be made to the designated beneficiary.

### Forfeitures

If a participant terminates service prior to being fully vested in their account under the Plan, they will forfeit the amount in which they are not vested. Forfeitures of contributions made by the Company are determined at year end and may be used to reduce amounts otherwise required to be contributed to the Plan.

For the year ended December 31, 2024, no forfeitures were used to reduce employer contributions.

## **Note 2**

### **Summary of Significant Accounting Policies**

#### Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

#### Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (see Note 4). Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

### Payment of Benefits

Benefits are recorded when paid by the trustee.

### Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

## **Note 3 Information Certified by the Plan's Trustee**

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. American United Life Insurance Company (AUL), the trustee of the Plan for the period from April 1, 2022 through December 31, 2023 and Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company (Principal), the trustee of the Plan for the period from January 1, 2022 through March 31, 2022, have certified to the completeness and accuracy of all investments and notes receivable from participants reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity reflected in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.

## **Note 4 Fair Value Measurements**

The Plan complies with Financial Accounting Standards Board Accounting Standards Codification Topic 820, Fair Value Measurements and Disclosures (ASC 820). ASC 820 defines fair value, establishes a consistent framework for measuring fair value and expands disclosure requirements for fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

Under ASC 820, assets and liabilities are grouped into three levels, based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are:

- *Level 1* – Valuation is based upon quoted prices for identical instruments traded in active markets.
- *Level 2* – Valuation is based upon quoted prices for similar instruments in active markets, quoted prices for identical or similar instruments in markets that are not active, and model-based valuation techniques for which all significant assumptions are observable in the market.
- *Level 3* – Valuation is generated from model-based techniques that use significant assumptions not observable in the market. These unobserved assumptions reflect Plan management's own estimates of assumptions that market participants would use in pricing the asset or liability. Valuation techniques include use of option pricing models, discounted cash flow models, and similar techniques.

Under ASC 820, the Plan bases fair values on the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements for assets and liabilities where there exists limited or no observable market data and, therefore, are based primarily upon the Plan's estimates, are often calculated based on current pricing policy, the economic and competitive environment, the characteristics of the asset or liability and other such factors. Therefore, the results cannot be determined with precision and may not be realized in an actual sale or immediate settlement of the asset or liability. Additionally, there may be inherent weaknesses in any calculation technique, and changes in the underlying assumptions used, including discount rates and estimates of future cash flows, that could significantly affect the results of current or future values.

Following is a description of the valuation methodology used for assets measured at fair value.

*Mutual Funds and Money Market Funds:* Valued at the net asset value (NAV) of shares held by the Plan at year end.

The preceding methodology described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**Note 5 Plan Termination**

Although they have expressed no intention to do so, Solvista Health has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants will become 100% vested in their accounts.

**Note 6**      **Tax Status**

The Plan obtained its latest determination letter dated January 1, 2018, in which the Internal Revenue Service states that the plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. Plan management and the Plan's tax counsel believe that the Plan is currently designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

**Note 7**      **Related-Party Transactions**

The Plan pays for certain plan expenses while the Company absorbs certain administrative expenses, such as accounting fees, on behalf of the Plan. Vanguard provides recordkeeping services to the Plan. Certain plan investments are shares of mutual funds managed by Vanguard. Therefore, these transactions qualify as party-in-interest transactions and are denoted as such on the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year).

**Note 8**      **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9**      **Subsequent Events**

The Plan has evaluated subsequent events through October 6, 2024, the date at which the financial statements were available to be issued, and determined that no events have occurred that would require disclosure.
