Independent Auditors' Report

The following description of SouthGroup 401(k) Plan (hereafter referred to as the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of SouthGroup Insurance and Financial Services, LLC (hereafter referred to as the "Company") who are twenty-one (21) years of age and have completed one year of service. An employee may begin participation in the Plan on the first day of the quarter following the date on which the employee meets the requirements for eligibility. The Company's Board of Directors and the Plan Administrator control and manage the operation and administration of the Plan. Ascensus Trust Company served as the Custodian of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The Company and its subsidiary are limited liability companies pursuant to the provisions of the Mississippi Limited Liability Company Act. Its primary business activity is to provide customer insurance agency activities, including administration, accounting, servicing, marketing and other services for its members.

Contributions

Participants may contribute up to 15 percent of their pre-tax annual salary, limited to \$23,000 and \$22,500 for 2024 and 2023 respectively, as adjusted annually by the Secretary of the Treasury. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Additionally, participants age fifty (50) and older can elect to make additional catch-up deferrals (limited to \$7,500 for 2024 and 2023, respectively). As a safe harbor plan, the Company contributes 100 percent of the first 3 percent of base compensation that a participant contributes to the Plan and 50 percent of the next 2 percent.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of the Company's contribution and Plan earnings and is charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Forfeited balances of terminated participant's non-vested accounts are used to reduce employer contributions for the year. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, plus actual earnings thereon. Vesting in the Company's matching contribution portion of their accounts, plus actual earnings thereon is as follows:

Forfeited Accounts

At December 31, 2024 and 2023, there were forfeited nonvested account balances of \$0 and \$1,018. Forfeited accounts may be used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, forfeiture amounts of \$1,018 and \$-0- were used to reduce Company contributions.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions in any investment options allowed by the Plan. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at a rate of 4.25 percent to 9.50 percent, which is commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Payment of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account to include participant rollover contributions or non-recurring partial payments over a specified period.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Administrative Expenses

During 2024 and 2023, administrative and loan fees payable to the Trustee of the investments were paid by the Plan and all other expenses related to the administration of the Plan were absorbed by the Company.

NOTE 2 • SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the modified cash basis of accounting. The modified cash basis of accounting differs from accounting principles generally accepted in the United States of America in that contributions from the Company are recorded when received and administrative expenses are recorded when disbursed.

Significant Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates. Significant estimates include the fair value measurement of investments. It is at least reasonably possible that the fair market value measurement of investments will change within the next year.

Employee and Employer Contributions

Employee and employer contributions are recognized as additions to net assets when received.

Investment Valuation and Income Recognition

Investments are reported at fair value and any unrealized appreciation or depreciation for the year is reflected in the statements of changes in net assets available for benefits - modified cash basis. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for a discussion of fair

value measurements. Purchases and sales of investments are recorded on a trade-date basis. Interest income and dividends are recorded when received.

Notes Receivable from Participants

Participant loans are measured at their unpaid principal balance, plus any accrued, but unpaid interest. Delinquent loans are treated as distributions based upon the terms of the Plan document.

Concentration of Market Risk

The Plan assets include a significant amount of registered investment companies, which invest primarily in marketable equity securities and fixed income securities. Accordingly, the performance of the investments is dependent on the equity and debt securities markets which involve price volatility. Additionally, the registered investment companies may invest in securities with contractual cash flows, such as asset backed securities, collateralized mortgage obligations and commercial mortgage-backed securities, including securities backed by subprime mortgage loans. The value, liquidity and related income of these securities are sensitive to changes in economic conditions, including real estate value, delinquencies or defaults, or both, and may be adversely affected by shifts in the market's perception of the issuers and changes in interest rates.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Subsequent events were evaluated by the Plan through October 13, 2025, which is the date the financial statements were available to be issued.

In August 2025, the board of directors of the Plan Sponsor authorized the appointment of a new trustee for the Plan. Effective September 1, 2025, the trustee transitioned from Ascensus Trust Company to BankPlus.

NOTE 3 • INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE

Pursuant to the provisions of 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan's independent accountants did not perform any auditing procedures with respect to the information certified by Ascensus Trust Company, the Trustee, except for comparing the information to the related financial statements and

All information included in the financial statements and the accompanying notes and supplemental schedules relating to cash and cash equivalents, investments, participant loans, appreciation and depreciation of investments and interest and dividends was obtained from the Custodian's certifications and are unaudited.

NOTE 4 • FAIR VALUE MEASUREMENTS

Accounting Standards Codification Topic 820, Fair Value Measurements, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurement) and the lowest priority to unobservable inputs (Level 3 measurement). The three levels of the fair value hierarchy are described as follows:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods may produce a fair value calculation that may not be indicative of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 7 • INCOME TAX STATUS

The Plan adopted a non-standardized form of a prototype plan sponsored by Ascensus, LLC. The prototype plan has received an opinion letter from the Internal Revenue Service, dated January 1, 2018, as to the prototype plan's qualified status. The Plan Administrator believes the Plan is designed and is being operated in compliance with the applicable provisions of the Internal Revenue Code.

There were no uncertain tax positions identified related to the current year and the Plan has no unrecognized tax benefits at December 31, 2024 and 2023, for which liabilities have been established. The Plan recognizes interest and penalties, if any, related to unrecognized tax benefits as a component of income tax expense.

NOTE 8 • NON-EXEMPT TRANSACTIONS AND OTHER NONCOMPLIANCE

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets, but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer. While the Plan remitted all employee contributions to the Plan, contributions of \$58,031

and \$47,110 were not remitted within the required time period for the years ended December 31, 2024 and 2023, respectively. The Plan has corrected the 2023 matter through the Voluntary Fiduciary Correction Program and made the participant accounts whole for the contributions in 2023.

For the year ended December 31, 2024 and 2023, there were three and two instances, respectively, in which the Plan Sponsor withheld funds from participants' paychecks for loan repayments that were not credited to the participant's loan balances. For the year ended December 31, 2024 and 2023, these amounts totaled \$169 and \$137, respectively. The Plan is in the process of correcting the matters through the Voluntary Fiduciary Correction Program.

NOTE 9 • SECURE 2.0 ACT

On December 29, 2022, the Securing a Strong Retirement Act of 2022 ("SECURE 2.0") was signed into law. Secure 2.0 has key effective dates which vary by provision. The plan has adopted and implemented all mandatory provisions to date with other provisions to be phased in over the next few years in accordance with applicable law and IRS guidance. Written amendments to the Plan to reflect these operational changes will be adopted at a later date.
