## 1. Description of Plan

The following description of the Savings Plan for Employees of Alice Hyde Medical Center (the "Plan") provides only general information. Participants should refer to the Plan Adoption Agreement for a more complete description of the Plan's provisions.

### *(a) General*

The Plan is a defined contribution 401(k) plan covering eligible employees of Alice Hyde Medical Center (the "Plan Sponsor") who have reached the age of 18. The Plan Administrator is responsible for the Plan. The Investment Review Committee determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Board of Directors. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

### *(b) Contributions*

Participants may elect to defer a specified percentage of gross wages subject to Internal Revenue Code (IRC) limitations. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants direct the investment of all contributions into various investment options offered by the Plan.

For the purpose of employer matching contributions, the participant must complete one year of service, defined as 1,000 hours. The discretionary match on employee deferral contributions is based on years of plan participation and age as follows:

- 0% match if the employee has not been employed at least one year, is not contributing at least 1% and hasn't met a minimum of 832 hours.
- 3% match once the employee reaches 832 hours worked, has been employed for at least one year and employee is contributing at least 1%.
- 3.5% match if the employee has participated in the Plan for 15 years and is contributing at least 2%; match will remain at 3.5% until employee reaches age 55.
- 5% match if the employee has participated in the Plan for 15 years, is contributing at least 3% and is 55 years old; employee will receive the 5% match for one year.
- 6% match if the employee has participated in the Plan for 10 years, is contributing at least 3% and is 56 years old.

The Plan Sponsor may also make non-elective contributions to the Plan. No discretionary non-elective contributions were made by the Plan Sponsor during the years ended December 31, 2024 and 2023.

### Description of Plan (continued)

#### *(c) Participant Accounts*

Each participant's account is credited with the participant's contributions and allocations of (a) the Plan Sponsor's contributions (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participants' earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### *(d) Vesting*

Participants are vested immediately in voluntary contributions and earnings thereon. Vesting in all Plan Sponsor contributions is based on years of service as follows:

1	33%
2	67%
3	100%

#### *(e) Notes Receivable from Participants*

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates determined by the Plan Administrator and commensurate with local prevailing rates. Participants make principal and interest payments directly through Fidelity Management Trust Company rather than through regular payroll deductions.

#### *(f) Payments of Benefits*

Upon termination due to death, disability or retirement, a participant may elect to receive either a lump-sum distribution or various annuity options. The benefits paid are the vested balance of the participant's account. The Plan allows participants to receive benefits in cases of hardships.

#### *(g) Forfeited Accounts*

Forfeitures are used to reduce the amount of future employer contributions. The Plan used forfeitures of \$0 and \$69,960, respectively, to reduce employer contributions during the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, there was \$10,540 and \$4,579, respectively, in forfeited nonvested accounts.

### 2. Summary of Accounting Policies

#### *(a) Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis in accordance with accounting principles generally accepted in the United States of America.

#### *(b) Use of Estimates*

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### *(c) Risks and Uncertainties*

The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

#### *(d) Investment Valuation and Income Recognition*

Investments are held and maintained by the Plan Custodian. Investments are reported at their respective quoted fair values in active markets. Investment contracts held by a defined contribution plan are required to be reported at fair value. However, contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

#### *(e) Notes Receivable from Participants*

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as distributions on the basis of the terms of the Plan Adoption Agreement.

#### *(f) Payment of Benefits*

Benefits are recorded when paid.

#### *(g) Administrative Expenses*

Certain expenses incurred maintaining the Plan are paid directly by the Plan Sponsor. Investment-related expenses are included in net appreciation (depreciation) in fair value of investments. The majority of administrative expense paid by the Plan were participant and recordkeeping fees.

#### *(h) Subsequent Events*

The Plan evaluated subsequent events through September 30, 2025 the date the Plan's financial statements were available to be issued.

### 3. Fair Value Measurements

Accounting principles generally accepted in the United States of America establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 Measurements) and lowest priority to unobservable inputs (Level 3 Measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

- Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.
- Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:
- Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

- Level 3: Inputs that are unobservable inputs for the asset or liability.

### Fair Value Measurements (continued)

The following is a description of the valuation methodologies used for assets measured at fair value as of December 31, 2024 and 2023.

*Mutual funds:* Fair value is determined at the closing price reported on the active market on which the individual securities are traded.

Within the fair value hierarchy, the Plan's investments that are measured at fair value on a recurring basis on Level 1 as of December 31, 2024 and 2023 are \$53,538,381 and \$46,998,348, respectively.

#### 4. Investment Contract

The Plan has entered into a fully benefit-responsive guaranteed investment contract. The separate accounts are stated at contract value based on the quoted market prices of the underlying assets. The unit value of the investment is equal to the value of the assets in the fund at the end of the day. The unit value of the separate accounts is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. Each time amounts are added to the separate account the contract is credited with the number of investment units ("contract units") equal in value to the amounts added.

The contract guarantees principal and accrued interest, based on credited interest rates, for participant-initiated withdrawals as long as the contract remains active. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio. The contract is included in the financial statements at contract value. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. Furthermore, certain events would allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value.

Examples of such events include (a) an uncured breach of the Plan's investment guidelines, (b) a material amendment to the contract without the issuer's consent, (c) a violation of a material obligation under the contract, (d) a material misrepresentation. The Plan

Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

### 5. Party-In-Interest Transactions

The Plan has a number of service providers. Such parties are considered parties-in-interest under ERISA.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of the Plan's termination, the participants would become 100% vested in their accounts. Additionally, the Plan may amend at any time without the consent of any participant or any beneficiary, provided that no amendment deprives any participant of the participant's non-forfeitable accrued benefits.

### 7. Tax Status

The Plan has not obtained a determination letter. The Plan is required to operate in conformity with applicable requirements of the IRC. The Plan Administrator believes that the Plan is currently designed and is being operated in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken uncertain tax positions that more likely than not would not be sustained upon examination by the Internal Revenue Service (IRS). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by the IRS; however, there are currently no audits for any tax periods in process. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

### 8. Information Certified by the Custodian

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the schedule of assets held for investments purposes as of December 31, 2024 and the related investment activity reflected in the statements of change in net assets available for benefits for the years ended December 31, 2024 and 2023.
