NOTE 1 - DESCRIPTION OF PLAN

The following description of the DLZ Corporation Employee Stock Ownership and 401(k) Plan (the "Plan") provides only general information. Plan participants should refer to the Plan document or Summary Plan Description for a more complete description of the Plan's provisions, which are available from the Plan administrator.

General

The Plan is a defined contribution plan that includes an Employee Stock Ownership Plan (ESOP) covering substantially all full-time employees of DLZ Corporation and Subsidiaries (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Amendments

Effective January 1, 2023, the Plan was amended and restated in its entirety to reflect the following changes to the Plan:

- Allowing an ESOP stock conversion effective December 31, 2023, in which 100% of the Company stock in the ESOP account of each participant whose employment with the Company terminated on or before November 30, 2021, is converted to cash and held in the participant's cash account.
- Providing that no additional employees of the Company are eligible to participate in the ESOP portion of the Plan on or after January 1, 2023.
- Interns are excluded from the Plan effective January 1, 2023.
- Increasing the mandatory cash-out amount from \$5,000 to \$7,000 as permitted by SECURE 2.0 (effective January 1, 2024).
- Increasing the maximum default automatic contribution percentage under the Plan from 10% to 15%.
- Allowing the recontribution of hardship withdrawals related to federally declared disasters as permitted by SECURE 2.0 (effective January 1, 2024).

Eligibility

Employees are eligible to participate in the 401(k) portion of the Plan on the first day of the month following their date of hire. Participation in the ESOP requires an individual to complete one year of service defined as a 12-month period in which an employee works at least 1,000 hours.

Contributions

Each year, participants may contribute pre or after-tax contributions up to 50% of their annual eligible compensation as pre-tax, Roth, or after-tax contributions, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants who have attained age 50 prior to the end of the Plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. The automatic deferral percentage will increase by 1% per year up to a maximum of 10% of eligible compensation.

Contributions (Continued)

Company contributions are discretionary and consist of a match contribution. The Plan also allows for a profit-sharing contribution made at the discretion of the Board of Directors. The matching contributions are based upon a percentage of each participant's salary deferral that is contributed to the Plan. For the year ended December 31, 2024, the Company matched 50% of up to 6% of compensation contributed by each participant totaling \$2,033,884. During the year ended December 31, 2024, the Company made a \$1,466,751 contribution to the Plan. Contributions are subject to certain Internal Revenue Code ("IRC") limitations.

Forfeitures

Forfeited balances from terminated participants' nonvested accounts are re-allocated annually to the remaining Plan participants in the ratio each participants compensation bears to the total compensation of all participants. For the year ended December 31, 2024, \$303,660 of forfeitures were used to reduce employer profit sharing contributions and \$31,434 of ESOP forfeitures were re-allocated to Plan participants. Amounts available for future use as of December 31, 2024 and 2023, were \$64,324 and \$248,339, respectively.

Participant Investment Account Options

The Plan currently offers various mutual funds, common collective trusts, and money market and similar funds as investment options for participants. Each investment option has its own investment strategy, which can be obtained through the prospectus of the respective fund. Participants may change their investment options at any time.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Company matching contributions, as well as profit sharing contribution and (b) plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee may vote as directed by the Plan committee if no direction is received from the participant. The trustee is required, however, to vote any unallocated shares on behalf of the collective best interest of Plan participants and beneficiaries.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's portion of their accounts, plus actual earnings, is based on years of continuous service as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the plan administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

For the 401(k) portion of the Plan, a participant may elect to receive a single lump sum or a series of installments equal to the value of his or her account upon termination of service, death, or disability. A participant may also request in-service or hardship distributions if the requirements are met.

Payment of the ESOP account will either be paid as a single lump sum or installments over a period of time up to five years. A single lump sum will be paid to a terminated participant if their account balance is \$5,000 or less on the date of distribution. If the vested balance of the participant's account is greater than \$5,000 on the date of distribution, then the account will be distributed in five annual installments. Distributions due to conflict of interest or death will be paid in a single lump sum.

Diversification

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company stock into investments which are more diversified. Participants who are at least age 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of their shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The Plan's financial statements are prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates. The fair value of DLZ Corporation preferred stock is particularly subject to change in the near term.

Investments Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 8 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of the Plan are paid by the Company and are not included in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

NOTE 3 - INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Vanguard Fiduciary Trust Company, the trustee of the Plan, has certified that the following data included in the accompanying financial statements and supplemental schedule are complete and accurate with respect to investments:

NOTE 5 - PARTY-IN-INTEREST TRANSACTIONS

Certain Plan assets are investments sponsored by Vanguard Fiduciary Trust Company, the Plan's trustee. Other assets are invested in the stock of DLZ Corporation, the Plan sponsor. Transactions in these investments qualify as exempt party-in-interest transactions.

The Company provides certain accounting, administrative, and investment management services to the Plan for which it receives no compensation.

NOTE 6 - PLAN EXPENSES

Administrative expenses paid from the Plan represent recordkeeping and administrative fees which amounted to \$50,335 for the year ended December 31, 2024.

NOTE 7 - TAX STATUS

The Internal Revenue Service (“IRS”) has determined and informed the Company by letter dated February 8, 2018, that the Plan and the related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 8 - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (ASU) Topic 820 are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets; quoted prices for identical or similar assets and liabilities in inactive markets; inputs other than quoted market prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, then the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 - Inputs to the valuation methodology are unobservable and significant to measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily Net Asset Value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

DLZ Corporation preferred stock: Valued at fair value as determined by a third-party independent appraiser, which has been reviewed and approved by the Plan trustee and management.

Common collective trust: Valued at the NAV of the units of the Vanguard Fiduciary Trust Company collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

During the year ended December 31, 2024, \$414,413 of Level 3 assets were sold.

NOTE 9 - PLAN TERMINATION

Although they have not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their account balances.

NOTE 10 - RISKS, UNCERTAINTIES, AND CONCENTRATIONS

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. During the years ended December 31, 2024 and 2023, approximately 16% and 17% of the Plan's investments were invested in the Vanguard U.S. Growth Admiral Shares Fund, respectively. Additionally, during the year ended December 31, 2024, approximately 16% of the Plan's investments were invested in DLZ Corporation preferred stock.

NOTE 11 - NON-EXEMPT TRANSACTIONS

Defined contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonably segregated from the employer's general assets but no later than the 15th business day of the month following the month in which the participant contributions are withheld by the employer.

Contributions amounting to \$229 were not remitted timely to the trust during the year ended December 31, 2024. Corrections for the year ended December 31, 2024, were pending as of the date the audit report was available to be issued.

NOTE 12 - SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 13, 2025, which is the date the financial statements were available to be issued. No significant matters were identified for disclosure during this evaluation.
