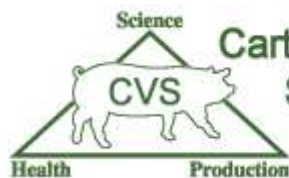

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Carthage Veterinary Service, Ltd. Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Carthage Veterinary Service, Ltd. Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

**NOTE A | DESCRIPTION OF THE PLAN**

The following description of the Carthage Veterinary Service, Ltd. Profit Sharing Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

*1. General*

The Plan is a defined contribution 401(k) and profit sharing plan covering all non-excluded employees of Carthage Veterinary Service, LTD., Carthage Innovative Swine Solutions, LLC, Professional Swine Management, LLC, Hancock Veterinary Clinic, LLC and Carthage System, LLC (the Company) who complete at least three months of service and are age 21 or older. The Plan was adopted and began operations on September 30, 1980. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees of the Plan control and manage the operation and administration of the Plan. Bank of America, N.A. serves as the trustee of Plan assets. On December 15, 2020, the Plan was amended to change the year end to a calendar year end effective December 31, 2020. Effective October 1, 2021, the Plan was restated to be in compliance with the requirements of the 2017 Cumulative List. Effective October 10, 2022, the Plan was amended to change the eligibility conditions to the attainment of age 21 and completion of three months of service.

*2. Contributions*

Three types of contributions can be made to the Plan.

Deferral Contributions - Each year, participants may contribute up to 100% of their pre-tax or post-tax (Roth) annual compensation as defined in the plan document, subject to Internal Revenue Code annual limitations. The maximum deferral in 2024 and 2023 is the lesser of 100% of compensation or \$ 23,000 and \$ 22,500, respectively. In 2024 and 2023, participants who will be at least 50 years old by the end of the year may make an additional "catch-up" contribution of up to \$ 7,500.

Safe Harbor Employer Matching Contributions - The Company makes a safe harbor contribution equal to 100% of each participant's elective deferral contributions, up to 3% of the participant's Plan compensation for the Plan year, plus 50% of the amount of the participant's elective deferral contributions that exceed 3% of Plan Compensation, but that do not exceed 5% of the participant's Plan compensation. By law, the Plan cannot recognize compensation in excess of \$ 345,000 in calendar year 2024 in calculating the safe harbor contribution.

**NOTE A | DESCRIPTION OF THE PLAN**

*2. Contributions*

Profit Sharing Contributions - The Company can, at its discretion, elect to contribute to the Plan on behalf of each participant for the Plan year. Employees who have completed 1,000 hours of service during a Plan year and are employed on the last day of the Plan year are eligible for discretionary employer contributions. Discretionary profit sharing contributions totaling \$ 737,523 were made for the year ended December 31, 2024, and are included in Employer contribution receivables on the statement of net assets available for benefits. Contributions are subject to certain Internal Revenue Code limitations.

The Plan also allows rollover contributions.

*3. Participant Accounts*

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's safe harbor contribution, the profit sharing contribution, and allocations of Plan earnings and losses and administrative expenses. Allocations are based on participant earnings, contributions or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

*4. Vesting*

Participants are vested immediately in their deferral contributions and safe harbor employer contributions plus actual earnings thereon. Participants become 100% vested in profit sharing contributions after completing three years of service.

*5. Payment of Benefits*

On termination of service due to death, disability, retirement, or other reasons, a participant generally receives a lump-sum payment of his or her vested accrued benefit when requested. Account balances of terminated participants are to be distributed as soon as administratively feasible upon severance of employment. Participant consent is not required for distribution of account balances less than \$ 5,000. The Plan also allows in-service distributions for participants upon reaching the age 59 ½.

*6. Forfeitures*

The non-vested portion of discretionary employer contributions for all terminated employees is used to pay additional administrative expenses of the Plan and any remaining forfeitures are allocated to participants eligible to share in the discretionary employer contributions. Forfeited non-vested accounts totaled \$ 17,219 and \$ 4,667 at December 31, 2024 and 2023, respectively. Forfeitures totaling \$ 2,286 were used to pay administrative expenses of the Plan during the year ended December 31, 2024.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

*1. Basis of Accounting*

The accompanying financial statements have been prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

*2. Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

*3. Investment Valuation and Income Recognition*

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian and trustee. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**NOTE B | SUMMARY OF ACCOUNTING POLICIES**

4. *Payment of Benefits*

Benefits are recorded when paid.

5. *Expenses*

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Any additional administrative expenses of the Plan are paid by the Plan participants, as provided in the Plan document. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

6. *Subsequent Events*

Management has evaluated subsequent events for recognition and disclosure in the financial statements through October 10, 2025, which is the date the financial statements were available to be issued. Through October 10, 2025, no subsequent events required recognition or disclosure in the financial statements.

**NOTE D | FAIR VALUE MEASUREMENTS**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Investments in mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the SEC. The funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Self-directed accounts consist of mutual funds, common stocks, certificate of deposit, and cash and cash equivalents. Fair values of self-directed accounts have been determined by the trustee from observable market quotations for both actively and inactively traded markets, when available.

The Plan invests in a collective trust, which is valued at the NAV of units of the collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. This practical expedient is not used when it is determined to be probable that the Plan will sell the investment for an amount different than the reported NAV.

**NOTE E | INVESTMENTS IN ENTITIES THAT CALCULATE NET ASSET VALUE PER SHARE**

As part of the Plan’s investment portfolio, there are investments made in entities in which purchases and withdrawals are not made in an open market. Instead, the purchases and withdrawals occur with the entity, and in certain circumstances, those transactions are entirely controlled and/or restricted by the entity. **NOTE F | TAX STATUS**

The Plan is qualified under Section 401(a) and tax exempt under Section 501(a) of the Internal Revenue Code. The Plan is a non-standardized pre-approved profit sharing money purchase plan with CODA and obtained its last approval letter, dated June 30, 2020, in which the Internal Revenue Service stated that the Plan was in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been restated since receiving the determination letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable provisions of the Internal Revenue Code and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE G | PLAN TERMINATION**

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE H | RELATED-PARTY TRANSACTIONS**

Certain Plan investments are managed by Bank of America, N.A. Bank of America, N.A. is the recordkeeper for the Plan and, therefore, these transactions qualify as party-in-interest transactions.

Bank of America, N.A. receives revenue from mutual fund service providers. This revenue is used to offset certain amounts owed for administrative services provided to the Plan. If the revenue received by Bank of America, N.A. from mutual fund service providers exceeds the amount owed under the Plan Agreement, Bank of America, N.A. remits the excess to the Plan's trust on a quarterly basis. Such amounts were applied to pay Plan administrative expenses or allocated to the accounts of the participants. During 2024, there were no funds allocated to the Plan's administrative expenses. At December 31, 2024 and 2023, the balance of the Plan's credit account was \$ 199 and \$ 193, respectively.

**NOTE I | RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near-term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
