NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of Exceptional Family Resources 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Exceptional Family Resources, Inc. d/b/a Exceptional Family Resources (the Organization). It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance. Reliance Trust Company is the custodian and Transamerica Retirement Solutions, LLC is the recordkeeper for the years ended December 31, 2024 and 2023.

Eligibility

Full time employees working forty hours per week of the Organization become eligible to participate immediately upon employment. Direct service providers must work 1,000 to become eligible to participate in the Plan.

Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan up to Internal Revenue Code (IRC) limits. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan provides for matching contributions by the Organization equal to eligible participant's elective deferrals up to a maximum of 4% of eligible compensation. Contributions are subject to certain statutory limitations.

Eligible Compensation

Compensation is defined as wages within the meaning of IRC Section 3401(a) and all other payments of compensation for which the employer is required to furnish the employee a written statement under IRC Sections 6041(d), 6051(a)(3), and 6052.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) the Organization's matching contribution and, (b) Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their contributions, the Organization's contributions, and actual earnings/losses thereon.

Payment of Benefits

Upon termination of service due to death, disability, retirement or other reasons, a participant may elect to receive their vested benefit in a single lump sum payment or have the payment paid as a direct rollover to an individual retirement account. All account balances less than \$5,000 are automatically paid out in a lump sum.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from a participant's voluntary contributions account. All hardship withdrawals must comply with Internal Revenue Service rules relating to hardships, which are uniformly applicable to all participants.

Expenses

Certain expenses of maintaining the Plan are paid by the Organization and are therefore excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year. All investments are participant directed.

Risk and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, currency and credit risks. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the value of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying financial statements.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement

GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements).

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of unobservable inputs and minimize the use of unobservable inputs.

Registered investment companies are valued using quoted market prices. The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no changes to the valuation techniques during 2024 or 2023.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Substantially all administrative expenses associated with the Plan are paid by participants.

4. STABLE VALUE FUND

The Plan is invested in a fully benefit-responsive investment contract with Transamerica Financial Life Insurance Company. Transamerica Financial Life Insurance Company maintains the contributions in a general account. The account is credited with earnings on the credited interest rate and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The interest rate was at an average of 2.05% during 2024.

As described in Note 2, because the stable value fund is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. The stable value fund is not considered a guaranteed interest contract and there is no stated minimum or maximum interest rate. Contract charges may reduce the return. Prior to January 1st and July 1st, the effective annual rate of interest is established for the corresponding six-month period. Although plan participants generally may withdraw assets from the stable value fund without restrictions, Transamerica Financial Life Insurance Company may impose a hold period at the contract level in the event of a full contract discontinuance or partial contract discontinuance. The Plan Administrator does not believe that any events that would limit the Plan's ability to transact at contract value with the Plan participants are probable of occurring. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

6. PARTY-IN-INTEREST TRANSACTIONS

Reliance Trust Company is the trustee as defined by the Plan and, therefore, transactions between Reliance Trust Company and the Plan qualify as party-in-interest transactions. Transamerica Retirement Solutions LLC (Transamerica) is the recordkeeper for the Plan and, therefore, transactions between Transamerica and the Plan qualify as party-in-interest transactions.

7. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

8. TAX STATUS

The IRS has determined and informed by letter for the prototype plan adopted by the Plan, dated March 31, 2014, that the prototype plan is designed in accordance with applicable sections of the IRC. The Plan has not requested its own determination letter from the IRS. The Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC. Therefore, no provisions for income taxes have been included in the Plan's financial statements.

9. RECONCILIATION TO FORM 5500

Certain items have been classified differently between the financial statements and Form 5500. Net assets available for benefits and changes in net assets available for benefits per the financial statements agree to Form 5500 in total as of and for the years ended December 31, 2024 and 2023.

10. SUBSEQUENT EVENTS

Effective January 1, 2025, the Plan merged with the ARISE Child & Family Services, Inc. Profit Sharing 401(k) Plan (the "Merging Plan"). As a result of the merger, all assets, liabilities, and participant account balances of the Merging Plan were transferred to and became part of the Plan. The transfer of assets was completed on August 19, 2025.

Following the merger, ARISE Child & Family Services, Inc. and ARISE at Marshall Farms, Inc. became participating employers under the Plan. The merger was approved by the Boards of Directors of both organizations in December 2024 and was executed in accordance with the Participating Employer Addendum and related plan documents.

Subsequent events have been evaluated through October 13, 2025, which is the date the financial statements were available to be issued.
