To the Plan Sponsor and Plan Participants
of the Key Environmental Inc. 401(k) Profit Sharing Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Key Environmental Inc. 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTE A - DESCRIPTION OF PLAN

The following description of the Key Environmental Inc. (the "Company") 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a multiple employer defined contribution plan covering voluntarily enrolled employees of several participating companies (including a controlled group of corporations) representing the plan sponsor, consisting of Key Environmental Inc., Field and Technical Services LLC, KE Engineering Services PC, FTS Construction LLC, and C&S Realty Ventures LP. See Note G regarding RPG Resources LLC, who terminated their participant in the plan effective April 1, 2023. Eligibility begins the first day of the month coinciding with or next following the date of hire. The Plan is a safe harbor 401(k) plan and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

On December 29, 2022, President Biden signed into law the Consolidated Appropriations Act of 2023, which includes the package of retirement provisions referred to as "SECURE 2.0". These provisions continue the themes and reforms that began with the 2019 SECURE Act, focusing on getting more participants into the retirement system, finding ways for them to accumulate more assets, and then ensuring they get connected with those assets when retirement comes.

Many of the provisions of the SECURE 2.0 are effective on January 1, 2023, and beyond and will require significant changes to plan administration and recordkeeping.

Contributions

The Plan allows participants to make elective pretax contributions of 1% to a maximum of 100% salary reduction subject to the Internal Revenue Code (IRC) limits. Maximum allowed deferral amounts were \$23,000 for 2024 and \$22,500 for 2023. The Plan permits participants age 50 and older to make "catch-up" contributions to the Plan (\$7,500 for 2024 and 2023). Participants may also contribute qualified rollover contributions representing distributions from other qualified plans. The Company uses a two rate safe harbor contribution matching formula. The Company contributes a matching contribution equal to the employee deferral up to 3% of compensation as defined by the Plan, plus 50% of the amount of employee contributions that are over 3% but do not exceed 5% of compensation. Effective June 1, 2023, the Company amended the Plan to add a Roth contribution feature. Upon determination of participants' contributions, the Company contributions are made to the trustee in cash. The contributed cash is allocated to individual employee accounts and invested at the participants' direction.

The Company may make discretionary matching contributions determined annually based on the participant's pretax contributions. Additionally, discretionary profit sharing amounts may be contributed at the option of each Company's board of directors. The Company's discretionary profit sharing contribution is allocated to the account of each participant who has completed at least 1,000 hours of service during the Plan year and is employed on the last day of the year, and is based upon a percentage of the participant's annual eligible compensation to total eligible compensation. There were no discretionary employer matching or profit sharing contributions for either the year ending December 31, 2024 or 2023. All contributions are subject to the limitations of the IRC.

Contributions (Continued)

Participants direct the investments of their elective contributions as well as matching and profit sharing contributions made to the Plan on their behalf into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contribution and an allocation of the Company's contribution and Plan earnings (losses), and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. Participant accounts are participant directed. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. A participant is also 100% vested in all Company fixed safe harbor matching contributions. Vesting in the Company's discretionary contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Notes Receivable from Participants

Participants may borrow from their investment accounts a minimum loan of \$1,000 up to a maximum of \$50,000 or 50% of their account balance, whichever is less. One outstanding loan is permissible at a time. The notes are secured by the balance in the participant's account and bear interest at a rate equal to 1% above the prime rate and fixed for the duration of the loan, generally not to exceed 5 years. Principal and interest are paid ratably through bi-weekly payroll deductions.

Payments of Benefits

On termination of service, a participant whose balance exceeds \$7,000 may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or in installments only with respect to minimum required distributions, over a period not exceeding the assumed life expectancy of the participant. Balances not exceeding \$7,000 may only be distributed in a single lump sum payment and are distributed regardless of participant consent (with a rollover in absentia).

Other Withdrawals

The plan permits hardship distributions for currently employed participants from the following accounts provided the account is 100% vested: pre-tax elective and Roth deferrals (and earnings thereon), rollover accounts, and qualified employer contributions including any safe harbor contributions in accordance with Plan provisions. During 2024 and 2023, the Plan paid cash hardship distributions of \$0 and \$127,000, respectively.

Other Withdrawals (Continued)

In-service distributions may be made from accounts which are fully vested and are available for those participants who have not been separated from service and have satisfied the 59 1/2 year age requirement.

Forfeited Accounts

Forfeited nonvested accounts are used to reduce future employer contributions or cover future Plan expenses. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$0. Forfeitures used for each of the years ended December 31, 2024 and 2023 totaled \$962 and \$7,227, respectively.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of certain assets and liabilities and changes therein, and disclosures. Accordingly, actual results may differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document. Deemed distributions of participant loans totaled \$4,702 and \$62,129 for the years ended December 31, 2024 and 2023, respectively.

Investment Valuation and Income Recognition

Investments are reported at fair value, except the fully benefit-responsive group annuity contract, which is reported at contract value.

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note D for discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Contract value is the relevant measure for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or net depreciation in fair value of investments include the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses of the Plan are paid by the Plan through revenue sharing, as provided in the Plan document. Management fees and operating expenses charged to the Plan are deducted from income earned on a daily basis and are not separately reflected, but rather included in net appreciation (depreciation) of fair value of investments. Fees related to the administration of certain participant-initiated transactions are charged directly to the participant's account.

NOTE C - CERTIFIED INVESTMENTS (UNAUDITED)

The Plan's investments were held in trust and administered by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the Custodians of the Plan. Information related to investments and notes receivables from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including all investments and notes receivables from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivables from participants for the years then ended was obtained by management and agreed to or derived from information certified as complete and accurate by the Custodians.

NOTE D - FAIR VALUE MEASUREMENTS

Certain investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs were used only when Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented and there were no changes in the methods used to measure fair value at December 31, 2024 and 2023.

The valuation methodologies used for assets measured at fair value are as follows:

Mutual Funds

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The mutual funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are considered to be actively traded.

Gains and losses included in changes in net assets available for benefits for the years ended December 31, 2024 and 2023, are reported in net appreciation (depreciation) in fair value of investments.

The Plan's policy is to recognize transfers between Level 1 and Level 2 and into and out of Level 3 as of the date of the event or change in circumstances that caused the transfer. For the years ended December 31, 2024 and 2023 there were no significant transfers between Level 1 and 2 and no transfers into or out of Level 3.

NOTE E - GROUP ANNUITY CONTRACT

The Plan has a group annuity contract with Empower Annuity Insurance Company of America that invests contributions in the Key Guaranteed Portfolio Fund. The Key Guaranteed Portfolio Fund is a general account product. The methodology for calculating the interest crediting rate is based on the earnings of the underlying assets in the entire medium long-term new portfolio compared to the minimum interest crediting rate, as stated in the contract, and prevailing market conditions. The interest crediting rate is reset quarterly. At December 31, 2024 and 2023, the average interest earned by the Plan was 1.41% and 1.23%, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. At December 31, 2024 and 2023, the Key Guaranteed Portfolio Fund's fair value equaled its contract value. As described in Note B, contract value is the relevant measurement attribute for this Fund.

Certain events limit the Plan's ability to transact at contract value with the issuer. Such events include premature termination of the contracts by the Plan, plant closings, layoffs, Plan termination, bankruptcy, mergers, or early retirement incentives. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants or the issuer are probable of occurring. The insurance company may not terminate the contract at any amount less than the contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the group annuity contract at December 31, 2024 and 2023 was \$577,890 and \$1,201,151, respectively.

NOTE F - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The group annuity contract and certain other investments are managed by Empower Annuity Insurance Company of America. Empower Annuity Insurance Company of America is a Plan custodian.

Transactions in the Funds qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE G - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Partial Plan Termination

A former participating employer, RPG Resources LLC, was acquired by an outside entity on April 1, 2023. The acquiring entity requested a termination from the Key Environmental, Inc. 401(k) Profit Sharing Plan effective as of that date. The participating employer terminated their participation in the Plan with a terminating resolution. The event triggered a partial plan termination as of April 1, 2023, and all affected participants became immediately 100% vested in their accounts

as of this date with a terminated employee status. The deconversion of plan assets to a successor plan occurred timely thereafter and each terminated participant stipulated their intentions to either 1) remain in the Plan for accounts over \$5,000, 2) take a distribution of their account, or 3) transfer their balances to the successor plan of the acquiring employer. Participants with notes receivable balances were given the option to transfer their loans to the successor plan or to treat the loan balance as a taxable distribution. Those terminated participants with balances less than \$5,000 after the deconversion date who had not made a selection as to treatment of their accounts were forced out according to the Plan document. This threshold was increased to \$7,000 for 2024.

NOTE H - INCOME TAX STATUS

The Company has adopted a Volume Submitter Profit Sharing with CODA standardized plan pre-approved by the Internal Revenue Service (IRS). The IRS issued an opinion letter dated June 30, 2020, stating that the standardized plan is acceptable with the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the opinion letter, the Company and Plan administrator believe that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC, and the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE I - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE J - SUBSEQUENT EVENTS

Date of Management's Review

Management has evaluated subsequent events through October 13, 2025, the date on which the financial statements were available to be issued.

Effective September 16, 2025, the Plan approved certain changes to the plan regarding how the expenses of the plan are paid. Fee levelization was adopted in an effort to improve 401(k) fee transparency and lower fund expenses. In addition, zero revenue sharing funds were added and an updated investment lineup to support the new fee structure was introduced.
