Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

***Other Matter – Supplemental Schedule Required by ERISA***

The supplemental schedule listed in the table of contents is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

- The form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.
- The information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

**Note 1. Description of the Plan**

The following brief description of the Harrison Profit Sharing and Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document and *Summary Plan Description* for more complete information.

**General**

The Plan was established in 1950 by the Harrison Steel Castings Company of Attica, Indiana (the Company) for the benefit of its employees. The Plan is a defined-contribution profit-sharing plan. The Plan is subject to the *Employee Retirement Income Security Act of 1974* (ERISA).

The trustee of the Plan is Ascensus Trust Company (Ascensus) and the recordkeeper of the Plan is The Vanguard Group, Inc. (Vanguard). The Plan operates under a prototype adoption agreement sponsored by Ascensus, Inc. The Plan allows for employees to be eligible for employee contributions upon completion of three consecutive months of service or employer contributions upon completion of one year of service, defined by 1,000 service hours.

**Contributions**

The Plan allows eligible employees through a salary deferral election to have the Company make annual contributions of an amount equal to a dollar amount or percentage of eligible compensation. Employee rollover, Roth and catch-up contributions are also permitted. Company matching contributions will be 100% of the first 3% of participant's elective deferral percentage. Contributions are subject to certain limitations. The Company profit-sharing contributions remain discretionary and determined based on points for those actively employed at year end.

The Plan Document also includes an automatic deferral feature whereby a participant is treated as electing to defer 3% of eligible compensation unless the participant made an affirmative election otherwise. The automatic enrollment percentage will increase 1% per year to a maximum of 10% of eligible compensation.

The Company made a discretionary profit-sharing contribution of \$649,928 and \$429,292 for the Plan years ended December 31, 2024 and 2023.

**Participant Investment Account Options**

Participants have the option of directing all of their contributions into any of the various investment options offered by the Plan and may change the allocation daily.

**Participants Accounts**

Participant accounts are credited with the participant's contribution, the Company's contributions and Plan earnings and are charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting**

Participants are immediately vested in their voluntary contributions. Vesting in the remainder of their accounts is based on years of credited service. A participant is 100% vested after three years of credited service based on their anniversary date.

***Notes Receivable From Participants***

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. The minimum amount of a loan is \$1,000. The maximum amount of a loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the voluntary savings and vested portion of Company contributions. All loans are covered by demand notes and are repayable over a period not to exceed five years through payroll withholdings.

The Plan does not allow more than two loans outstanding at a time and loans cannot be taken from the Roth portion of the account or nonmutual fund investments. Interest rate is prime rate plus 1%.

Notes receivable from participants are reported at the amortized principal balance plus accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan Document.

***Payment of Benefits***

Upon termination of service, participants will receive a lump-sum amount equal to the value of their account. Withdrawals other than for termination are permitted under certain circumstances provided by the Plan. The Plan allows for certain in-service withdrawals from a participant's account.

***Plan Termination***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

***Use of Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets and changes in net assets available for benefits. Actual results could differ from those estimates.

***Valuation of Investments and Income Recognition***

Investments are reported at fair value. Quoted market prices, if available, are used to value investments. Mutual funds were valued at the net asset value (NAV) of shares held by the Plan at year end. Money market funds are valued at costs, which approximate fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

***Plan Tax Status***

The Plan operates under a volume submitter 401(k) profit-sharing Plan adoption agreement in connection with a prototype retirement Plan and custodial document sponsored by Ascensus, Inc. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Plan or the Company, at the Company's discretion.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule of assets (held at end of year) is complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023
- Investment information included in the accompanying schedule of assets (held at year end) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule of assets (held at end of year).

**Note 4. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities

***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There are no Level 2 or Level 3 securities held by the Plan.

**Note 5. Forfeitures**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$56,694 and \$48,263, respectively. These accounts will be used to reduce future Plan expenses. Also, in 2024 and 2023, \$50,792 and \$50,609, respectively, were used to reduce plan expenses.

**Note 6. Transactions With Related Parties and Parties-in-Interest**

Provisions of ERISA require that significant transactions with related parties or parties-in-interest be disclosed. Related parties and parties-in-interest include, among other persons, shareholders and officers of the Company, members of the Advisory Committee, employees of the Company or others who provide accounting or other services to the Plan, companies significantly controlled by any of the above persons or direct relatives of the above persons, and major customers or suppliers of the Company. Significant transactions or relationships with the above persons or entities include:

- (1) Fees for trust services paid by the Plan to the trustee and recordkeepers were \$83,337 and \$66,225 in 2024 and 2023, respectively.
- (2) Individually non-material expenses paid to parties-in-interest aggregated to \$38,549 and \$42,485 in 2024 and 2023, respectively.

**Note 7. Nonexempt Transactions**

Defined-contribution plans are required to remit employee contributions to the Plan as soon as they can be reasonable segregated from the employer's general assets. In 2023, there were \$29,535 of employee contributions and \$19,083 of participant loan repayments which were not remitted in accordance with the DOL remittance policy.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.
