#### **Note 1. Description of the Plan**

The following description of the KSB GIW, Inc. (the “Company”) Pension Plan (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

##### General:

The Plan is a defined benefit plan established effective July 1, 1972, and most recently amended in 2024. For 2008 through December 30, 2009, the Plan covered salaried employees of GIW Industries, Inc. Effective December 31, 2009, the Company merged GIW Industries, Inc. Pension Plan for Hourly Employees into the GIW Industries, Inc. Pension Plan. This merger did not affect participant pension benefits due to the fact that the benefit provisions of both Plans were incorporated into the merged pension plan. Effective December 31, 1994, the Plan benefits were frozen for the GIW Industries, Inc. Pension Plan for Salaried Employees and no further benefits will accrue nor are new participants allowed to enter the Plan after December 31, 1994. Effective July 31, 1996, the Plan benefits were frozen for the GIW Industries, Inc. Pension Plan for Hourly Employees and no further benefits will accrue nor are new participants allowed to enter the Plan after July 31, 1996. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Principal Life Insurance Company (“Principal”) serves as custodian of the Plan.

##### Plan amendment:

Effective March 4, 2024, the Company’s name was changed to KSB GIW, Inc. and an amendment was executed to change the Plan’s name to KSB GIW, Inc. Pension Plan. Additionally, the Plan documents were restated with Principal Life Insurance Company to a pre-approved plan document with an updated determination letter.

##### Pension benefits:

Plan participants are eligible for their plan benefit after when they reach retirement. Normal retirement benefits are available upon attainment of age 65 for salary and hourly participants. Upon termination of employment, participants may elect to receive their pension benefits in the form of a joint and survivor annuity or a life annuity payable monthly upon retirement based on their years of service. Early retirement benefits are available at age 55 with 15 years of credited service. Participants forfeit the right to receive the portion of their accumulated plan benefits if they terminate before rendering 5 years of service.

The Pension Protection Act of 2006 (PPA) as amended by the Worker, Retiree and Employer Recovery Act of 2008 (WRERA) imposes certain benefit restrictions for qualified benefit plans that do not meet certain funding thresholds. The “At-Risk” status is referred to as the Funding Target Attainment Percentage (FTAP). A plan’s funded percentage is referred to as the Adjusted Funding Target Attainment Percentage (AFTAP). The January 1, 2024 AFTAP for the Plan is 127.66%. Because the Plan’s AFTAP equals or exceeds 80%, the Plan is not subject to any benefit restrictions.

#### **Note 1. Description of the Plan, Continued**

##### Death and disability benefits:

If a vested participant dies prior to the date retirement benefits are to commence, the eligible spouse will be entitled to receive a monthly survivor's benefit equal to the amount the eligible spouse would have been entitled to receive in the form of a 50% joint and survivor annuity. If an active participant becomes totally disabled after the completion of 5 years of service and prior to the normal retirement date, the participant shall be entitled to a disability benefit, reduced by public disability benefits, beginning after 6 months of continued disability and ceasing when the participant is no longer considered disabled or reaches the normal retirement date.

##### Contributions:

The Company's funding policy for the Plan is to make annual contributions to the Plan in amounts not less than the minimum funding requirement of ERISA or more than that permitted by the Internal Revenue Code (IRC). For the 2024 and 2023 years, the Company made no contributions. The Plan met the minimum funding requirement for both the 2024 and 2023 Plan years.

##### Vesting:

Participants become 100% vested after the earlier of attainment of age 65 or completion of 5 years of credited service as determined by the years of service in the plan agreement.

#### **Note 2. Summary of Significant Accounting Policies**

##### Basis of accounting:

The financial statements of the Plan are prepared on the accrual basis of accounting.

##### Use of estimates:

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets available for benefits and the actuarial present value of accumulated plan benefits as the date of the financial statements. Actual results could differ from those estimates. The Plan uses an actuary to determine the actuarial present value of accumulated plan benefits. A change in the actuarial assumptions used could significantly change the amount of the actuarial present value of accumulated plan benefits reported in the accompanying financial statements.

##### Investment valuation and income recognition:

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Administrative Committee determines the Plan's valuation policies utilizing information provided by the insurance company. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Note 2. Summary of Significant Accounting Policies, Continued**

#### Payment of benefits:

Benefits are recorded when paid.

#### Expenses:

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of the Plan are recorded by the custodian and included in administrative expenses. These administrative expenses incurred include fiduciary, custodian, investment management actuarial, and other professional service and administrative fees. Certain administrative functions are performed by the employees of the Company. Neither the Company nor the employees of the Company receive compensation from the Plan. In addition, certain investment related expenses are included in net appreciation of fair value investments.

#### Subsequent events:

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

#### Recently issued accounting pronouncements:

Accounting standards that have been issued or proposed by the Financial Accounting Standards Board (FASB) or other standards-setting bodies are not expected to have a material impact on the Plan's financial statements.

### **Note 3. Actuarial Present Value of Accumulated Plan Benefits**

Accumulated plan benefits are those estimated future periodic payments, including lump sum distributions, which are attributable under the Plan's provisions to services rendered by the participants. Accumulated plan benefits include benefits expected to be paid to retired or terminated participants or their beneficiaries, beneficiaries of participants who have died, and present employees or their beneficiaries. Benefits for retired or terminated participants or their beneficiaries are determined according to the Plan, generally based on years of credited service. The accumulated plan benefits for active employees will equal the accumulation, with interest, of the annual benefit accruals as of the benefit information date. Benefits payable under all circumstances – retirement, death, disability, and termination of employment – are included, to the extent they are deemed attributable to employee service rendered to the valuation date. Benefits to be provided via annuity contracts excluded from Plan assets are excluded from accumulated plan benefits. Principal Life Insurance Company, the Plan's independent actuary, estimates the actuarial present value of accumulated plan benefits, which is the amount that results from applying actuarial assumptions to adjust the accumulated plan benefits earned by the participants to reflect the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as for death or withdrawal) between the valuation date and the expected date of payment.

### Note 3. Actuarial Present Value of Accumulated Plan Benefits, Continued

The actuary's estimate of the present value of accumulated plan benefits is made as of the beginning of the Plan year, January 1, 2024. The Plan Administrator estimates that there were no material changes in the present value of accumulated plan benefits from December 31, 2023 to January 1, 2024. The following were significant actuarial assumptions used in the Plan's valuations as of January 1, 2024 and January 1, 2023:

**Investment return:** 4.98% as of January 1, 2024, which decreased from 5.11% in the prior year valuation.

**Discount rate:** 6.00% as of January 1, 2024, which did not change from 6.00% in the prior year valuation.

**Mortality rates:** The mortality table used was based on Pri-2012 Total dataset base rate mortality table projected generationally using the Principal Mortality Improvement Scale (Principal 2023) in the current year.

The mortality table used was based on Pri-2012 Total dataset base rate mortality table projected generationally using the Principal Mortality Improvement Scale (Principal 2022) for the prior year.

**Retirement age:** Graded table beginning at age 55 varying by age and gender; vested terminated participants are assumed to begin receipt of benefits at age 65.

As discussed above, there was no change in the discount rate. The mortality table used in estimating the present value of accumulated plan benefits changed. There was no significant change in actuarial assumptions in the accompanying statement of changes in accumulated plan benefits.

The foregoing actuarial assumptions are based upon the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of accumulated plan benefits.

### Note 4. Custodian Certifications

The following is a summary of the Plan's asset information as of December 31, 2024 and 2023, and for the years then ended, included throughout the Plan's financial statements and supplemental schedules, that was prepared by or derived from information provided by the custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the custodian that the information provided to the plan administrator by the custodian related to the following assets is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to information which appears throughout the financial statements and supplemental schedules related to the following assets:

The custodian also certified to the completeness and accuracy of \$2,122,397 and \$2,496,291 of net appreciation in the fair value of investments for the years ended December 31, 2024 and 2023, respectively.

#### **Note 5. Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts:* Valued at net asset value (NAV). The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the accounts, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

#### Note 6. Related-Party and Party in Interest Transactions

Certain Plan investments are managed by Principal, a member of Principal Financial Group. Principal is the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made direct payments to the third-party administrator totaling \$65,810 and \$81,978 for the years ended December 31, 2024 and 2023, respectively, which were not covered by revenue sharing. The Company pays directly any other fees related to the Plan's operations.

#### **Note 7. Plan Termination**

The Plan has been established with the expectation that it will continue indefinitely. However, since future conditions cannot be foreseen, the Company reserves the right to amend, modify, or terminate the Plan at any time. In the event the Plan terminates, the net assets of the Plan will be allocated, as prescribed by ERISA and its related regulations, generally to provide the following benefits in the order indicated:

1. Annuity benefits that former employees or their beneficiaries have been receiving for at least three years, or that employees eligible to retire for that three-year period would have been receiving if they had retired with benefits in the normal form of annuity under the Plan. The priority amount is limited to the lowest benefit that was payable (or would have been payable) during those three years. The amount is further limited to the lowest benefit that would be payable under the Plan provisions in effect at any time during the five years preceding Plan termination.
2. Other vested benefits insured by the Pension Benefit Guaranty Corporation ("PBGC") up to the applicable limitations (discussed below).
3. All other vested benefits not insured by the PBGC.
4. All non-vested benefits.

Benefits to be provided via contracts under which Principal is obligated to pay the benefits would be excluded for allocation purposes.

Certain benefits under the Plan are insured by the PBGC if the Plan terminates. Generally, the PBGC guarantees most vested normal age retirement benefits, early retirement benefits, and certain disability and survivor's pensions. However, the PBGC does not guarantee all types of benefits under the Plan, and the amount of benefit protection is subject to certain limitations. Vested benefits under the Plan are guaranteed at the level in effect on the date of the Plan's termination. Whether all participants receive their benefits, should the Plan terminate at some future time, will depend on the sufficiency, at that time, of the Plan's net assets to provide for accumulated benefit obligations, the financial condition of the Company, or the level of benefits guaranteed by the PBGC.

#### **Note 8. Tax Status**

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated February 28, 2023, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax provisions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### **Note 9. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the 2024 statement of net assets available for benefits.

Plan contributions are made, and the actuarial present value of accumulated plan benefits are reported based on certain assumptions pertaining to interest rates, inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Society of Actuaries (SOA) is an actuarial organization that periodically reviews mortality data and publishes mortality tables and improvement scales. In October 2019, the SOA released the Pri-2012 Mortality Tables for private-sector retirement plans in the U.S. The Pri-2012 report contains different sets of mortality tables based on complete dataset or various subsets. The Total dataset base rate table was selected based on information provided by the plan sponsor.

Pri-2012 section 12.4. provided three approaches for designated beneficiaries in the calculation of joint-and-survivor annuities. We believe "Approach 1" is reasonable for this plan.

**Treatment of administrative expenses**

No adjustments are made for administrative expenses, either through a reduction in the discount rate or by calculating a present value of future expenses.

Plan sponsors may change their administrative expense handling at any time. Our approach provides consistent handling of ASC 960 liabilities from year to year, whether expenses are paid with plan assets or directly by the employer.

Note - expenses paid with plan assets are required to be included in funding normal cost. As a result, the plan is reimbursed annually through required funding. Exception – contributions are not required due to assets sufficiently in excess of liabilities to fund both expenses and normal cost. In this case, administrative expenses are taken from the excess assets.
