We have performed audits of the financial statements of OneStream Software 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for year ended December 31, 2024, and the related notes to the financial statements.

1. Plan Description

The following description of the OneStream Software 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was adopted effective October 1, 2013 by OneStream Software, LLC (the Company or Employer). The Plan is a defined contribution plan covering substantially all employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan was amended and restated effective January 1, 2024.

The trustee and recordkeeper of the Plan, effective December 1, 2022, is Fidelity Management Trust Company (the Trustee). Prior to December 1, 2022, Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (Principal Trust), Principal Life Insurance Company (Principal Life), and Principal Global Investors Trust Company (Principal Global) (collectively, the Former Custodians) were the custodians of the Plan. Principal Trust remains the custodian of one of the investments as of December 31, 2024. The administrator of the Plan is the Company.

The Plan has given the Trustee and Principal Trust the authority to hold the assets of the Plan and to invest, control, and disburse all assets of the Plan in accordance with the Plan agreement.

Eligibility

Participants must be 21 years of age to participate in the Plan. An eligible participant can enter the Plan upon meeting the eligibility requirements on the first day of each month.

Under the terms of the Plan agreement, substantially all employees of the Company are eligible, except for: (1) nonresident aliens with no U.S. source of income, (2) employees covered by a collective-bargaining agreement, (3) leased employees, and (4) independent contractors and interns. Interns are eligible to participate in the Plan on the first entry date after they have reached age 21 and have completed at least 1,000 hours of services during an eligibility computation period.

Contributions

The Plan provides for employee salary deferral contributions in the form of pretax dollars, subject to maximum limitations established by the Internal Revenue Code (IRC). The Plan includes an auto-enrollment provision, whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6% of eligible compensation. Automatically, enrollment deferral contributions are increased by 1% each year on January 1, subsequent to enrollment, up to 10% for individuals that have been enrolled in the Plan for at least six months.

Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover).

Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions.

The Company may make Employer match contributions as a percentage of eligible compensation deferred by participants. Effective January 1, 2023, the Plan began matching 50% of employee contributions up to the first 5% of compensation. Effective January 1, 2024, the Plan began matching 50% of employee contributions up to the first 6% of compensation. The participant must be employed as of the last day of the contributions period to be eligible for any matching contributions that may be made for that Plan year.

Participants direct the investment of their contributions and the Company's contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer contributions, and an allocation of Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan and Plan losses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the Plan agreement. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are immediately 100% vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service.

Company matching contributions vest in accordance with the following schedule:

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan agreement.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Participants may only have one loan outstanding at a time. Loans are secured by the participant's account and bear an interest rate as determined by the Plan administrator based on prevailing interest rates, which would be made under similar circumstances and is fixed for the term of the loan. The notes are repaid ratably through payroll deductions over a period of five years

or less, unless used to purchase a principal residence, in which case the note terms may not exceed ten years.

Payment of Benefits

Distributions are payable upon retirement, death, attainment of age 59½, qualified reservist distribution, or termination of employment in the form of a lump-sum amount equal to the vested balance of a participant's account. A participant may also receive a distribution in the case of financial hardship subject to the discretion of the Company, as defined in the Plan agreement.

Immediate lump-sum distributions may be made to terminated participants if the participant's vested account balance is \$1,000 or less. For terminated participants with vested balances greater than \$1,000, but less than \$5,000, their vested balance may be automatically rolled into an individual retirement account (IRA) unless otherwise elected.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$146,239 and \$103,579, respectively. These accounts will first be used to pay administrative expenses, and any remaining amounts will be used to reduce future Employer contributions. In 2024, approximately \$1,831 of the forfeited funds were used to pay administrative expenses and/or fund Employer contributions.

2. Summary of Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Contributions

Participant contributions are recognized in the period the contribution is withheld. Non-discretionary Matching Contributions are computed at the end of the year based on eligible compensation contributed to the Plan throughout the year. These matching contributions are remitted annually in the following period.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividend income, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by the Fidelity Management Trust Company, a qualified institution.

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedules, related to Principal U.S. Property Separate Account investment, including this investment held as of December 31, 2024 and 2023, and net appreciation in fair value of investments for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Money Market Funds - Money market funds are valued at the daily closing price as reported by the fund.

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Collective Investment Trusts (CITs) - Collective investment trusts are valued at the net asset value (NAV) of units held. The NAV, as provided by the trustee of the CITs, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the CIT less its liabilities. This practical expedient is not used when it is determined to be probable that the CITs will sell for an amount different than the reported NAV. The CCTs provide for daily redemptions by the Plan at reported NAV with no advance notice. There are no unfunded commitments related to these investments. These are direct filing entities.

Pooled Separate Account (PSA) - The PSA is valued at the NAV of the units held. The NAV is based on the fair value of the underlying investments held by the PSA less its liabilities. The fair value of the underlying investments, which can consist of a single mutual fund or multiple securities, is determined using market quotations or prices obtained from independent pricing sources. The NAV, as provided by Principal Life is used as a practical expedient to estimate fair value. NAV would not be used if it was probable that the investment would not be traded at NAV. The investment allows one transfer per 30-day period, which applies to all participant-directed transfers out, including non-scheduled rebalancing activity. Once the number of allowed transfers out is met, participants are not allowed to transfer back into this investment option until the holding period elapses. There are no unfunded commitments related to this type of investment. This is a direct filing entity.

5. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by the Trustee and Principal Trust. Participant loan and distribution processing fees are paid to Fidelity Workplace Services LLC. The Plan also issues loans to participants, which are secured by the vested balance of the participants' accounts. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules.

6. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts.

7. Tax Status

The Plan uses a pre-approved plan document sponsored by Fidelity Management & Research Company (FMR LLC). FMR LLC has received an opinion letter from the Internal Revenue Service (IRS), dated June 30, 2020, which states that the pre-approved plan document, as then-designed, satisfies the applicable provisions of the IRC. Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Subsequent Events

The financial statements and related disclosures include an evaluation of events up to and including October 7, 2025, the date the financial statements were available to be issued.

10. Delinquent Participant Contributions

During the Plan years ended December 31, 2024, 2023, and 2022, participant contributions and loan repayments totaling \$1,673,054, \$172,041, and \$364, respectively, were not remitted to the Plan within the period prescribed by Department of Labor regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA.

These non-exempt transactions do not affect the tax status opinion of the Plan and the Company intends to pay all potential fines imposed.
