Note 1: Description of Plan

The following description of the Sunstar Americas, Inc. 401(K) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a Section 401(k) defined contribution retirement savings plan established on October 1, 1991 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The Plan covers substantially all employees of Sunstar Americas, Inc. (the "Employer" and "Plan Administrator"). The trustee of the Plan is Vanguard Fiduciary Trust Company ("Trustee").

Eligibility

Employees are eligible to participate in the salary deferral provisions and Employer matching contribution provision of the Plan immediately upon hire with no minimum service requirement and having attained 18 years of age. Covered employees who have completed one year of service, as defined by the Plan, and have attained 18 years of age are eligible to participate in the Employer discretionary profit sharing contribution provisions of the Plan.

Contributions

Eligible employees may make pre-tax and/or, Roth after-tax salary deferral contributions in flat dollar amounts or as a percentage of compensation, as defined by the Plan, up to the maximum amount allowable by law. Eligible employees who do not elect an initial salary deferral rate or do not opt out of participation within 30 days of hire are automatically enrolled in the Plan at a 5% pre-tax salary deferral rate with the Vanguard targeted age-directed date funds as the qualified default investment alternative. Additionally, in July of each Plan year, automatically enrolled participant salary deferral rates are increased 1% up to a maximum rate of 100% of plan compensation, unless the participant affirmatively opts out of the increase. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute to the Plan amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Employer contributes a matching contribution equal to 50% of the first 5% of salary deferral contributions contributed by a participant to the Plan not to exceed 2.5% of the participant's Plan compensation. The Plan also provides for the Employer to make a discretionary profit-sharing contribution, as approved by the Board of Directors annually, to eligible employees. The Employer discretionary profit sharing contribution is allocated to qualified participants based on the ratio that each qualified participant's compensation, as defined by the Plan, bears to the total compensation of all qualified participants. For the year ended December 31, 2024, the Employer made matching contributions of \$791,298 and no discretionary profit sharing contributions.

Note 1: Description of Plan (Continued)

Investment Options

Participants self-direct investment of their salary deferral, Employer matching and rollover contributions amongst several funds offered by the Plan or may choose, by way of brokerage accounts, to invest in other funds, common stocks and other types of investments as allowed by the Plan. Investment of the Employer discretionary profit sharing contributions is directed by the Plan Administrator into the age appropriate Vanguard targeted age-directed date funds and a collective trust fund.

Vesting

Participants are immediately fully vested in their salary deferral, Employer matching and rollover contributions, plus actual earnings thereon. Participants vest in their Employer discretionary profit sharing contributions on a graduated basis based on years of vesting service, as defined by the Plan, and are fully vested after six years of vesting service.

Forfeitures

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$140,444 and \$5,749. These amounts are allocated to participants each Plan year on the same basis as the allocation of the Employer discretionary profit sharing contribution. No forfeited nonvested accounts were allocated to participants as of December 31, 2024..

SECURE 2.0 Act

The SECURE 2.0 Act of 2022 ("SECURE 2.0"), signed into law on December 29, 2022, makes significant changes to existing law for retirement plans by building upon provisions in the SECURE Act of 2019. SECURE 2.0 introduces new requirements and considerations for plan sponsors that are intended to expand coverage, increase savings, preserve income, and simplify plan rules and administrative procedures. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Management has evaluated those provisions and determined there is no material impact on the Plan. Plan management will determine the optional provisions, if any, to elect in the future.

Participant Accounts

Each participant's self-directed account is credited with the participant's contribution, the Employer's matching contribution, and actual earnings (loss) thereon and charged with administrative expenses and distributions, if any. Each participant's Employer discretionary profit-sharing account is credited with an allocation of (a) the Employer's discretionary profit sharing contribution, (b) actual earnings (loss) thereon, and (c) forfeitures of terminated participants' nonvested accounts, and charged with an allocation of certain administrative expenses, if any. Allocations are based on participant earnings, account balances or specific transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants

Participants may borrow from their Plan account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. Loan terms range from 6 months to 5 years or up to 30 years for the purchase of a primary residence. The notes are secured by the vested balance in the participant's account and bear interest at 2% above the current prime interest rate. The interest rate will be locked in at initiation of the loan. Principal and interest are paid ratably through payroll deductions. Loans outstanding at December 31, 2024 bore interest at rates ranging from 5.25% to 10.50%.

Payment of Benefits

On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or monthly installments. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. In addition, the Plan allows for hardship withdrawals if certain criteria are met, subject to the terms of the Plan document. The Plan also allows for in-service distributions upon attaining age 59 1/2.

Plan Termination

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event of Plan termination, participants would become fully vested in their Employer discretionary profit sharing account balance.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

Use of Estimates in Preparation of Financial Statements

The preparation of financial statements in accordance with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes in net assets available for benefits during the reporting period and disclosure of contingent assets and liabilities. Actual results may differ from these estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Determination as to when participant notes are considered in default and reclassified as distributions is based on the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Administrative Expenses

Administrative fees on loans from the Plan are charged to the borrowing participants' accounts. The asset management expenses are paid from the Plan's investment funds. Other administration expenses of the Plan, such as quarterly record keeping fees, are paid from quarterly per capita charges to participant accounts and revenue sharing from certain of the Plan's investment funds utilizing a plan revenue account. The Employer also may pay for certain Plan expenses which are not reflected in the accompanying financial statements.

Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, which is the date the financial statements were available to be issued.

Effective August 29, 2025 the Plan was amended and restated. The provisions of the Plan remained substantially the same. Additionally, the Plan transitioned its custodial, trust and recordkeeper services from Vanguard Fiduciary Trust Company ("Vanguard") to Empower Trust Company LLC ("Empower"). All plan assets were successfully transferred from Vanguard to Empower in September 2025.

Note 5: Fair Value Measurements

In measuring the fair value of the Plan's investments, Plan management utilizes a framework that provides for a fair value hierarchy that prioritizes the inputs to valuation techniques. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has ability to access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used to measure assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds - Valued at the daily closing price as reported by the fund. Funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common stocks held in self-directed brokerage accounts - Valued at the closing price reported on the active market on which the individual securities are traded.

Collective Trusts - Valued using NAV as a practical expedient. NAV is determined by using the estimated fair values of the units held by the Plan at year-end which is determined by the trustee of the collective trust fund based on the contractual terms of the underlying investment contracts of the trust fund. The collective trust fund in which the Plan invests seeks to provide a relatively predictable return from current income with no change in principal value. The contracts in which the collective trust fund invests are primarily invested in US treasury securities, high-quality mortgage-backed securities, corporate bond and asset-backed securities. The collective trust fund has no unfunded commitments, allows for daily liquidity, and requires no additional days notice for redemption for participant-directed transactions.

Note 6: Risks and Uncertainties

The Plan provides for various investment options. These investment options are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment options and the level of uncertainty related to changes in the value of the investment options, it is at least reasonably possible that changes in risks in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 7: Related-Party Transactions and Party-in-Interest Transactions

The Plan invests in shares of mutual funds managed by an affiliate of Vanguard Fiduciary Trust Company ("VFTC"), the Trustee of the Plan, and a collective trust for which VFTC is a Trustee. Transactions in such investments qualify as party-in-interest transactions. In addition, the parent company of VFTC provides record keeping services to the Plan. Fees incurred and paid by the Plan for the record keeping services were \$57,923 for the year ended December 31, 2024.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 8: Income Tax Status

The Employer has adopted a pre-approved defined contribution plan sponsored by the Vanguard Group. The pre-approved defined contribution plan obtained its latest determination letter on June 30, 2020, in which the IRS stated that the prototype Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and has no income subject to unrelated business income tax. Therefore, no provision for income taxes has been included in the Plan's financial statements.
