Basis for Opinion

A. DESCRIPTION OF PLAN

The following description of the Dick Lavy Trucking, Inc. (the Company and Plan Sponsor) 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description for a more complete description of the Plan's provisions.

1. General - The Plan is a defined contribution plan covering substantially all employees of Dick Lavy Trucking, Inc. and Waco Warehouse, Inc (other than union employees and non-resident aliens) that have completed one year and 1,000 hours of service and are age 21 or older. The Plan includes an automatic enrollment feature with ability to opt out with deferral election provided to the employer. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
2. Contributions - Each year, participants may contribute up to a maximum dollar limit set by law, as defined in the Plan. The Plan provides a formula for matching contributions at the discretion of the Company. In addition, the Company may make non-elective and qualified non-elective contributions at its discretion. The Plan may also accept eligible rollover contributions at the discretion of the Plan Administrator. Effective January 1, 2012, all employees who are eligible to make pre-tax salary deferrals can also make after-tax salary deferrals, also known as Roth deferral contributions.
3. Participant Accounts - Each participant's account is credited with his or her contribution, the Company's matching and qualified non-elective contributions, as well as allocations of the Company's non-elective contribution, and an allocation of Plan earnings. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
4. Vesting - Participants are immediately vested in their elective deferral, qualified non-elective contribution, and rollover contribution account, plus actual earnings thereon. Vesting in the Company's matching contribution portion of their account and non-elective contribution account, plus actual earnings thereon, is based on vesting years of service. Participants vest 20 percent per year of service and are 100 percent vested after five years of service. Participants become fully vested in the Company's contributions regardless of years of service if they are still employed at their normal retirement age or upon death, disability, or Plan termination.
5. Investment Options - The participant directs the investment of their contribution and the Company's matching contribution into various investment options offered by the Plan.

A. DESCRIPTION OF PLAN - (Continued)

6. Payment of Benefits - On termination of service for any reason, a participant will receive a lump sum amount equal to the value of the participant's vested interest in his or her account. Withdrawals for financial hardship are permitted provided certain conditions are satisfied.
7. Forfeited Accounts – At December 31, 2024 and 2023 forfeited, non-vested accounts totaled \$12 and \$808 respectively. These accounts will be used to reduce future employer contributions or pay plan expenses. Plan expenses paid out of the forfeiture account totaled \$7,261 and \$5,668 for 2024 and 2023.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

2. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

The Plan's investments in mutual funds are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians and insurance company. See note C for discussion of fair value measurements.

The Plan's investments in common collective trusts are valued at the net asset value (NAV) of the units held by the Plan. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investments for an amount different than the reported NAV.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES - (Continued)

3. Investment Valuation and Income Recognition - Continued

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in interest and dividends. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Excess Contribution Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. There were no excess contributions in 2024 and 2023.

5. Payment of Benefits

Benefits are recorded when paid.

6. Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

7. Subsequent Events

Management has evaluated subsequent events through October 13, 2025, the date the financial statements were available to be issued.

C. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted price in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3).

U.S. GAAP guidance provides for the use of NAV as a practical expedient for estimating fair value of alternative investments. Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using NAV are not categorized within the fair value hierarchy.

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Managed portfolio investments that are valued on a daily basis. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued based on reported NAV, as provided by the Plan administrator of the fund. The NAV is used as a practical expedient to estimate fair value. If available, quoted market prices (NAV) are used to value investments in the trust. The fair value of certain other investments for which quoted market prices are not available are valued based on yields currently available on comparable securities of issuers with similar credit ratings. There are no imposed redemption restrictions nor does the Plan have any contractual obligations to further invest in the trusts.

Fees paid to Creative Retirement Solutions for contract administration services amounted to \$9,593 and \$3,957 for the years ended December 31, 2024 and 2023, respectively.

H. INCOME TAX STATUS

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

I. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the statement of net assets available for benefits.
