Scope and Nature of the ERISA Section 103(a)(3)(C) Audit for the 2024 Financial Statements

We have performed an audit of the financial statements of Backyard Farms, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). Description of Plan

The following description of the Backyard Farms, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a tax-exempt defined contribution plan covering substantially all full-time employees of Backyard Farms, LLC (the Company). The Plan is part of a non-standardized pre-approved plan designed by FMR, LLC. The Internal Revenue Service has informed FMR, LLC by a determination letter dated June 30, 2020, that the non-standardized pre-approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Summary Plan Description previously provided to them for a description of vesting and benefit provisions.

Contributions

Participants may voluntarily defer up to 90% of their annual compensation, as defined by the Plan. Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes a matching contribution of 100% of the first 3% of deferred compensation of each participant and 50% of the next 2% of deferred compensation.

Contributions are subject to certain limitations.

Vesting

Participants are always 100% vested in their contributions and matching employer contributions. A participant is 100% vested in top heavy contributions after six years of credited vesting service, as defined by the plan document.

1. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities, at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurement.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan has an investment in the Great Gray Metlife Stable Value Solutions Fund II (the Fund), a common/collective trust, with a fair value based on the net asset value (NAV) of the underlying assets in the common/collective trust. The investment objective of the Fund is to seek the preservation of capital and to provide safety of principal, adequate liquidity, and a competitive yield with low return volatility. Withdrawals from the Fund are permitted at any time by participants.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company. Administrative expenses paid by the Plan totaled \$26,621 in 2024, which includes \$16,169 paid to the Plan trustee.

Subsequent Events

Management has considered transactions or events occurring through October 10, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

2. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants who have received top-heavy contributions will become 100% vested in their accounts.

During 2024 as well as 2023, the Plan incurred a partial plan termination. All participants were already 100% vested in all contribution accounts.

3. **Information Certified by Trustee**

Information included in the financial statements and supplemental schedule relating to investments, net appreciation in fair value of investments, investment and notes receivable from participants interest income, and notes receivable from participants was obtained by management and agreed to or derived from the information certified to be complete and accurate by the trustee. This information is included in the following:

4. **Party-in-Interest Transactions**

Certain plan investments are units of mutual funds and a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as transactions with a party-in-interest.

5. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. **Fair Value Measurement**

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability; and
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024:

Mutual funds and money market fund: Valued at the quoted NAV of shares held by the Plan at year-end.

Common/collective trust: Valued at fair value based on the underlying NAV of units held by the Plan at year-end as a practical expedient.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Description of Plan

The following description of the Backyard Farms, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan is a tax-exempt defined contribution plan covering substantially all full-time employees of Backyard Farms, LLC (the Company). The Plan is part of a non-standardized pre-approved plan designed by FMR, LLC. The Internal Revenue Service has informed FMR, LLC by a determination letter dated June 30, 2020, that the non-standardized pre-approved Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (the Code). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Code and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Participants should refer to the Summary Plan Description previously provided to them for a description of vesting and benefit provisions.

Contributions

Participants may voluntarily defer up to 90% of their annual compensation, as defined by the Plan. Participants may direct the investment of their contributions into various investment options offered by the Plan.

The Company contributes a matching contribution of 100% of the first 3% of deferred compensation of each participant and 50% of the next 2% of deferred compensation.

Contributions are subject to certain limitations.

Vesting

Participants are always 100% vested in their contributions and matching employer contributions. A participant is 100% vested in top heavy contributions after six years of credited vesting service, as defined by the plan document.

1. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosures of contingent assets and liabilities, at the date of the financial statements. Accordingly, actual results may differ from those estimates.

Valuation of Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurement.

Purchases and sales of securities are recorded on the trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

The Plan has an investment in the Great Gray Metlife Stable Value Solutions Fund II (the Fund), a common/collective trust, with a fair value based on the net asset value (NAV) of the underlying assets in the common/collective trust. The investment objective of the Fund is to seek the preservation of capital and to provide safety of principal, adequate liquidity, and a competitive yield with low return volatility. Withdrawals from the Fund are permitted at any time by participants.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses are paid by the Company. Administrative expenses paid by the Plan totaled \$26,621 in 2024, which includes \$16,169 paid to the Plan trustee.

Subsequent Events

Management has considered transactions or events occurring through October 10, 2025, which is the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

2. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants who have received top-heavy contributions will become 100% vested in their accounts.

During 2024 as well as 2023, the Plan incurred a partial plan termination. All participants were already 100% vested in all contribution accounts.

3. **Information Certified by Trustee**

Information included in the financial statements and supplemental schedule relating to investments, net appreciation in fair value of investments, investment and notes receivable from participants interest income, and notes receivable from participants was obtained by management and agreed to or derived from the information certified to be complete and accurate by the trustee. This information is included in the following:

4. **Party-in-Interest Transactions**

Certain plan investments are units of mutual funds and a money market fund managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the trustee as defined by the Plan and, therefore, these transactions qualify as transactions with a party-in-interest.

5. **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

6. **Fair Value Measurement**

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability; and
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value at December 31, 2024:

Mutual funds and money market fund: Valued at the quoted NAV of shares held by the Plan at year-end.

Common/collective trust: Valued at fair value based on the underlying NAV of units held by the Plan at year-end as a practical expedient.

The method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
