Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of CTS 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

1. Description of the Plan

The following description of the CTS 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the comprehensive Plan Document for a more complete description of the Plan's provisions.

General

The Plan was adopted effective January 1, 1998 by Communication Technology Services, LLC, (collectively, the "Company" or "Employer") sponsor of the Plan. The Plan is a defined contribution plan covering all eligible employees of the Company, as defined below. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Custodian and Administration of the Plan

The custodian of the Plan is Voya Retirement Insurance and Annuity Company ("Voya"). The administrator of the Plan is the Company. The custodian holds all assets of the Plan in accordance with the service provider contract with the Company. Plan management is responsible for oversight of the Plan. The CTS 401(k) Investment Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

Employees of the Company as defined in the Plan document, must be 21 years of age or older to be eligible to participate in the Plan. Employees must complete 60 days of service to be eligible to participate in the Plan and to receive Employer matching contributions. The entry date for participation in the Plan is the first day of each calendar month. Employees subject to a collective bargaining agreement and employees with certain job classifications as defined in the Plan document are not eligible to participate in the Plan.

Employee Contributions

Each year, participants may contribute up to 100% of eligible compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Effective April 1, 2024, participants will be automatically enrolled in the Plan at a contribution rate of 6% of eligible compensation. Rollovers are allowed if the employee meets the eligibility requirements of the Plan.

Employer Contributions

The Company may make a discretionary employer matching contribution as a percent of eligible compensation deferred by participants. During 2024, the Company matched 25% of participant contributions up to 6% of eligible compensation.

Contributions are subject to certain Internal Revenue Service (IRS) limitations. Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions, employer contributions, and an allocation of net Plan earnings or losses. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which participants are entitled is the vested portion of their accounts.

Vesting

Participants are 100% vested in their individual pre-tax deferral, Roth, and rollover contributions and the allocated earnings thereon. A participant's vested interest in the discretionary employer matching contributions are based upon the participant's years of continuous service. A participant is 100% vested at five years of credited service in accordance with the following schedule:

1 but less than 2	20
2 but less than 3	40
3 but less than 4	60

5 years or more	100

Participants become fully vested in the event of retirement, death, and disability, as defined by the Plan.

Payment of Benefits

A participant's entire vested interest in the Plan is payable upon death, attainment of normal retirement age, becoming disabled, and termination of employment as defined in the Plan document. Benefits are payable in one lump-sum payment. Partial or installment payments are permitted only to satisfy required minimum distribution rules. Hardship withdrawals are available if certain conditions are met as defined in the Plan document. In-service distributions of employee deferral contributions to participants who have attained the age of 59½ are also allowed under the Plan. Participants may elect to rollover their vested balance to another qualified retirement plan or IRA. If a participant's employment terminates with the Employer, the Plan permits distribution of the participant's account, not in excess of \$5,000, to be cashed out or transferred to an individual retirement account as designated by the plan administrator without the participant's consent.

Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$27,483 and \$11,272, respectively. These accounts may be used to reduce plan expenses or future employer contributions. \$21,624 of forfeited funds were used to offset plan expenses in 2024.

Notes Receivable from Participants

Participants are permitted to borrow a minimum of \$1,000 of their vested benefits under the Plan. Participants may borrow up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000, reduced by the highest outstanding loan balance in their account during the prior 12-month period. Loans are secured by the participant's account and bear an interest rate of the prime rate plus 2%. The notes are repaid ratably through monthly payroll deductions over a period of five years or less, unless used to purchase a principal residence up to 15 years. These loans are subject to certain restrictions as defined by the Plan Document and applicable restrictions under the IRC. Also, each participant may not have more than two loans outstanding at any time.

2. Summary of Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus accrued unpaid interest. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant's compensation.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to participant-initiated transactions are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 13, 2024, the date the financial statements were available to be issued and have not identified any events that require disclosure other than the event described below.

Effective January 1, 2025, participants who are automatically enrolled in the Plan will have an automatic escalation of 1% annually up to 8%.

3. Certified Investment Information

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments and notes receivable from participants held as of December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya, a qualified institution.

At the request of the Plan Administrator, the Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information in the financial statements, including reading the disclosures related to the investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP, and in the ERISA-required supplemental schedule, including assessing whether the supplemental schedule is in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

4. Fair Value Measurements

Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Pooled Separate Accounts

Pooled separate accounts are valued at the daily closing price. The pooled separate accounts held by the Plan publish their daily net asset value ("NAV") and transact at this published price, similar to a mutual fund. The published NAV is readily determinable fair value and the basis for current transactions and, therefore, are classified as level 1 assets in the fair value hierarchy. The pooled separate accounts held by the Plan invest exclusively in mutual funds. Mutual funds are registered with the Securities and Exchange Commission and are required to publish their daily NAV and transact at that price.

Self-Directed Brokerage Accounts

These accounts are comprised of common stock, mutual funds, including a money market fund, and exchange traded funds. Common stock and exchange traded funds are valued at the published market price on an active market. The mutual funds and the money market fund are valued as described above.

Stability of Principal Fund

Management has determined that fair value approximates contract value for these investments that are not fully benefit-responsive. Therefore, the nonfully benefit-responsive Stability of Principal Funds are reported at contract value. Contract value represents the accumulation of contributions made under the contract, plus interest, less funds used to pay benefits and administrative expenses of the contract. In determining the reasonableness of the methodology, the Plan's management

evaluates a variety of factors including review of existing contracts and overall credit rating of the issuer.

The preceding methods described may produce a fair value calculation which may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Investment Contracts with Insurance Company

The Plan offers a Voya Fixed Account option which are deposit contracts with Voya. This investment option offers a guaranteed rate of at least 1% on an annual basis. Each calendar year, Voya sets an annual minimum rate which will apply to all amounts held in this fund during the calendar year. Deposits in this account are invested in Voya's general account. Interest will be credited with the same guaranteed interest rate, on a daily basis, at the rate of interest which is the daily equivalent of the effective annual rate of interest applicable for each calendar year. This fund option also contains withdrawal and transfer limitations. The Voya Account has a transfer and withdrawal limit of 20%. As a result, a participant may transfer up to 20% annually to other investment options included in the Plan. Therefore, the Voya Account is not considered fully benefit responsive and will be presented at fair value in the accompanying statements of net assets available for benefits

The Voya Fixed Account is charged for participants' withdrawals and administrative expenses. This account is included in stability of principal fund in the accompanying statements of net assets available for benefits. The stability of principal fund is included in the accompanying financial statements at contract value (which approximates fair value) of \$766,261 and \$660,907 at December 31, 2024 and 2023, respectively, as reported by Voya.

6. Related Party and Party-in-Interest Transactions

Certain Plan investments are in funds and accounts that are managed by Voya, and therefore, these transactions qualify as party-in-interest transactions. Participant loan and distribution processing fees are paid to Voya by participants. The Plan also issues loans to participants which are secured by the vested balance of the participants' accounts. As described in Note 2, the Plan paid certain expenses related to plan operations and investment activity to various service providers. These transactions are party-in-interest transactions, which are exempt from prohibited transaction rules. Certain employees of the Company who participate in the Plan perform administrative services for the Plan at no cost to the Plan.

7. Risks and Uncertainties

The Plan holds various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in ERISA. In the event that the Plan is terminated, participants would become 100% vested in their accounts.

9. Tax Status

The Company adopted a Non-Standardized Pre-Approved Profit Sharing Plan with CODA. The IRS issued a favorable opinion letter dated June 30, 2020 that the Plan and related trust were designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan and the related trust is currently designed and operated in compliance with the applicable requirements of the IRC and continues to be tax-exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the federal and state taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
