### **Opinion**

## **1. Summary Description of Plan**

The following brief description of the Texas Scottish Rite Hospital for Children Defined Contribution Retirement Plan (the “Plan”) is provided for general informational purposes only. Reference should be made to the Plan Document for a more complete description and understanding of the provisions of the Plan.

### **General**

The Plan is a defined contribution plan, established January 1, 2006 under the provision of Section 403(b) of the Internal Revenue Code (“IRC”), for the benefit of employees of Texas Scottish Rite Hospital for Children (the “Hospital”), operating under the registered name of Texas Scottish Rite Hospital for Crippled Children, and of employees of Pedi-Ortho Health Corporation (“POHC”). The Plan is funded by the Hospital, POHC and by its participants and is administered by the Hospital. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

Effective October 1, 2005, the Hospital closed its defined benefit plan to new entrants. Covered qualified employees could elect to remain in the defined benefit plan. The Plan covers all new full-time and certain part-time employees, excluding leased employees, and certain qualified participants of the defined benefit plan that elected, in January 2006, to participate in the Plan. Those persons are eligible for Hospital matching contributions upon the attainment of one year of service and eighteen years of age.

### **Contributions**

Each year, participants may contribute a portion of their pretax annual compensation, as defined by the Plan, subject to maximum contributions as required under IRC Section 402(g). Participants who have 15 or more years of service with the Hospital may be eligible for a \$3,000 15 year catch-up contribution. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other eligible retirement plans. The Plan has an automatic enrollment feature, whereby the Hospital automatically deducts 3% from eligible employees’ pay for employees hired on or after January 1, 2009. Contribution amounts will be increased 1% automatically each year until they reach 10%. Employees and participants can elect to stop or change this automatic contribution.

### Contributions (Continued)

Participants direct the investment of their contributions and matching contributions into various investment options offered by the Plan. In the event participants do not elect an investment option, an automatic investment alternative is designated. Participants choose from among twenty mutual funds.

Effective September 22, 2014 the Hospital adopted the Texas Scottish Rite Hospital for Children 401(a) Plan (the “401(a) plan”) and employer contributions previously made to the Plan are now made to the 401(a) plan. The Hospital and POHC contribute 200% of the first 3% of compensation that a participant contributes to the 401(a) Plan.

Effective January 1, 2024, the Plan was amended to permit after-tax (Roth) contributions.

### Participant Accounts

Each participant’s account is credited with the participant’s contribution, and related matching contributions, as well as the participant’s share of investment income, appreciation (depreciation) and any related administrative expenses and distributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

### Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Hospital’s and POHC’s contribution portion of their accounts is based on years of continuous service.

Employer contributions are subject to a vesting schedule:

Participants who leave the Hospital or POHC before they are vested in the Company’s contributions forfeit their non-vested portion.

**Payment of Benefits**

On termination of service due to death, disability or retirement, elections may be made to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or periodic installments under various payment options. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Participants are allowed to withdraw employee account balances prior to termination of their employment under certain conditions as specified in the Plan. The Plan may make involuntary cashout distributions of terminated vested participants with account balances of \$1,000 or less. Account balances above \$1,000 but less than \$5,000 will be subject to the applicable automatic Individual Retirement Account rollover requirements of the IRC Section 401(a)(31)(b).

**Forfeiture and Employer Advance Accounts**

At the discretion of the Plan sponsor, forfeitures may be used to restore plan forfeitures to participant accounts, to pay Plan expenses or to reduce future employer contributions to the Plan. Changes in these accounts during the years ended December 31, 2024 and 2023 were as follows:

**Plan Administration**

The Plan is administered by the Hospital. The duties of the Plan Administrator are to oversee the operation and administration of the Plan in accordance with the specific terms of the Plan, to provide prudent investment choices and to keep accurate records and reports. The Plan's investments are managed by The Vanguard Group, Inc. ("Vanguard") under the terms of an agreement, effective July 15, 2019. Vanguard receives participant, rollover, Hospital and POHC contributions and invests them in accordance with the participant direction, as well as the income from Plan assets held by the Plan custodian, Vanguard Fiduciary Trust Company. Vanguard also pays the benefits to participants from Plan assets.

**Notes Receivable from Participants**

The Plan was amended on September 6, 2024 to permit participants to take loans from their accounts effective January 1, 2025.

**2. Summary of Significant Accounting Policies**

**Basis of Accounting and Use of Estimates**

The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America.

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, disclosure of contingencies at the date of the financial statements, and reported changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

**Administrative and Investment Expenses**

Certain administrative expenses are paid by the Hospital. These expenses include normal recurring fees for legal, audit and tax preparation services. Plan administrative and recordkeeping fees are paid from the forfeitures account or by the Hospital. The Plan is under no obligation to reimburse the Hospital for these expenses. Plan expenses paid by the Hospital are not included in these financial statements. Management fees and operating expenses charged to the Plan for investments in the various mutual funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair values of such investments.

**Benefits**

Benefit payments to plan participants are recorded upon distribution.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Changes in fair value are reflected in operations. Plan investment purchases and sales are recorded on the trade date. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Plan investments are recorded at quoted market prices, if available, or estimated using quoted market prices for similar securities. Shares of mutual funds are valued at the net asset value of shares held by the Plan at the end of the reporting period. The Plan presents, in the accompanying statements of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of realized and unrealized gains or losses on those investments.

The Plan provides for investments with different investment strategies, which, in general, are exposed to various risks such as interest rate, credit, foreign investment, active management, and overall market volatility risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. The Plan attempts to limit these risks by authorizing and offering participants a broad range of investment options that are invested in high quality securities or are offered and administered by reputable and known investment companies. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits. The Plan's exposure to a concentration of risk is limited by the diversification of investments across multiple investment fund options. Additionally, the investments within each investment fund option are further diversified into varied financial instruments.

Due to the level of risk associated with certain investment securities, the recent volatility in the financial markets, and the level of uncertainty related to changes in the fair value of investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

#### 3. Fair Value Measurements

As defined in Accounting Standards Codification (“ASC”) 820, fair value is based on the prices that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. In order to increase consistency and comparability in fair value measurements, ASC 820 establishes a three-tier fair value hierarchy for disclosure of fair value measurements. The valuation hierarchy is based upon the transparency of inputs to the valuation of an asset or liability as of the measurement date. The three levels are defined as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access. The valuation methodology for the fixed income, equity and balanced mutual funds is the net asset value of shares held by the Plan.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets.

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement. These investments require significant management judgment or estimations.

The fair value measurement level of the asset or liability within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another. For the years ended December 31, 2024 and 2023, there were no significant transfers in or out of levels 1, 2 or 3.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds: Valued at the net asset value (“NAV”) of shares held by the Plan at year end. Mutual funds held by the Plan are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods of determining fair value described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The following table sets forth by level, within the fair value hierarchy, the Plan’s assets at fair value as of December 31, 2024 and 2023.

**4. Plan Termination**

Although it has not expressed any intent to do so, the Hospital has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested in their employer contributions.

#### **5. Tax Status**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code (the “Code”). The Plan is required to operate in conformity with the Code to maintain the tax-exempt status for plan participants under Section 403(b).

The Hospital has adopted the Vanguard Group Volume Submitter 403(b) Plan. The Internal Revenue Service has issued an opinion letter dated February 1, 2018 stating that the plan is acceptable under Section 403(b) of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the opinion letter, the Hospital believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service (“IRS”). The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **6. Party-in-Interest Transactions**

The Plan’s investments are managed by Vanguard; therefore, those transactions qualify as party-in-interest transactions. Such transactions, while considered party-in-interest transactions under ERISA regulations, are permitted under the provisions of the Plan and are specifically exempt from the prohibition on party-in-interest transactions under ERISA.

#### **7. Reportable Transactions**

During the years ended December 31, 2024 and 2023, there were no reportable transactions, investment assets acquired and disposed of within the Plan, or non-exempt transactions with parties-in-interest which would require supplemental presentation under United States Department of Labor regulations.

#### **8. Recent Legislation**

In December 2022, Securing a Strong Retirement Act (“SECURE 2.0”) was passed into law. This package of laws builds on the Setting Every Community Up for Retirement Enhancement (“SECURE”) Act of 2019. SECURE 2.0 covers numerous changes to retirement provisions designed to increase retirement savings, facilitate access to retirement savings, encourage employees to save for retirement, and lower employers’ cost of offering and funding retirement savings plans. The provisions include both required and optional elements and the Plan Administrator will determine the optional provisions to elect. The United States Department of the Treasury and the Internal Revenue Service continue to issue guidance and regulations implementing provisions of SECURE 2.0. Many of the provisions in SECURE 2.0 were effective in 2023 and 2024, but it will not be completely implemented until 2028. The deadline for amending plan documents has been extended to December 31, 2026.

#### **9. Recent Accounting Pronouncement**

In July 2025, the Financial Accounting Standards Board (“FASB”) issued Accounting Standards Update (“ASU”) 2025-05, *Financial Instruments – Credit Losses (Topic 326): Measurement of Credit Losses for Accounts Receivable and Contract Assets*. This amendment simplifies the estimation of expected credit losses for current receivables and contract assets arising from revenue transactions under Accounting Standards Codification (“ASC”) Topic 606, *Revenue from Contracts with Customers*, such as participant contributions receivable. This amendment provides a practical expedient to assume current economic conditions remain unchanged over the life of these assets when estimating credit losses, without incorporating macroeconomic forecasts. Additionally, non-public entities may elect to consider cash collections received after the statement of net assets available for benefits date, but before financial statement issuance, in their loss estimates. ASU 2025-05 is effective for fiscal years beginning after December 15, 2025, with early adoption permitted, and requires prospective application.

The Plan is currently assessing the impact this recent accounting pronouncement will have on its financial statements.

#### **10. Subsequent Events**

The Plan Administrator has performed an evaluation of subsequent events through October 13, 2025, which is the date the financial statements were available to be issued.
