## Independent Auditors' Report

To the Plan Administrator of

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the McGowan & Company, Inc. NOTES TO FINANCIAL STATEMENTS

**Note 1. Description of Plan**

The following description of the McGowan & Company, Inc. Employees' 401(k) Plan (the "Plan"), provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan covering all employees of McGowan & Company (the "Company") who are age twenty or older for the deferral and have one year of service for the Company match. Employees that have met these requirements will become participants in the Plan on the first day of the month coinciding with or following the date the requirements were satisfied. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Contributions:

Participants may contribute through salary and wage deferrals up to the maximum percentage allowable of their annual wages including bonuses and overtime, but an amount not to exceed the limits set forth by the Internal Revenue Code ("IRC"). Unless a participant makes an affirmative election, the Company will automatically withhold a deferral in the amount of 1% of compensation for each payroll period. Participants may also contribute amounts representing distributions from other qualified retirement plans. Participants who have reached age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may designate all or a portion of their elective deferral to a Roth elective deferral. The Company will make a matching contribution in the amount of 50% of the participant's deferral limited to a deferral of 6%. Employees may transfer their service years from any acquired company. The matching contribution is made to the participant's account at the same time as the deferral contribution after each pay cycle. All contributions are made in cash.

Participant Accounts:

Each participant's account is credited with the participant's contribution, any Company contribution, and an allocation of Plan earnings, and is charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable From Participants:

Participants may borrow from their fund accounts to the extent of one-half of their vested account balance under the Plan, not to exceed \$50,000. The loans are secured by the balance in the participant's account and bear interest at the prime rate. Principal and interest is paid ratably through monthly payroll deductions.

Vesting:

Participants are immediately 100% vested in their deferral contributions plus actual earnings thereon. The Company matching contributions plus actual earnings thereon are vested based on a four year schedule as follows: 1 year 25%; 2 years 50%; 3 years 75%; 4 years 100%. A participant is also 100% vested in the event of death or disability.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 1. Description of Plan (Continued)**

Forfeitures:

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,046 and \$1,175, respectively. Forfeited balances of terminated participants' non-vested accounts are used to reduce employer contributions. During 2024, employer contributions were reduced by \$818 from forfeited nonvested accounts.

Payment of Benefits:

Upon termination of employment, death, disability, or retirement, a participant may elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account. The Plan also provides for in-service distributions of hardship withdrawals, subject to certain limitations. If a terminated participant's account balance is under \$1,000, the plan administrator will make an automatic rollover of the account balance to a qualified individual retirement account.

Participants are eligible to receive in-service withdrawals upon attaining age 59½ or normal retirement age.

**Note 2. Summary of Significant Accounting Policies**

- A. Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.
- B. Investment Valuation and Income Recognition – Investments are reported at fair value as reported by Ascensus Trust Company ("Ascensus"), the Trustee of the Plan. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee. See Note 5 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

- C. Notes Receivable From Participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon terms of the Plan document.
- D. Administrative Fees – Fees of the Plan are paid by the Company or the Plan at the discretion of the Company. In addition, certain transactions and account maintenance fees are charged to the affected participants.

NOTES TO FINANCIAL STATEMENTS (CONTINUED)

**Note 2. Summary of Significant Accounting Policies (Continued)**

- E. Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
- F. Benefit Payments – Benefits are recorded when paid.
- G. Excess Contribution Payable – During 2023, the Plan errantly received duplicate employer contributions. Related to the duplicate employer contributions, an excess contribution payable of \$17,643 was distributed out of the Plan in January 2024.
- H. Subsequent Events – The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**Note 3. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

**Note 4. Unaudited Information**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the plan administrator received a certification from Ascensus Trust Company acknowledging the completeness and accuracy of all investments and notes receivable from participants reflected in the statements of net assets available for benefits at December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) at December 31, 2024, the related investment and loan interest activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024, and investment related information in the accompanying notes to the financial statements. This information is unaudited by independent accountants.

**Note 5. Fair Value Measurements**

The Plan estimates the fair value of financial instruments using available market information and other generally accepted valuation methodologies. The inputs used to measure fair value are classified into three levels:

Level 1 – Quoted market prices in active markets for identical assets and liabilities

Level 2 – Observable market-based inputs or unobservable inputs that are corroborated by market data

Level 3 – Unobservable inputs in which little or no market data exists

**Note 5. Fair Value Measurements (Continued)**

The following is a description of the valuation methodologies used for plan assets measured at fair value:

- The fair value of investments held in the mutual funds is determined based on their quoted closing market prices in active markets for identical investments, and is classified as Level 1.
- Common/collective trust funds: Valued at the net asset value ("NAV") per unit based on quoted market prices of the underlying investments. The NAV is used as a practical expedient to estimate fair value and is based on the fair value of the underlying investments held by the account or trust fund. These investments are able to be redeemed daily with no notice period required. There are no unfunded commitments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. There have been no changes in the methodologies used from 2023 to 2024. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

(a) In accordance with GAAP, certain investments that were measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in these tables are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

**Note 6. Income Tax Status**

The Plan has adopted a prototype plan provided by Ascensus LLC. Ascensus LLC has received an opinion letter, dated June 30, 2020, from the Internal Revenue Service stating that the prototype plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. Although the Plan has been amended since adopting the prototype document, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.

The Plan's management has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require such recognition or disclosure in the financial statements.

**Note 7. Party-in-Interest Transactions**

Certain plan investments are held in funds managed by Vanguard. Vanguard is the Recordkeeper as defined by the Plan and certain fees are paid out of the Plan to the Recordkeeper and Trustee, therefore, these transactions qualify as party-in-interest transactions.

**Note 8. Risks and Uncertainties**

The Plan holds various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
