Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Fury Motors, Inc. Salary Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Fury Motors, Inc. Salary Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). 

NOTE 1 DESCRIPTION OF PLAN

The following description of Fury Motors, Inc. (the Employer) Salary Savings Plan (the Plan) provides general information only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan originally effective September 3, 1990. The Plan has been amended throughout the years to comply with tax legislation and most recently amended effective April 1, 2023.

Eligibility

Non-union employees age 20½ and older are eligible to participate upon completion of three months of service (250 hours). Union employees age 18 and older are eligible to participate upon completion of 30 days of continuous employment with a single employer except if hired during May or June in which they are eligible after 60 days of continuous employment. Eligible participants enter the Plan as of the first day of the month coinciding with or next following the date the eligibility requirements are met.

Contributions

Each year, participants may contribute a percentage of their eligible compensation up to the maximum permitted by the Internal Revenue Code (IRC). Both pre-tax and after-tax Roth contributions are allowed. Participants, upon meeting eligibility requirements, automatically defer 3% of their eligible compensation to the Plan unless otherwise instructed by the participant. Effective January 1, 2023, the plan includes an auto increase feature where participant's deferral rate will increase by 1% annually on January 1st until the rate reaches 6%. The Plan allows participants age 50 and older to make catch-up contributions. Participants may also contribute amounts representing eligible rollover distributions from a qualified plan or other eligible retirement savings account.

The Employer may make a discretionary matching contribution or profit sharing contribution to the Plan. Participants must be employed on the last day of the plan year to receive an allocation of the profit sharing contribution. There was no discretionary profit sharing contributions for the years ended December 31, 2024 and 2023. For the year ended December 31, 2024 and 2023, the discretionary matching contributions contribution for non union employees was 10% of elected deferrals up to a maximum of 6% of eligible compensation.

Effective January 1, 2023, the Employer will make a safe harbor matching contribution for all eligible non union employees who participate in the deferral portion of the Plan. For the years ended December 31, 2024 and 2023, the safe harbor matching contribution was equal to 100% of the employee's deferrals up to 1% of eligible compensation plus 50% of deferrals that exceed 1% of eligible compensation but do not exceed 6% of compensation.

Contributions (Continued)

During the years ended December 31, 2024 and 2023, the following employer contributions were for eligible union employees:

- Employer seed money contributions for union employees who are employed as of November 15, 2021 of \$900 per year during 2021-2025.
- Employer union contributions for certain union employees employed as of November 15, 2021 of 6% of eligible compensation.
- Employer union match contributions for union employees employed as of November 15, 2021 and future eligible union employees of 50% of deferrals up to a maximum of 6% of eligible compensation.

Participants direct the investment of contributions into various investment options offered by the Plan. Contributions are subject to limitations.

Participant Accounts

Each participant's account is credited with the participant's salary deferral, the Employer's matching and profit sharing contributions, and an allocation of Plan earnings or losses. Allocations are based on participant earnings, or account balances as defined. Income is allocated daily based on the self-directed fund shares in the participant's account.

Vesting

Participants are immediately vested in their contributions, employer seed money contributions, plus actual earnings thereon. Vesting in the Employer's matching and profit sharing contributions portion of their accounts, plus actual earnings thereon, is based on years of continuous service. A participant is 100% vested in Employer matching contributions after five years of credited service. A participant is 100% vested in profit sharing contributions after one year of credited service. A participant is 100% vested in the Safe Harbor matching contributions after 2 years of service. A participant is fully vested upon reaching normal retirement age, death, or permanent disability.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The Plan allows participants to borrow funds from the Plan based on certain conditions. Notes are repaid through payroll deductions. Note terms are up to five years, except for notes to fund the purchase of a principal residence, for which the note may be repaid over a reasonable period that may exceed five years. The notes are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates as determined quarterly by the Plan administrator.

Forfeited Accounts

Forfeited nonvested accounts may first be used to reduce administrative expenses and then are used to reduce future Employer contributions. Remaining forfeitures are reallocated to participants. Forfeited nonvested accounts as of December 31, 2024 and 2023 were \$11,340, and \$32,199, respectively. Forfeitures used to pay expenses during 2024 and 2023 were \$-0- and \$1,219, respectively. Forfeitures used to reduce employer contributions during 2024 and 2023 were \$32,206 and \$4,277, respectively.

Benefit Payments

The benefit to which a participant is entitled is the benefit that can be provided by the participant's account. Upon termination of service, death, disability, or retirement (age 65), the participant will receive the value of the vested interest in his or her account in the form of a lump sum distribution. The benefit is in the form of a qualified joint and survivor annuity for married participants unless a spousal waiver is obtained. The Plan allows for in-service distributions, if a participant reaches age 59 ½ (65 prior to 2023), and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If a participant's vested account balance is not greater than \$5,000 (\$7,000 as of January 1, 2024), the Plan administrator will authorize the benefit payment without the participant's consent.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared under the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are valued at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain fees related to the administration of notes receivable from participants and benefit payments are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Benefits Paid to Participants

Benefit payments are recorded when paid.

Subsequent Events

In preparing these financial statements, Plan management has evaluated events and transactions for potential recognition or disclosure through October 7, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFICATION OF INVESTMENT INFORMATION

The Standard Insurance Company, the current qualified institution effective January 1, 2024, has certified to the completeness and accuracy of the notes receivable from participants and all investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2024, the statement of changes in net assets available for benefits for the year then ended, and the supplemental schedule of assets (held at end of year) as of December 31, 2024.

Minnesota Life Insurance Company, the former qualified institution effective prior to January 1, 2024, has supplied the Plan administrator with a certification as to the completeness and accuracy of all notes receivable from participants and investment information reflected on the accompanying statement of net assets available for benefits as of December 31, 2023 and the statement of changes in net assets available for benefits for the year then ended.

NOTE 4 FAIR VALUE OF INVESTMENTS

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023 except for the annuity contract previously valued as level 3. The Minnesota Life Fixed Account was previously presented, recorded and disclosed as a non-benefit responsive investment contract valued at fair value. Management determined the basis to conclude it was a non-benefit responsive contract in prior periods related to transfers to competing investment options which do not affect a contract's benefit responsiveness and transfer restrictions that were not probable of occurrence. Therefore, the financial statements were revised to present, record, and disclose the Minnesota Life Fixed Account as a fully-benefit responsive investment contract valued at contract value. There was no difference between fair value and contract value in making the adjustments to the financial statements.

Pooled Separate Accounts: Valued at the net assets value (NAV) of units as determined by the insurance company. NAV is readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has a traditional fully benefit-responsive guaranteed investment contract with Minnesota Life Insurance Company (the Insurance Company). The Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 0%. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the Insurance Company to terminate the agreement prior to the scheduled maturity date.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by the Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY (CONTINUED)

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

NOTE 6 RISKS AND UNCERTAINTIES

The Plan provides for investment in a variety of investment funds. In general, investments are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 7 PLAN TERMINATION

Although it has not expressed any intent to do so, the Employer has the right under the Plan provisions to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants will become 100% vested in their accounts.

NOTE 8 PLAN TAX STATUS

The Plan is placing reliance on an opinion letter received from the Internal Revenue Service (IRS) on the prototype plan indicating that the Plan is qualified under the IRC and is, therefore, not subject to tax under current income tax law. The prototype plan has been amended since receiving the opinion letter. However, the Plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 PARTY-IN-INTEREST TRANSACTIONS

The Plan investments are managed by The Standard Insurance Company (The Standard). Therefore, transactions with The Standard qualify as party-in-interest. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investment rather than a direct payment.
