Opinion

We have audited the accompanying financial statements of Lifetime Assistance, Inc. Employee Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

The financial statements do not include any adjustments that might be necessary upon termination. Our opinion is not modified with respect to that matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following brief description of the Lifetime Assistance, Inc. Employee Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the plan document for more complete information.

General

The Plan is a discretionary defined contribution plan and covers substantially all of the employees of Lifetime Assistance, Inc. (the Agency). Employees are eligible to participate in the Plan upon attaining age 21 and completing one year of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Employer contributions to the Plan are discretionary in nature, as determined by the Agency's Board of Directors on an annual basis. Contributions as a percentage of employee compensation ranged from 2.5% - 7.5% in 2024 and 2023, depending on the employee's length of service with the Agency. Participants direct the investment of their employer contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the Agency's contributions, an allocation of Plan earnings or losses and charged with an allocation of Plan expenses.

Vesting

Participants are 100% vested in Agency contributions allocated to their account plus actual earnings thereon after three years of service.

Benefits

Participants are eligible for normal retirement benefits equal to the vested balance of their account upon attaining age 65. Vested benefits may also be paid to a participant or his or her beneficiaries upon disability, death or termination of employment.

Notes Receivable from Participants

Participants may borrow up to the lesser of \$50,000 or one-half of their vested account balance. Unless used to purchase a principal residence, participant loans are repaid over a period not to exceed five years. Participant loans bear interest at a fixed rate equal to 1.25% plus the prime rate in effect when the loan is made.

Administrative Expense

Investment fees are paid by the Plan. The Agency pays for the Plan's annual audit and any other costs of the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements are prepared in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP).

Payments of Benefits

Benefits are recorded when paid.

Investments

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term.

The Plan's investments are reported at fair value. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are permitted under the plan for a participant with an immediate and heavy financial need (hardship), and the distribution is necessary to satisfy the need. All notes receivable must comply with the rules relating to hardships, which are uniformly applicable to all participants. These notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable are reclassified as distributions based upon the terms of the Plan document.

Fair Value Measurement - Definition and Hierarchy

U.S. GAAP defines fair value as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

U.S. GAAP establishes a framework for measuring fair value, which provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

The three levels of the fair value hierarchy under Accounting Standards Codification (ASC) Topic 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs to the valuation methodology include:
 - Quoted prices for similar assets or liabilities in active markets
 - Quoted prices for identical or similar assets or liabilities in inactive markets
 - Inputs other than quoted prices that are observable for the asset or liability
 - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Classification within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for assets measured at fair value.

Money market funds: Stated at cost, which approximates fair value based on the short-term nature and liquidity of the instrument.

Mutual funds: Valued based on quoted prices for identical assets in active markets. Mutual funds are considered Level 1 inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There have been no changes in the valuation methodologies used during 2024 or 2023.

Forfeited Accounts

Forfeitures may be used to reduce employer discretionary contributions. At December 31, 2024 and 2023, there were no unapplied forfeitures.

Estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the amounts of net assets available for benefits and the amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

3. TERMINATION OF THE PLAN

The Agency has the right under the Plan to discontinue, reduce or suspend its contributions at any time and to terminate the Plan and the trust, in whole or in part, subject to the provisions of ERISA. In the event of termination or partial termination, participants' account balances become fully vested. Upon termination, the custodian would distribute the assets of the trust in accordance with the Plan agreement.

4. TAX STATUS

The Plan has received a favorable opinion letter from the Internal Revenue Service, dated June 30, 2020 as a pre-approved plan's qualified status. The pre-approved plan's opinion letter has been relied upon by the Plan. The Plan has been amended since the date of the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

7. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.

7. SUBSEQUENT EVENTS (Continued)

In September 2023, the Plan Sponsor's Board of Directors approved a motion to begin the process of consolidating their multiple retirement plans into one ERISA 403(b) plan, which became effective January 1, 2025. The Plan will no longer receive contributions or new enrollments beginning in the 2025 plan year.

In August 2025, the Plan Sponsor's Retirement Committee approved a motion to terminate the Plan with an effective date of October 1, 2025. Participants in the Plan will not accrue any additional benefits in the Plan as of October 1, 2025. All participants in the Plan became fully vested upon the termination date.
