INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Wagner Hardwoods LLC 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Wagner Hardwoods LLC 401(k) Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the financial statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following is a brief description of the Wagner Hardwoods LLC 401(k) Retirement Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan covers substantially all employees of Wagner Hardwoods LLC (the “Company” or “Plan Sponsor”). Employees are eligible to participate in the Plan upon completion of 60 days of service and have attained the age of 18 years old. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Each eligible employee may make pre-tax or Roth contributions to the Plan up to 100% of eligible compensation, as defined in the Plan, not to exceed statutory limits. Upon becoming eligible to participate in the Plan, participants are auto-enrolled at 5% of eligible compensation with annual 1% increases to a maximum of 10% of eligible compensation, unless the participant makes an election indicating otherwise. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes qualified matching contributions to the Plan equal to 100% of the first 3% of compensation and 50% of the next 2% of compensation immediately on becoming eligible to participate in the Plan. The Company may also make discretionary contributions. There were no such discretionary contributions for the year ended December 31, 2024.

Vesting – Participants are immediately vested in their elective contributions and qualified matching contributions plus or minus any earnings or losses thereon. Vesting in the Company’s discretionary contribution portion of their accounts plus or minus any earnings or losses thereon is based on years of service with the Company. Participants vest 20% after two years of service and 20% for each year thereafter.

Forfeited Accounts – Forfeited accounts may be used to pay administrative expenses or to reduce employer contributions. There were no forfeitures available as of December 31, 2024 and 2023. Forfeitures of \$45 were used to reduce employer contributions during the year ended December 31, 2024.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and allocations of the Company’s qualified matching contributions, discretionary contributions, and Plan earnings, and charged with withdrawals and an allocation of administrative expenses. Allocations are based on the participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

1. PLAN DESCRIPTION (continued)

Payment of Benefits – On termination of service due to death, disability, retirement, or other termination of a participant’s employment, a participant may elect to receive either a lump-sum amount equal to the value of the participant’s vested interest in his or her account, or annual installments. Distributions will be made as soon as practical after a participant’s request. The Plan also allows for in-service withdrawals for employees who attain age 59 ½. Distributions are also permitted in the event of financial hardship, as defined by the Plan.

Administrative Expenses – The costs of administering the Plan are borne by both the Plan and the Company.

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, all participants shall become fully vested in their accounts at the date of such termination.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities which are subject to reporting at fair value based on standards established within accounting principles generally accepted in the United States of America. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Mutual funds: Valued based on the quoted market price available on an active market, which represents the net asset values (“NAV”) of the shares held by the Plan at year-end.

Common collective trust funds: Valued at the NAV of units held by the Plan at year-end. These common collective trust funds generally have no redemption restrictions or unfunded capital commitments.

Pooled separate accounts: Valued at the NAV of units held by the Plan at year-end. These pooled separate accounts generally have no redemption restrictions or unfunded capital commitments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in different fair value measurements at the reporting date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Dividend income is recognized on the ex-dividend date.

Payment of Benefits – Benefit payments to participants are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events – Management has evaluated the effects of all subsequent events through October 10, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures (as discussed in Note 2). The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, 2024 and 2023, with the exception of the common collective trust funds and the pooled separate accounts, which are valued at fair value using the NAV practical expedient. The fair value of the common collective trust funds and the pooled separate accounts is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

4. INCOME TAX STATUS

The Plan has adopted the Principal Financial Group Prototype Non-Standardized Profit Sharing Plan with Cash or Deferred Arrangement (the “Prototype Plan”). The Prototype Plan received an Opinion Letter from the Internal Revenue Service (“IRS”) on June 30, 2020, stating that the form of the Prototype Plan is acceptable under Section 401 of the IRC for use by employers for the benefit of their employees. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified and the related trust is tax exempt.

5. TRANSACTIONS WITH PARTIES IN INTEREST

The Plan’s pooled separate accounts and common collective trust funds are investments managed by Principal Life Insurance Company and Principal Global Investors Trust Company, respectively. Principal Global Investors Trust Company is an affiliate of Principal Life Insurance Company. Principal Life Insurance Company (“Principal”) is the trustee of the Plan and, therefore, these transactions qualify as party-in-interest transactions.

6. CERTIFIED INVESTMENT INFORMATION
