## INDEPENDENT AUDITOR'S REPORT

### ***Qualified Opinion***

We have audited the financial statements of the Carpenters Health Fund of West Virginia (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statement of net assets available for benefits and the statements of benefit obligations as of December 31, 2024, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the three-month period ended December 31, 2024, and the related notes to the financial statements.

In our opinion, except for the omission of the information described in the Basis for Qualified Opinion section of our report, the accompanying financial statements referred to above present fairly, in all material respects, the net assets available for benefits as of December 31, 2024, and the changes in its net assets available for benefits for the three-month period then ended, and the accumulated plan benefits as of December 31, 2024 and the changes in its accumulated plan benefits for the three-month period ended December 31, 2024 in accordance with accounting principles generally accepted in the United States of America.

### ***Basis for Qualified Opinion***

During the course of our audit, we were unable to obtain sufficient appropriate audit evidence to support the completeness and accuracy of incoming and outgoing reciprocity transactions and the related receivable and payable amounts recorded during the three-month period ended December 31, 2024. These transactions may be material to the financial statements, and the absence of adequate supporting documentation limits our ability to determine whether any adjustments might be necessary to the related account balances, net assets available for benefits, and changes therein. In our opinion, disclosure of this information is required by accounting principles generally accepted in the United States of America.

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

***Emphasis of Matter***

As further discussed in Note 1 to the financial statements, the Board of Trustees voted to merge the Plan into the Greater Pennsylvania Carpenters' Medical Plan (GPCMP) effective December 31, 2024. As a result of this merger, all assets and liabilities of the Plan were transferred out of the Plan as of December 31, 2024. Our opinion is not modified with respect to this matter.

***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditor's Responsibilities for the Audit of the Financial Statements***

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.

- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### ***Supplemental Schedules Required by ERISA***

Our audit was conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of reportable transactions, referred to as "supplemental information," is presented for the purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, except for the possible effects of the matter described in the Basis for Qualified Opinion paragraph, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1 – DESCRIPTION OF PLAN

The following description of the Carpenters Health Fund of West Virginia (the Plan) provides only general information. Participants should refer to the Plan's governing documents for a more complete description of the Plan's provisions.

General - The Plan provides health and other benefits covering eligible participants who have worked or are working for any of the contributing employers as established by the collective bargaining agreement by and between the Keystone Mountain Lakes Regional Council of Carpenters, which were collectively bargained by and between the Mid Atlantic Regional Council of Carpenters and various employers. The Plan and related trust were established on May 1, 1956. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Merger - The Board of Trustees of Carpenters Health Fund of West Virginia and the Board of Trustees of Greater Pennsylvania Carpenters' Medical Plan voted to merge the plan into the Greater Pennsylvania Carpenters' Medical Plan effective December 31, 2024. As a result, \$27,597,422 of Plan assets were transferred out of the Plan as of December 31, 2024.

In connection with the Plan's merger, no actuarial valuation was performed on the Plan related to the three-month period ended December 31, 2024 and benefit obligations have been zeroed out as of December 31, 2024.

Benefits - The Plan provides health benefits (hospital, surgical, major medical, dental and disability) and life insurance covering eligible persons. The basic qualifying requirements state that participants will become eligible for benefits on the first day of the second benefit month following crediting of the required amount to the participant's eligibility reserve. The Plan has also obtained stop-loss insurance in order to protect itself from excessively large claims.

The Plan is primarily self-insured for providing health and welfare benefits to participants and their beneficiaries with the exception of life and accidental death and dismemberment coverage which is underwritten by insurance.

Effective July 1, 2021, all medical expenses will be applied to the medical out-of-pocket maximums of \$8,550 per individual and \$17,100 per family. The Plan has distributed these maximums between covered medical and prescription expenses.

Effective July 1, 2021, the Plan will provide certain preventive benefits with no cost-sharing to the Participant with "A" or "B" recommendations by the US Preventative Services Task Force.

Effective July 1, 2021, the Board of Trustees approved limiting the Eligibility Reserve Credits to \$2,500 (previously \$10,000) while creating Health Reimbursement Arrangement (HRA) accounts where Participants may maintain balances up to \$10,000.

Contributions - Contributions to the Plan are made by participating employers based on the negotiated contribution rates set forth in collective bargaining agreements. In addition, participants may qualify to self-pay in order to continue eligibility.

In general, if the balance in a participant's eligibility reserve is less than the required contribution, the participant will be permitted to make self-contributions to the Plan in order to maintain eligibility.

Prescription Drug Rebates – The Plan periodically receives rebates from prescription drug manufacturers based on utilization.

Other - The Plan's Board of Trustees, as Sponsor, has the right under the Plan to modify the benefits provided to participants. The Plan may be terminated by the board of trustees or the bargaining parties, subject to the provisions of ERISA.

## 2 – SUMMARY OF ACCOUNTING POLICIES

Date of Management's Review - Subsequent events were evaluated through the date of the auditor's report, which is the date the financial statements were available to be issued.

Basis of Accounting - The financial statements of the Plan are prepared using the accrual method of accounting.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments - Investments are stated at fair value. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Postretirement Benefits - The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed to employee service rendered to September 30. Postretirement benefits include future benefits expected to be paid on behalf of (1) current retirees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active member's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service in the industry rendered to the valuation date.

The actuarial present value of the expected postretirement benefit obligation is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims cost/data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment.

Other Plan Benefits - Plan obligations at December 31 for health claims incurred by active participants but not reported at that date, for accumulated eligibility of participants, and for future disability payments to members considered permanently disabled at December 31 are estimated by an actuary in accordance with accepted actuarial principles. Such estimated amounts are reported in the accompanying statement of the Plan's benefit obligations at present value. Health claims incurred by retired participants but not reported at period end are included in the postretirement benefit obligation.

Allowance for Doubtful Accounts – The Plan's administration has evaluated employer contributions receivable and has determined that an allowance for doubtful accounts was not necessary as all amounts are deemed to be fully collectible.

Prescription drug rebates – Prescription drug rebates are recognized when received.

### 3 – INCOME TAX STATUS

The trust established under the Plan to hold the Plan's assets is intended to qualify pursuant to Section 501(c)(9) of the Internal Revenue Code, as a tax-exempt organization. The Plan sponsor believes that the Plan, as amended, qualifies, and is operating in accordance with the applicable provisions of the Internal Revenue Code.

The Plan purchases stoploss insurance from Union Labor Life Insurance Company and utilizes Independence Blue Cross and Express Scripts to administer all health and prescription drug claims, respectively.

### 6 – CONCENTRATION OF CREDIT RISK

All of the revenue and receivables shown on the financial statements are from carpentry services. The Plan's ability to collect contributions and enter into contracts could be affected by fluctuations in the carpentry service industry and the overall economy.
