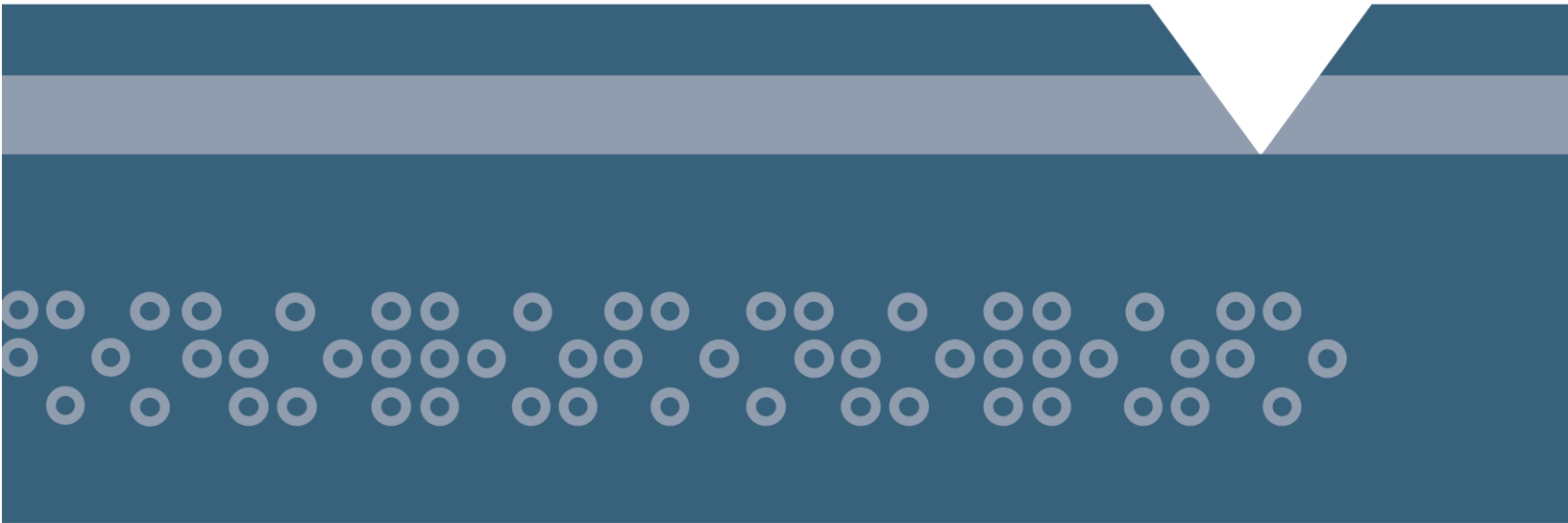

INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Texas Farm Products 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and June 30, 2024, the related statement of changes in net assets available for benefits for the six months ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and June 30, 2024, and for the six months ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND JUNE 30, 2024

1. Description of Plan

The following description of the Texas Farm Products (the “Company”) 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions. The Plan is a tax-qualified defined contribution plan under Section 401(a) of the Internal Revenue Code of 1986, as amended, which provides retirement, disability, or death benefits for eligible employees of the Company. The Plan is subject to various provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

- (a) *Participant accounts.* Each participant’s account is credited with the participant’s voluntary contribution, the Company’s profit sharing contribution and Plan earnings, which are allocated proportionately among all participants based on their investment in each fund. Each participant’s account is also charged with an allocation of administrative expenses, which may be paid from plan assets or by the Company, and may be charged directly to participant accounts for certain transactions, such as distributions, as provided in the Plan document.
- (b) *Employee contributions.* Participants are permitted to contribute up to the maximum deferral amount indicated by the Internal Revenue Service (IRS) to the Plan on a tax-deferred or after-tax (roth) basis. Transfers from qualified plans are allowed under the provisions of the Plan. The Company has an automatic enrollment feature which requires that all newly eligible employees will automatically have a 3% deferral deducted from their compensation unless they elect not to participate.
- (c) *Employer contributions.* The Company may contribute annually a discretionary match contribution. The Company may also contribute a discretionary profit sharing contribution. The Company made matching contributions of \$125,391 and \$206,695 for the six months ended December 31, 2024 and the year ended June 30, 2024, respectively.
- (d) *Vesting.* Participants are fully vested in their employee contributions plus actual earnings thereon. Effective July 1, 2023 vesting in non-elective and profit sharing contributions and earnings thereon, is based on years of service and is determined as follows:

- (e) *Notes receivable from participants.* Loans to participants may be granted up to the amount of the participant’s vested account balance, as provided in the Plan’s written loan program. Loans bear a reasonable rate of interest, are secured by the participant’s account, and require periodic repayment over a reasonable period. Principal and interest are typically repaid through payroll deductions. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest

- (f) *Forfeitures.* Forfeitures of non-vested Company contributions are used first to reduce Plan expenses and then Company contributions. As of December 31, 2024 and June 30, 2024, forfeited non-vested accounts were immaterial to the financial statements.
- (g) *Plan expenses.* Investment related expenses are included in the net appreciation of the fair value of investments. Administrative expenses are paid directly by the Plan unless otherwise paid by the Plan sponsor. The Plan sponsor may also pay certain administrative expenses on behalf of the Plan. In some cases, administrative expenses may be offset against income earned on Plan investments, as provided in agreements with service providers.
- (h) *Plan year change.* Effective July 1, 2024, the Plan changed its plan year-end from June 30 to December 31 to align with the calendar year. Accordingly, the accompanying financial statements for the current year cover the six-month period from July 1, 2024 through December 31, 2024.

2. Summary of Significant Accounting Policies

- (a) *Basis of accounting.* The financial statements of the Plan are prepared on the accrual basis of accounting.
 - (b) *Use of estimates.* The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.
 - (c) *Investment valuation and income recognition.* Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's 401(k) Oversight Committee determines the Plan's valuation policies utilizing information provided by its investment adviser and asset custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.
 - (d) *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and June 30, 2024. Delinquent participant loans are reclassified as distributions based on the terms of the Plan document.
 - (e) *Payment of benefits.* Benefits are recorded when paid.
 - (f) *Notes receivable from participants.* Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on

the accrual basis. No allowance for credit losses has been recorded as repayments are typically made through payroll deductions, and the notes are collateralized by the participants' account balances.

- (g) *Expenses.* Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in the administrative expenses. Investment related expenses are included in net appreciation of fair value of investments. Fees related to the administration of distributions to participants, beneficiaries, or alternate payees may be charged directly to the participant's account as a reasonable administrative expense, paid from plan assets, or paid by the Company, as provided in the Plan document.

3. Information Certified by the Plan's Custodian

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Principal Trust Company, the custodian of the Plan, except for comparing such information certified by the custodian to information included in the Plan's financial statements and supplemental schedule. All investment information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and June 30, 2024 and net change in fair market value for the six month period ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by the Plan's custodian.

4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:
 - quoted prices for similar assets or liabilities in active markets;
 - quoted prices for identical or similar assets or liabilities in inactive markets;
 - inputs other than quoted prices that are observable for the asset or liability;

- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and June 30, 2024.

Mutual Funds: Valued at the daily closing price which is based on the net asset value (NAV) of shares held by the plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are shares of mutual funds managed by Principal Trust Company. Principal Trust Company is the recordkeeper and custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. The Plan has a number of services providers. Such providers are parties-in-interest under ERISA.

6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

7. Tax Status

The Internal Revenue Service (IRS) has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax position taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. Subsequent Events

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements. Subsequent events have been evaluated through October 14, 2025, which is the date the financial statements were available to be issued.
