INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the
Emory University Health Care Plan

Opinion

We have audited the financial statements of the Emory University Health Care Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of plan benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and changes in plan benefit obligations for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and plan benefit obligations of the Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and changes in plan benefit obligations for the years ended December 31, 2024 and 2023, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and

disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Note 1 - Description of plan:

General

The following description of the Emory University Health Care Plan (the Plan) is provided for general information purposes only. Participants should refer to the summary plan description for a complete description of the Plan's provisions.

The Plan is a defined benefit health and welfare benefit plan established in 1939, to provide health insurance benefits to active and retired employees, and covered spouses or same sex domestic partners of Emory University, Emory Healthcare, Inc., and affiliated entities (collectively, the University), and to the dependents of such employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The University (the Trustee and Plan Sponsor) established the Emory University Postretirement Employee Benefit Trust (the Master Trust), a trust established under Section 501(c)(9) of the Internal Revenue Code of 1986 as amended (the IRC) in 1993. On January 1, 2003, the Master Trust was amended and restated to allow the transfer of a portion of the Master Trust assets to a newly established voluntary employee beneficiary association trust sponsored by Emory Healthcare, Inc. - the Emory Healthcare, Inc. Postretirement Employee Welfare Benefit Trust (the Emory Healthcare Master Trust). As a result, on January 1, 2003, total assets of \$13,987,656 were transferred from the Master Trust to the Emory Healthcare Master Trust. Assets of the Plan are invested in the Master Trust and the Emory Healthcare Master Trust (collectively, the Trusts).

Certain plan benefits are provided to participants by healthcare providers affiliated with the University or with The Emory Clinic, Inc., a party related to the University. An exemption from the prohibited transaction provisions of ERISA was received by the Plan related to the participation of these healthcare providers in the Plan.

Eligibility

The Plan provides health benefits (including a prescription drug program, mental health, medical, dental, and vision benefits) to regular full-time employees, regular employees scheduled to work half-time, and temporary full-time employees on an assignment scheduled for at least six consecutive months, and to the spouses and dependents of eligible employees. Employees who retire from the University, and who were hired prior to January 1, 2003, are entitled to receive retiree healthcare benefits if they are age 55 or older with at least 10 consecutive years of service and have a total age plus years of service at retirement of at least

Eligibility - continued

75 years. Effective January 1, 2003, the University discontinued subsidizing retiree healthcare benefits for new employees. All University employees hired prior to January 1, 2003 and certain employees of Emory Healthcare who met age and service requirements continue to be eligible for the retiree healthcare benefits. The cost of providing these benefits is shared with retirees. Once a retiree or eligible spouse of a retiree turns 65 and is eligible for Medicare benefits, the retiree or spouse becomes a participant of the Emory Post 65 Retiree Health Reimbursement Arrangement Plan (RHRA Plan) and are no longer eligible for benefits under this Plan.

Benefits

Medical benefits are provided under three options: Kaiser Permanente (Kaiser), Aetna POS, and Aetna HSA (Aetna). Eligible employees and retirees under the age of 65 may elect to enroll annually in one of these options. All medical plans provide self-insured benefits with administrative services provided by Aetna or Kaiser, as applicable.

Dental benefits are provided under two coverage options, one of which is fully insured and one of which is a self-insured benefit. Aetna provided the administrative services for both dental plans.

Claims and administrative expenses are paid directly from the general assets of the University and are included in these financial statements. Emory Healthcare was reimbursed by the Emory Healthcare Master Trust for claims incurred for Emory Healthcare retirees through December 31, 2024.

The Plan also provides continuation of certain benefits upon termination of employment as required by the Consolidated Omnibus Budget Reconciliation Act (COBRA).

Contributions

Contributions are made by the University to the Trusts in amounts determined by the Plan's actuary to meet funding goals for the postretirement obligation. The costs of the postretirement benefits are shared by the University and retirees who were employed by the University prior to January 1, 2003. Contributions are made by current employees in amounts determined annually by the University to meet cost sharing objectives.

Note 1 - Description of plan - continued:

Administrative expenses

Expenses incurred in the administration of the Plan are primarily paid by the Plan, including claims, administration fees, and other service fees. The expenses paid to service providers of the Plan qualify as party-in-interest transactions. Certain expenses of the Plan are paid by the University. The University does not expect reimbursement from the Plan for any expenses paid on behalf of the Plan.

Note 2 - Summary of significant accounting policies:

Basis of presentation

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

Use of estimates

The preparation of financial statements in conformity with U.S. GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims incurred but not reported, claims payable, and disclosure of contingent assets and liabilities. Actual amounts could differ from those estimates.

The actuarial present value of plan benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimation and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

Payment of benefits

Premiums paid for the Plan by the Plan Sponsor are recorded as premiums paid to insurance carrier in the accompanying statements of changes in net assets available for benefits.

Claim payments are recorded when paid by the third-party claims processor. Amounts due to claims processors that have yet to be reimbursed by the Plan Sponsor are included in accrued expenses and other payables in the accompanying statements of net assets available for benefits, as applicable.

Claims incurred but not reported

The Plan's liability for incurred but not reported claims is estimated using historical medical claims experience.

Rebates

Rebates provided from the Plan's service providers are recorded as an offset to claims when earned. Rebates due as of December 31, 2024 and 2023 have been reported as a receivable, with the offset being netted against claims.

Transfers to related plan

Transfers to related plan represents the reallocation of the Trusts' assets between the Plan and the RHRA Plan based on plan expenses incurred in the current year. Transfers of the Trusts' assets to the RHRA Plan from the Plan totaled \$3,285,855 and \$4,705,992 as of December 31, 2024 and 2023, respectively.

Investment valuation and income recognition

Assets in the Master Trust and the Emory Healthcare Master Trust are recorded at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

The net change in fair value of investments in master trusts is allocated to each participating plan based on the relationship of the interest of each plan to the total of the interests of the participating plans. Fees incurred by the Plan for investment management services are included in net change in fair value of investments in master trusts.

Risks and uncertainties

The Master Trust and the Emory Healthcare Master Trust invest in various investment securities. Investment securities are exposed to several risks, such as market, currency, interest rate, and credit risks. The fair value of investment securities fluctuates, and it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the funded status of the Plan.

Subsequent events

The Plan has evaluated subsequent events through October 14, 2025, which is the date these financial statements were available to be issued. All subsequent events, if any, requiring recognition as of December 31, 2024, have been incorporated into these financial statements.

Note 3 - Investment in Master Trusts:

The Plan's investment assets are held in trust accounts and consist of an undivided interest in the Master Trust and the Emory Healthcare Master Trust. The Master Trust and the Emory Healthcare Master Trust permits the commingling of Plan assets with the assets of the Emory University Welfare Plan for Insured Benefits, the Emory Healthcare, Inc. Master Welfare Benefit Plan, and the RHRA Plan for investment and administrative purposes. Each participating plan owns a proportionate share of the assets of the Master Trust and the Emory Healthcare Master Trust. Each participating plan is credited with the plan's contributions and allocations of the Master Trust and Emory Healthcare Master Trust net change in fair value of investments and is charged with an allocation of the Master Trust and Emory Healthcare Master Trust expenses. The net change in fair value of investments of the master trusts' investment assets are allocated to each participating plan based on the relationship of the interest of each plan to the total of the interests of the participating plans. Any benefits paid, including reimbursement of retiree costs, from the Master Trust and the Emory Healthcare Master Trust are allocated to the participating plan under which the benefits are covered.

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB Accounting Standards Codification No. 820 are described as follows:

- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds (or shares of registered investment companies) are valued at the NAV of shares held by the trusts at year-end by obtaining quoted prices on nationally recognized securities exchanges.
- Investments in common/collective trust funds are valued daily using the NAV of the units of the trust. NAV is based on fair value of the underlying stocks, debt instruments, mutual funds, and other securities in the trust. The Trusts can buy and sell units of the trust daily, but the market is considered inactive; hence, these investments are included in Level 2.
- Alternative funds include hedge funds valued at the NAV per share multiplied by the number of shares held as of the measurement date. The NAVs are not publicly reported and funds are valued at the NAV as a practical expedient. These funds are not categorized within the fair value hierarchy. The underlying investment strategies of the alternative funds vary but represent a balanced approach and are generally comprised of domestic equity, international equity, emerging markets, global equity and fixed income allocations.

The preceding methods may produce a fair value estimate that might not be indicative of net realizable value. Furthermore, although management of the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 - Commitments:

As discussed in Note 3, the Master Trust and the Emory Healthcare Master Trust invest in certain alternative investments valued at NAV for which no quoted market prices exist. In connection with these investments, the Master Trust had future capital commitments totaling approximately \$586,000 and \$977,000 as of December 31, 2024 and 2023, respectively and the Emory Healthcare Master Trust had future capital commitments totaling approximately \$138,000 and \$211,000 as of December 31, 2024 and 2023, respectively.

Note 5 - Postretirement Benefits:

The postretirement benefit obligation represents the actuarial present value of those estimated future benefits that are attributed by the terms of the Plan to employee service rendered to the date of the financial statements, reduced by the actuarial present value of contributions expected to be received in the future from current plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired employees and their beneficiaries and dependents, and (2) eligible active employees and their beneficiaries and dependents after retirement from service with the University.

Once a retiree or spouse turns 65, they become eligible to participate in the RHRA plan and are no longer eligible to receive postretirement benefits under the Plan. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributable to that employee's service rendered to the valuation date. The postretirement benefit obligation represents the amount that is to be funded by contributions from the University or from existing plan assets.

The actuarial present value of the expected postretirement benefit obligation is determined by the Plan's actuary and is the amount that results from applying actuarial assumptions to historical claims cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal, or retirement) between the valuation date and the expected date of payment, and to reflect the portion of those costs expected to be borne by the retired participants and other providers.

Note 5 - Postretirement Benefits - continued:

Except for a very limited number of employees, the University's annual post-Medicare HRA contribution increase is limited to 4% under the Plan. Retirees are responsible for any additional increase. Therefore, actual healthcare trend rates do not materially affect the obligations. Other significant assumptions used in the December 31, 2024 and 2023 valuations were as follows:

Note 6 - Tax status:

The Trusts established under the Plan to hold the Plan's assets are intended to qualify pursuant to Section 501(c)(9) of the IRC, and accordingly, the net income from the Trusts is exempt from income taxes. The Master Trust has obtained an exemption letter dated March 1, 1995 from the Internal Revenue Service (IRS). The Emory Healthcare Master Trust has obtained an exemption letter dated April 20, 2006, with an effective date of January 1, 2003 from the IRS. The Plan administrator believes that the Plan and Trusts, as amended, continue to qualify and to operate in compliance with the applicable requirements of the IRC and the Plan has no income subject to unrelated business income tax, therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Sponsor has analyzed tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Plan termination:

Although it has not expressed any intent to do so, the University has the right under the Plan to modify the benefits provided to, and contributions required of, participants, to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, remaining assets will be applied in an uniform and nondiscriminatory manner towards the provision of benefits for or on account of the participants. No assets of the Plan may revert to the University or be used for the purposes other than for the exclusive benefit of the Plan's participants.

Note 8 - Party-in-interest transactions:

Certain investments in the Trusts include mutual funds, common/collective trust funds and alternative investments managed by the Plan's trustee, Bank of New York. These transactions are party-in-interest transactions under ERISA.
